By leave of the Assembly to set aside Standing Orders 84.1 (3) and 185, Mrs. Blais, Minister responsible for Seniors, Mrs. Lapointe (Crémazie), Mr. Picard (Chutes-de-la-Chaudière) and Mr. Khadir (Mercier) jointly moved:

THAT the National Assembly mark World Elder Abuse Awareness Day, which will be held next Monday, 15 June.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

By leave of the Assembly to set aside Standing Orders 84.1 (2), 84.1 (3) and 185, Mr. Khadir (Mercier), Mr. Corbeil, Minister responsible for Aboriginal Affairs, Mr. Bouchard (Vachon) and Mr. Deltell (Chauveau) jointly moved:

THAT the National Assembly mark the first anniversary of the official apology of Canada, which, through the voice of its Prime Minister Stephen Harper, asked for forgiveness from the former students of Indian residential schools for the suffering endured and the damaging impact of the residential schools on their culture, their heritage and on the aboriginal languages.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Order 84.1 (2) and pursuant to Standing Order 146, Mr. Dupuis, Government House Leader, moved:

THAT, within the framework of the consideration of Bill 28, An Act respecting the boundaries of the waters in the domain of the State and the protection of wetlands along part of the Richelieu River, the Committee on Transportation and the Environment hold special consultations and public hearings on 17 June 2009 and that, for this purpose, it hear the following groups:

- Association des riverains de la rivière Richelieu
- Union des producteurs agricoles de Saint-Hyacinthe
- Municipalité régionale de comté du Haut-Richelieu
- Danielle Perras, porte-parole du regroupement formé de propriétaires de terrains en zone inondable

The presentation by each group shall last no more than 10 minutes and the exchange with the members of the Committee shall last no more than 50 minutes, which time shall be shared equally among the members of the parliamentary group forming the Government and the Members sitting in opposition;

The Minister of Sustainable Development, Environment and Parks shall be a member of the said Committee during its proceedings with respect to this order of reference.

By leave of the Assembly, the motion was carried.

Notices of Proceedings in Committees

Government Bills

Report Stage

The Assembly took into consideration the report from the Committee on Institutions on its clause-by-clause consideration of Bill 46, An Act to amend the Professional Code and other legislative provisions.

After debate thereon, the report was concurred in.

Passage in Principle

Mrs. Weil, Minister responsible for the administration of legislation respecting the professions, moved, –That Bill 21, An Act to amend the Professional Code and other legislative provisions in the field of mental health and human relations, do now pass in principle.

After debate thereon, the motion was carried and Bill 21 was accordingly passed in principle.

Mr. Dupuis, Government House Leader, moved that Bill 21 be referred for clause-by-clause consideration to the Committee on Institutions.

The motion was carried.

Passage

Mr. Bolduc, Minister of Health and Social Services, moved the passage of Bill 47, An Act to amend the Act to ratify the Agreement concerning the building and operating of a hospital centre in the Kahnawake Territory.

After debate thereon, the motion was carried and, accordingly, Bill 47 was passed.

Mrs. Thériault, Minister for Social Services, moved the passage of Bill 49, An Act respecting the representation of family-type resources and certain intermediate resources and the negotiation process for their group agreements, and amending various legislative provisions.

After debate thereon, the motion was carried and, accordingly, Bill 49 was passed.

Passage

Mrs. Ménard, Minister of Tourism, moved the passage of Bill 31, An Act to amend the Act respecting tourist accommodation establishments and other legislative provisions.

A debate arose thereon.

By leave of the Assembly to set aside Standing Order 21, the proceedings continued beyond 1.00 o'clock p.m.

The debate being concluded, the motion was carried and, accordingly, Bill 31 was passed.
