Deferred Divisions

The Assembly took the division, which had been deferred at the sitting of 26 May 2009, on the motion moved by Mr. Whissell, Minister of Labour, for the passage of Bill 25, An Act to amend the Pay Equity Act.

The motion was carried on the following vote:

Accordingly, Bill 25 was passed.

Motions Without Notice

Mr. Curzi (Borduas), Mr. Cloutier (Lac-Saint-Jean), Mr. Deltell (Chauveau) and Mr. Khadir (Mercier) jointly moved a motion concerning the French language; this motion could not be debated for want of unanimous consent.

Mrs. St-Pierre, Minister of Culture, Communications and the Status of Women, moved:

THAT the National Assembly ask the Federal Government to take note of the report of the Commissioner of Official Languages, to increase its efforts to meet the objectives of the policy and of the *Official Languages Act*, and that it reaffirm its wish that the French language be present on an equal footing with the English language on the occasion of the 2010 Vancouver Olympic Games.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

By leave of the Assembly to set aside Standing Order 84.1 (2) and pursuant to Standing Order 146, Mr. Gautrin, Deputy Government House Leader, moved:

THAT, within the framework of the consideration of Bill 51, An Act respecting the representation of certain home childcare providers and the negotiation process for their group agreements, and amending various legislative provisions, the Committee on Social Affairs hold special consultations and public hearings on 2 and 3 June 2009 and that, for this purpose, it hear the following groups:

- Association québécoise des centres de la petite enfance
- Association des éducatrices et éducateurs en milieu familial du Québec inc.
- Association des garderies privées du Québec

A period of 15 minutes shall be allotted for the opening statements, which time shall be shared equally among the members of the parliamentary group forming the Government, the parliamentary group forming the Official Opposition and the Members sitting in opposition;

The presentation by the Association québécoise des centres de la petite enfance as well as that of the Conseil québécois des services de garde éducatifs à l'enfance shall last respectively 20 minutes and the exchange with the members of the Committee shall last respectively 100 minutes, which time shall be shared equally among the members of the parliamentary group forming the Government and the Members sitting in opposition;

The presentation by each of the other groups shall last no more than 10 minutes and the exchange with the members of the Committee shall last no more than 50 minutes, which time shall be shared equally among the members of the parliamentary group forming the Government and the Members sitting in opposition;

A period of 15 minutes shall be allotted for the closing statements, which time shall be shared equally among the members of the parliamentary group forming the Government and the Members sitting in opposition;

The Minister of Families shall be a member of the said Committee during its proceedings with respect to this order of reference.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Order 84.1 (2) and pursuant to Standing Order 146, Mr. Gautrin, Deputy Government House Leader, moved:

THAT, within the framework of the consideration of Bill 40, An Act to amend the Balanced Budget Act and various legislative provisions concerning the implementation of the accounting reform, the Committee on Public Finance hear the Auditor General of Québec on Tuesday, 2 June 2009, from 3.00 o'clock p.m. to 6.00 o'clock p.m., in the Legislative Council Room:

The presentation by the Auditor General of Québec shall last no more than 10 minutes and the remaining time shall be shared equally among the members of the parliamentary group forming the Government and the Members sitting in opposition;

The Minister of Finance shall be a member of the said Committee during its proceedings with respect to this order of reference.

By leave of the Assembly, the motion was carried.

Notices of Proceedings in Committees

Mr. Gautrin, Deputy Government House Leader, convened the following Committees:

ORDERS OF THE DAY

Government Motions

The Assembly held the debate on the motion arising out of the tabling by Mr. Arcand, Minister of International Relations, on 6 May 2009, of the Social Security Agreement between the Government of Québec and the Kingdom of Belgium and the administrative arrangements relating thereto.

This motion reads as follows:

THAT, pursuant to section 22.3 of the *Act respecting the Ministère des Relations internationales*, the National Assembly ratify the administrative arrangements relating to the Social Security Agreement between the Government of Québec and the Kingdom of Belgium.

Pursuant to that which had been decided upon the adoption of the parliamentary reform, on 21 April 2009, concerning the allocation of speaking time for limited debates, Mr. Gendron, Third Vice-President, informed the Assembly of the allocation of speaking time for the discussion of this motion: 5 minutes shall be set aside for the independent Member; a fixed portion amounting to 10 % of the total time allotted for this debate shall be set aside for the Members of the Second Opposition Group; the remaining time shall be shared equally between the parliamentary group forming the Government and the parliamentary group forming the Official Opposition; within this framework, any time not used by the independent Member or by the Second Opposition Group shall be redistributed equally between the parliamentary group forming the Government and the parliamentary group forming the Official Opposition, and any time not used by the parliamentary group forming the Government shall go the parliamentary group forming the Official Opposition and vice versa; and individual addresses shall not be limited.

A debate arose thereon.

At 12.01 o'clock p.m., at the request of Mr. Gautrin, Deputy Government House Leader, and by leave of the Assembly, Mr. Gendron, Third Vice-President, suspended the proceedings until 3.00 o'clock p.m.

The proceedings resumed at 3.00 o'clock p.m.

Government Bills

Passage in Principle

Mr. Bachand, Minister of Finance, moved, —That Bill 11, An Act to amend the Acts establishing Capital régional et coopératif Desjardins, Fondaction and the Fonds de solidarité des travailleurs du Québec (F.T.Q.), do now pass in principle.

After debate thereon, the motion was carried and Bill 11 was accordingly passed in principle.

Mr. Dupuis, Government House Leader, moved that Bill 11 be referred for clause-by-clause consideration to the Committee on Public Finance.

The motion was carried.

Report Stage

The Assembly took into consideration the report from the Committee on Planning and the Public Domain on its clause-by-clause consideration of Bill 33, An Act to amend the Act respecting elections and referendums in municipalities and other legislative provisions.

After debate thereon, the report was concurred in.

The Assembly took into consideration the report from the Committee on Agriculture, Fisheries and Food on its clause-by-clause consideration of Bill 4, An Act to regularize and provide for the development of local slaughterhouses and to amend the Food Products Act, together with the amendment handed in by Mr. Lessard, Minister of Agriculture, Fisheries and Food.

The amendment was declared in order.

After debate thereon, the amendment was carried.

The report, as amended, was concurred in.
