Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mr. Mamelonet (Gaspé), Mr. Bérubé (Matane), Mr. Grondin (Beauce-Nord) and Mr. Khadir (Mercier) jointly moved:

THAT the National Assembly offer solace to the families stricken by the maritime tragedy that took place last night off the coast of Rivière-au-Renard as well as to the entire Gaspesian community.

By leave of the Assembly, the motion was carried.

At the invitation of Mr. Chagnon, Second Vice-President, the Assembly observed a minute of silence.

By leave of the Assembly to set aside Standing Orders 84.1 (2), 84.1 (3) and 185, Mrs. Lapointe (Crémazie), Mrs. Blais, Minister responsible for Seniors, Mr. Cloutier (Lac-Saint-Jean), Mr. Picard (Chutes-de-la-Chaudière) and Mr. Khadir (Mercier) jointly moved:

THAT the National Assembly reiterate its requests before the Federal Government and demand that it make, as expeditiously as possible, clear commitments and quickly make known its intentions in order that Québec's seniors be treated justly and with dignity and obtain: the \$110 dollar monthly increase in the guaranteed income supplement, the continuation of the payment, for a period of six months, of the old age security pension and supplement to a person whose spouse or common-law partner has died, automatic registration for people of 65 years of age who are entitled to the guaranteed income supplement, full retroactivity of the guaranteed income supplement for seniors who have been short-changed.

The question was put on this motion; a recorded division was thereupon demanded.

The motion was carried on the following vote:

— the Committee on Public Administration shall meet to hear the head officers of the Régie des alcools, des courses et des jeux, and shall then hold a deliberative meeting to dispose of the observations, conclusions and, if any, the recommendations made following the hearing.

Information on the Proceedings of the Assembly

Mr. Chagnon, Second Vice-President, informed the Assembly that on Wednesday, 20 May 2009, during Business Standing in the Name of Members in Opposition, a debate will be held on the motion by Mr. Cloutier (Lac-Saint-Jean).

This motion reads as follows:

THAT the National Assembly demand that the Government of Québec approach the Government of Canada in order that the responsibilities of the National Battlefields Commission and the lands managed by the latter be ceded to the Québec State and that the lands forming Parliament Hill that the Government of Québec has been leasing from the Federal Government since 1881 be ceded thereto.

ORDERS OF THE DAY

Government Bills

Passage in Principle

Mr. Bolduc, Minister of Health and Social Services, informed the Assembly that His Honour the Lieutenant-Governor recommended to its consideration Bill 24, An Act to amend various legislative provisions concerning health, and then moved, —That this Bill do now pass in principle.

After debate thereon, the motion was carried and Bill 24 was accordingly passed in principle.

Mr. Dupuis, Government House Leader, moved that Bill 24 be referred for clause-by-clause consideration to the Committee on Social Affairs.

The motion was carried.

Mrs. Ménard, Minister of Tourism, moved, —That Bill 31, An Act to amend the Act respecting tourist accommodation establishments and other legislative provisions, do now pass in principle.

After debate thereon, the motion was carried and Bill 31 was accordingly passed in principle.

Mr. Hamad, Minister of Employment and Social Solidarity, moved that Bill 31 be referred for clause-by-clause consideration to the Committee on Labour and the Economy.

The motion was carried.

At 4.11 o'clock p.m., at the request of Mr. Hamad, Minister of Employment and Social Solidarity, Mr. Chagnon, Second Vice-President, suspended the proceedings until 4.45 o'clock p.m.

Mrs. Thériault, Minister for Social Services, moved the adjournment of the Assembly until Wednesday, 20 May 2009, at 10.00 o'clock a.m.

The motion was carried.
