The Assembly was called to order at 10.07 o'clock a.m.

Business Having Precedence

Estimates of Expenditure

The Assembly entered upon the limited debate on the reports from the committees that considered the estimates of expenditure of the ministries for the 2009-2010 fiscal year.

Mr. Gendron, Third Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate. A set time envelope of 12 minutes will be granted to the Second Opposition Group and 5 minutes will be granted to the independent Member, while the parliamentary group forming the Government and the parliamentary group forming the Official Opposition will share equally the rest of the time set aside for this debate. Any time not used by the independent Member or by the Second Opposition Group will be redistributed equally among the parliamentary group forming the Government and the parliamentary group forming the Government and the parliamentary group forming the Government and the parliamentary group forming the Official Opposition. The debate arose thereon.

The debate being concluded and the Assembly having disposed of the want of confidence motions and the motion by the Minister of Finance moved within the framework of the Budget Speech, the question was put for concurrence in the several reports together from the committees that considered the estimates of expenditure of the ministries for the 2009-2010 fiscal year; a recorded division was thereupon demanded.

At the request of Mr. Gautrin, Deputy Government House Leader, the division was deferred until Routine Proceedings later on in today's sitting.

At 12.00 o'clock p.m., by leave of the Assembly to set aside Standing Orders 20 and 52, Mrs. Houda-Pepin, First Vice-President, suspended the proceedings until 1.30 o'clock p.m.

ROUTINE PROCEEDINGS

Mr. President gave the following directive regarding the management of the new item of business Statements by Members:

DIRECTIVE FROM THE CHAIR

The item of business Statements by Members was created to replace the motions introduced until now at Motions Without Notice and which aimed principally to mark various events or to discuss important issues of local, regional, national or international interest.

The number of motions without notice being henceforth limited since the adoption of the parliamentary reform, Members will therefore now have the opportunity to discuss this type of event by making a statement under the appropriate item of business. These statements will be subject to the provisions of the Standing Orders. During this item of business, up to ten statements may be made, each lasting no more than one minute.

The names of the Members who will make a statement as well as the subjects thereof will appear in the *Order Paper and Notices* on the day of their presentation. As regards the distribution of statements among the parliamentary groups and the independent Member and the order of their presentation, since they were the object of an agreement ratified by the Assembly, the Chair will apply it accordingly.

Lastly, the statements that remain unused at a sitting may not be deferred to a subsequent sitting, nor may they be used by another parliamentary group or an independent Member. However, a Member may replace another, with his permission, to make a statement on the subject on which notice was placed on the *Order Paper and Notices*.

The report states that the notice was drafted and published in accordance with the Rules for the Conduct of Proceedings Respecting Private Bills.

By leave of the Assembly, a debate arose thereon.

THAT the National Assembly mark the 375th anniversary of the city of Trois-Rivières, the second oldest French-speaking city in America;

THAT it commend its extraordinary vitality and the large-scale projects carried out since its founding by the people of Trois-Rivières;

THAT it congratulate the organizers of the festivities that provide us with a highly colourful and most promising schedule, such as that which we witnessed at the opening of the festivities last Saturday, 9 May;

THAT the National Assembly mark this city's growth and forward-looking projects each one more dynamic than the next, planned by the people of Trois-Rivières within the framework of these celebrations, particularly the Trois-Rivières sur le Saint-Laurent project, a project which should be completed in 2010, including its amphitheatre.

Mr. Deltell (Chauveau) and Mr. Dupuis, Minister responsible for Canadian Intergovernmental Affairs and the Reform of Democratic Institutions, jointly moved a motion concerning the Royal 22nd Regiment; this motion could not be debated for want of unanimous consent.

- the Committee on Institutions, to give clause-by-clause consideration to Bill 17, An Act to establish the Office Québec-Monde pour la jeunesse and to amend various legislative provisions.

Mrs. Houda-Pepin, First Vice-President, gave the following notice:

— the Committee on Social Affairs shall hold a deliberative meeting for the purpose of organizing its proceedings as regards the order of initiative on the phenomenon of homelessness in Québec and the statutory order on health and social services agencies.

Government Bills

Report Stage

The Assembly took into consideration the report from the Committee on Institutions on its clause-by-clause consideration of Bill 20, An Act to amend the Courts of Justice Act and the Act respecting the Ministère de la Justice.

After debate thereon, the report was concurred in.

Passage in Principle

Mrs. Weil, Minister of Justice, moved, –That Bill 9, An Act to amend the Code of Civil Procedure to prevent improper use of the courts and promote freedom of expression and citizen participation in public debate, do now pass in principle.

After debate thereon, the motion was carried and Bill 9 was accordingly passed in principle.

Mr. Dupuis, Government House Leader, moved that Bill 9 be referred for clauseby-clause consideration to the Committee on Institutions.

The motion was carried.

Mr. Lessard, Minister of Agriculture, Fisheries and Food, moved, –That Bill 4, An Act to regularize and provide for the development of local slaughterhouses and to amend the Food Products Act, do now pass in principle.

After debate thereon, the motion was carried and Bill 4 was accordingly passed in principle.

Mr. Dupuis, Government House Leader, moved that Bill 4 be referred for clauseby-clause consideration to the Committee on Agriculture, Fisheries and Food.

The motion was carried.

At 4.22 o'clock p.m., at the request of Mr. Dupuis, Government House Leader, Mrs. Houda-Pepin, First Vice-President, suspended the proceedings until 6.00 o'clock p.m.
