#### **Presenting Reports from Committees**

Mr. Reid (Orford), Committee Chair, tabled the following:

The report from the Committee on Transportation and the Environment, which held public hearings on 23 and 24 March 2015 within the framework of special consultations on Bill 32, An Act to amend the Act respecting compensation measures for the carrying out of projects affecting wetlands or bodies of water in order to extend its application.

#### **Complaints of Breach of Privilege or Contempt and Personal Explanations**

The President informed the Assembly that he had, within the prescribed time, received a request from Mr. Lisée, Member for Rosemont, to be heard on an alleged breach of privileges or immunities. In his notice, the Member alleges that the Minister for Rehabilitation, Youth Protection and Public Health acted in contempt of Parliament by knowingly misleading the House in relation to a reply she gave during Oral Questions and Answers on 18 March 2015 concerning the Canada-Québec agreement on homelessness.

#### RULING FROM THE CHAIR

In matters of contempt of Parliament, the Chair has already indicated that the deliberate nature of the act must be clear in order to conclude that a Member has knowingly misled the House. Parliamentary jurisprudence has always recalled the fundamental principle provided for in paragraph 6 of Standing Order 35, whereby no Member shall refuse to take another Member at his word. This assumption in favour of a Member cannot be reversed unless the Member, when speaking, misleads the Assembly and, subsequently, recognizes having deliberately misled it, thus acting in contempt of Parliament.

The Member alleges that the Minister knowingly misled the House because her answer was inconsistent with the content of the Canada-Québec agreement on homelessness made public on 19 March 2015. In his opinion, she gave two contradictory versions of the same facts.

However, nothing allows the Chair to conclude that the Minister admitted having deliberately misled the House. Furthermore, even if we draw inspiration from the interpretation given by the Speaker of the House of Commons of Canada, nothing suggests that the Minister gave two contradictory versions of the same facts.

When the Chair determines whether a matter of contempt of Parliament is receivable, the facts invoked must be compelling *prima facie*. In instances invoking contradictory versions, the Member speaking about a subject must have given two contradictory versions. In this case, we have two Members whose interpretations of a given situation differ.

The complaint is therefore not receivable.

#### **Oral Questions and Answers**

#### **Motions Without Notice**

Mrs. Poirier (Hochelaga-Maisonneuve), together with Mr. Paradis (Lévis) and Mrs. David (Gouin), moved a motion concerning access to abortion; this motion could not be debated for want of unanimous consent.

Mr. Bonnardel (Granby), together with Mr. Marceau (Rousseau) and Mr. Khadir (Mercier), moved a motion concerning a single income tax return; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mrs. Vallée, Minister of Justice, together with Mrs. Poirier (Hochelaga-Maisonneuve), Mrs. Roy (Montarville) and Mrs. Massé (Sainte-Marie-Saint-Jacques), moved:

THAT the National Assembly mark the 140th anniversary of the YWCA Montreal and YWCA Québec City;

THAT it highlight the organizations' important mission, which is to help fight violence and discrimination against women and girls;

THAT it reiterate that, despite the significant progress made, gender-based inequalities persist and that organizations like the YWCA contribute to achieving gender equality-related objectives;

THAT the Assembly congratulate and thank all of the men and women (past and present) who work within these organizations and that it acknowledge their essential work.

By leave of the Assembly, the motion was carried.

THAT it affirm that, to achieve gender equality, this issue is a priority;

THAT the Assembly acknowledge that the consultations will continue in the context of a travelling forum as proposed in the motion carried unanimously on 25 November 2014;

THAT the National Assembly recognize the urgent need for action and ask the Government to pursue its commitment to eliminate this scourge, which victimizes too many men, women and children.

THAT the Minister responsible for Access to Information and the Reform of Democratic Institutions be a member of the said Committee during its proceedings with respect to this order of reference.

#### **Government Bills**

#### Passage

Mr. Daoust, Minister of the Economy, Innovation and Exports, moved the passage of Bill 19, An Act to amend the Cooperatives Act and other legislative provisions.

After debate thereon, the motion was carried and, accordingly, Bill 19 was passed.

#### Passage in Principle

#### **Business Standing in the Name of Members in Opposition**

Mr. Bergeron (Verchères) moved:

THAT the National Assembly express its deepest concern regarding federal Bill C-51, in particular several provisions that are too vague or far-reaching in scope, which might lead to excesses on the part of the Canadian Security Intelligence Service (CSIS) and to violations of Quebecers' rights and freedoms;

THAT the National Assembly endorse the concerns expressed by various public-sector stakeholders, including university professors, former judges, lawyers and former prime ministers, regarding the major shift in CSIS's role;

THAT the National Assembly recognize the initiative undertaken by three ministers of the Government of Québec in their letter dated 17 March 2015;

THAT the National Assembly denounce the Federal Government's unilateral process;

THAT the National Assembly demand that the Government of Québec send its observations and amendment requests to the House of Common's Standing Committee on Public Safety and National Security before the parliamentary examination of the bill ends:

THAT the National Assembly demand that the Government of Québec table its observations and amendment requests in the National Assembly before sending them to the Standing Committee.

Mr. Ouimet, First Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate: 10 minutes to the mover of the motion for his reply; approximately 52 minutes to the parliamentary group forming the Government; approximately 30 minutes to the parliamentary group forming the Official Opposition; approximately 22 minutes to the Second Opposition Group; and 6 minutes to the independent Members. Within this framework, any time not used by the independent Members or by any of the parliamentary groups shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

The debate being concluded, the question was put on this motion, and a recorded division was thereupon demanded.

The motion was negatived on the following vote:
