#### **BUSINESS HAVING PRECEDENCE**

(1) Pursuant to Standing Orders 275 and 276, continuation of the debate on the motion by the Minister of Finance, –That this Assembly approves the budgetary policy of the Government,

And on the motions stating a grievance moved by:

#### The Member for Rousseau:

THAT the National Assembly severely censure the Liberal Government for presenting a budget without taking into account the consequences it would have on Quebecers.

# The Member for Granby:

THAT the National Assembly severely censure the Liberal Government for its lack of economic ambition and for breaking its campaign promise to create 250,000 jobs during its current mandate.

# The Member for La Peltrie:

THAT the National Assembly severely censure the Liberal Government for not having a plan to bridge the anticipated deficit caused by the \$853-million gap in program spending that will have to be eliminated.

#### The Member for Gouin:

THAT the National Assembly of Québec severely censure the Liberal Government for its 2015-2016 budget, which jeopardizes public services due to unprecedented budget cuts in the health and education networks, which will contribute to undermining the quality of the public services made available to Quebecers, and which sets in motion the impoverishment of the 530,000 employees working in these sectors by removing any leeway the Chair of the Conseil du trésor might have to negotiate the working conditions of public and parapublic sector workers in good faith.

THAT the National Assembly severely censure the Liberal Government for presenting a budget that reveals that the Plan Nord is a plan only, providing for no substantial investment.

# (52) Mrs. Ouellet (Vachon) – **17 March 2015**To the Minister for Transport and the Implementation of the Maritime Strategy

We ask the Minister for Transport and the Implementation of the Maritime Strategy to provide us with the following information regarding his mission to France in March 2015:

1. The list of persons who accompanied the Minister for Transport and the Implementation of the Maritime Strategy;

- 2. The overall expenses related to the mission as well as to its preparation, and charged to the Ministère des Transports;
- 3. The Minister's entire mission agenda;
- 4. The list of all persons met as well as a copy of their business cards;
- 5. For each working meeting held by the Minister, we would like to have: the list of persons present, the location, the duration, the details of expenses incurred, the subject and minutes, as well as the commitments made by each party (regarding employment, salaries, benefits to Québec, etc.);

# (53) Mr. Caire (La Peltrie) – **17 March 2015**To the Minister of Education, Higher Education and Research

According to the Auditor General of Québec, for the fiscal year ended on 30 April 2014, the Université du Québec à Montréal (UQAM) violated Bill 100, An Act to implement certain provisions of the Budget Speech of 30 March 2010, reduce the debt and return to a balanced budget in 2013-2014.

The UQAM granted 85 executives \$352,767 in lump sum settlements in addition to the maximum salary provided for in the Act. The department had then informed the UQAM that it had to comply with the Act, failing which it risked a subsidy reduction.

The UQAM has always denied having violated the Act in spite of the department's warning. Has the Minister of Education taken steps to recover the UQAM's overpayments?

#### (58) Mr. Surprenant (Groulx) – **14 April 2015**

To the Minister for Transport and the Implementation of the Maritime Strategy

The Minister for Transport and the Implementation of the Maritime Strategy says that his Government will invest more than \$1.5 billion by 2020 within the framework of the maritime strategy.

Page B.160 of the document entitled "The Québec Economic Plan", tabled by the Minister of Finance last 26 March, indicates that Budget 2015-2016 provides for a budget allowance of over \$1.5 billion for the 2015-2020 period.

Can the Minister confirm that there are significant differences between Government investment and a budget allowance?

Can he provide details regarding this \$1.5 billion budget allowance by clearly indicating:

- the Québec Government's share of investment (in \$ millions) by indicating the form (loans, subsidies, tax credits, etc.)
- the share of private investment (in \$ millions)
- the Federal Government's share of investment (in \$ millions)
- the share of any other investment.

# (59) Mr. Surprenant (Groulx) – **14 April 2015**

To the Minister for Transport and the Implementation of the Maritime Strategy

The Minister for Transport and the Implementation of the Maritime Strategy says that a broad consultation of maritime sector stakeholders was carried out during the preparation of the Québec Government's maritime strategy.

On several occasions he indicated that he had received approximately 80 briefs within the framework of this consultation. However, no documentation is available.

Why did the Minister choose to hold a private consultation rather than hold a public consultation? Can he provide us with the list of briefs he received and make them public? Can he provide us with the list of groups he met, including the dates of these meetings and the costs related thereto, within the framework of his maritime strategy?

Once the maritime strategy will have been tabled in June 2015, does he intend to hold a public consultation at the National Assembly?
