The Assembly was called to order at 2.08 o'clock p.m.

Moment of reflection

By leave of the Assembly to set aside Standing Order 53, Mr. Dupuis, Government House Leader, tabled the following:

The 9th edition of the Standing Orders of the National Assembly and Other Rules of Procedure, French and English versions.

By leave of the Assembly to set aside Standing Orders 53, 116 (1) and 188, Mr. Dupuis, Government House Leader, moved:

THAT the National Assembly adopt as the permanent rules of procedure the Standing Orders and the Rules for the Conduct of Proceedings of the National Assembly, such as contained in the document entitled "Standing Orders and Other Rules of Procedure" tabled today;

THAT it order that these rules of procedure come into force and govern all of its proceedings immediately the present motion is carried;

THAT it order that the rules of procedure indicated in appendix of the present motion enter into effect on the corresponding date provided for in the said appendix;

THAT it order that the replaced provisions cease to be in force when the rules of procedure provided for in the said document and said appendix enter into effect.

The motion was carried.

By leave of the Assembly to set aside Standing Order 53, Mr. Dupuis, Government House Leader, tabled the following:

A document entitled "Recognition of the Action démocratique du Québec as a Parliamentary Group and Allocation of Various Measures Among the Members Sitting in Opposition For the Duration of the 39th Legislature".

By leave of the Assembly to set aside Standing Orders 53, 84 and 188, Mr. Dupuis, Government House Leader, moved:

THAT the Members affiliated with the Action démocratique du Québec constitute, immediately the present motion is carried, a parliamentary group according to the terms and conditions contained in the document entitled "Recognition of the Action démocratique du Québec as a Parliamentary Group and Allocation of Various Measures Among the Members Sitting in Opposition For the Duration of the 39th Legislature" tabled today;

THAT the terms and conditions contained in the said document have precedence over any incompatible provisions of the Standing Orders and the Rules for the Conduct of Proceedings of the Assembly;

THAT the present motion become an order of the Assembly for the duration of the 39th Legislature, and this, notwithstanding the prorogation of the session.

The motion was carried.

Introduction of Bills

By leave of the Assembly to set aside Standing Order 53, Mr. Dupuis, Minister responsible for Canadian Intergovernmental Affairs and the Reform of Democratic Institutions, moved that leave be granted to introduce the following Bill:

36 An Act to amend the Act respecting the conditions of employment and the pension plan of the Members of the National Assembly and other legislative provisions

By leave of the Assembly to set aside Standing Order 232, the motion was carried.

Accordingly, Bill 36 was introduced in the Assembly.

Government Bills

Passage in Principle

By leave of the Assembly to set aside Standing Orders 53, 236 and 237, Mr. Dupuis, Minister responsible for Canadian Intergovernmental Affairs and the Reform of Democratic Institutions, moved, —That Bill 36, An Act to amend the Act respecting the conditions of employment and the pension plan of the Members of the National Assembly and other legislative provisions, do now pass in principle.

The motion was carried and Bill 36 was accordingly passed in principle.

Mr. Dupuis, Government House Leader, moved that Bill 36 be referred for clause-by-clause consideration to the Committee of the Whole.

The motion was carried.

Committee of the Whole

By leave of the Assembly to set aside Standing Order 53, Mr. Dupuis, Government House Leader, moved that the Assembly resolve itself into a Committee of the Whole for the clause-by-clause consideration of Bill 36, An Act to amend the Act respecting the conditions of employment and the pension plan of the Members of the National Assembly and other legislative provisions.

The motion was carried.

Bill 36 was considered in Committee of the Whole and thereupon reported.

The report was concurred in.

Passage
