The Assembly was called to order at 8.45 o'clock a.m.

Motions Without Notice

Pursuant to Standing Order 26.1, Mr. Fournier, Government House Leader, moved:

THAT, in order to complete the examination of Bill 28, An Act mainly to implement certain provisions of the Budget Speech of 4 June 2014 and return to a balanced budget in 2015–2016, the Assembly appoint the hours of meeting as follows:

THAT the Assembly be permitted to sit every day, beginning at 8.45 o'clock a.m., until it has completed the examination of the matter for which it was summoned or until it decides to adjourn its proceedings.

Pursuant to Standing Order 26.1, Mr. Fournier, Government House Leader, moved:

THAT, in order to complete the examination of Bill 28, An Act mainly to implement certain provisions of the Budget Speech of 4 June 2014 and return to a balanced budget in 2015–2016, the Assembly establish the exceptional legislative procedure as provided for in Standing Orders 182 to 184.2 and 257.1 to 257.10;

THAT the President be permitted to suspend the proceedings at any time during the sitting, at the request of a Minister or a Deputy Government House Leader.

At 10.02 o'clock a.m., the President suspended the proceedings to allow the Members to examine the motions presented by Mr. Fournier, Government House Leader.

The proceedings resumed at 10.30 o'clock a.m.

The President heard the comments of Mrs. Maltais, Official Opposition House Leader, and Mr. Caire, Deputy Second Opposition Group House Leader, on the receivability of the motions moved by Mr. Fournier, Government House Leader.

At 11.02 o'clock a.m., the President suspended the proceedings.

The proceedings resumed at 11.19 o'clock a.m.

The President ruled on the receivability of the motion to introduce an exceptional legislative procedure moved by the Government House Leader for the consideration and passage of Bill 28, An Act mainly to implement certain provisions of the Budget Speech of 4 June 2014 and return to a balanced budget in 2015–2016.

RULING FROM THE CHAIR

Standing Order 182 states that "The Government House Leader may, without notice, move a motion to introduce an exceptional procedure for the consideration of some matter that may or may not stand on the Order Paper and Notices: Provided that each such motion may introduce an exceptional procedure with regard to but a single matter." In other words, a motion to introduce an exceptional procedure may not be invoked to consider more than one order of business or, in legislative matters, more than one bill at a time.

However, the fact that a bill contains more than one principle does not render a motion to introduce an exceptional procedure inadmissible. Moreover, it is not uncommon for bills to contain more than one principle, and this has nothing to do with the number of sections a bill contains. To come to any other conclusion would make it virtually impossible to apply the exceptional procedure.

The Chair points out that its role is not to comment on the content of a bill, to judge whether it is appropriate for it to include more than one principle, or to judge the author's choice regarding its provisions.

In this regard, Standing Order 241 establishes that a bill containing more than one distinct principle may be proposed for division. Members should use this procedure if they believe a bill should be divided in order to make it possible to consider two distinct principles separately. It is up to the Assembly to determine whether to divide the bill.

On these grounds, the motion moved by the Leader of the Government to introduce an exceptional procedure is declared receivable.

Limited Debate

The President informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate on the reasons why the Assembly has been summoned for extraordinary sittings and on both motions moved by the Government House Leader, namely the motion to appoint the times during which the Assembly shall meet and the motion to introduce an exceptional legislative procedure: 57 minutes shall be allotted to the parliamentary group forming the Government; 33 minutes 32 seconds to the parliamentary group forming the Official Opposition; 23 minutes 28 seconds to the Second Opposition Group; and 6 minutes to the independent Members. Within this framework, any time not used by the independent Members or by any of the parliamentary groups shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

The debate being concluded, the question was put on the motion to appoint the hours during which the Assembly shall meet, and a recorded division was thereupon demanded.

The amendments submitted by Mrs. David (Gouin) to sections 17, 199, 247, 252, 254 and 256.1 were declared in order. The other amendments submitted by the Member for Gouin were declared out of order because they aimed to remove a section.

Mrs. Gaudreault, Second Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this debate: 28 minutes 30 seconds to the parliamentary group forming the Government; 16 minutes 46 seconds to the parliamentary group forming the Official Opposition; 11 minutes 44 seconds to the Second Opposition Group; and 3 minutes to the independent Members. Within this framework, any time not used by the independent Members or by any of the parliamentary groups shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

The debate being concluded, by leave of the Assembly to set aside Standing Order 257.7, Mrs. Gaudreault, Second Vice-President, put the question thereon on the whole of the amendments:
