The Assembly was called to order at 10.03 o'clock a.m.

ORDERS OF THE DAY

Business Standing in the Name of Members in Opposition

Mrs. Maltais (Taschereau) moved:

THAT the National Assembly recall sections 61 and 62 of the *Act respecting the National Assembly* as well as the wording of the oath of allegiance taken by the members of the Cabinet, that it demand that the Premier have his own directives regarding conflicts of interest enforced, that it solemnly affirm that a Cabinet member must not be bound to another employer during the exercise of his duties and that it ask for the appointment, as expeditiously as possible, of an independent ethics commissioner.

Following a meeting with the House leaders, Mr. Chagnon, Second Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this motion: 10 minutes shall be allotted for a reply by its mover; 11 minutes shall be allotted for the independent Members as a whole; the remaining time will be distributed among the parliamentary groups, who will have a time envelope that corresponds to the proportion of seats they respectively have in the Assembly; any time not used by a group will be transferred to the two other groups, in accordance with the proportion of seats they hold; and individual addresses shall not be limited.

A debate arose on the motion by Mrs. Maltais (Taschereau).

At the end of his address, Mr. Gautrin (Verdun) moved the following amendment:

THAT the motion by the Member for Taschereau be amended as follows: By replacing, in the fourth line, the word "demand" by the word "ask"; by adding, in the fourth line, after the word "Premier", the words "continue to"; by replacing, in the sixth line, the words "be bound to" by the words "hold a position for which he receives remuneration from"; by removing, in the eighth line, the words "as expeditiously as possible"; and by adding, at the end of the last line, the words "at the completion of the adoption by the Assembly of a Code of Ethics and Professional Conduct of the Members of the Assembly as proposed by the Government House Leader within the framework of discussions on the parliamentary reform".

The motion, as amended, would read as follows:

THAT the National Assembly recall sections 61 and 62 of the *Act respecting the National Assembly* as well as the wording of the oath of allegiance taken by the members of the Cabinet, that it ask that the Premier continue to have his own directives regarding conflicts of interest enforced, that it solemnly affirm that a Cabinet member must not hold a position for which he receives remuneration from another employer during the exercise of his duties and that it ask for the appointment of an independent ethics commissioner at the completion of the adoption by the Assembly of a Code of Ethics and Professional Conduct of the Members of the Assembly as proposed by the Government House Leader within the framework of discussions on the parliamentary reform.

The debate continued on the main motion by Mrs. Maltais (Taschereau) and on the amendment motion by Mr. Gautrin (Verdun), subject to the receivability of the latter, which Mr. Chagnon, Second Vice-President, took under advisement.

At the end of his address, Mr. Deltell (Chauveau) moved:

THAT the amendment by the Member for Verdun be subamended by adding, after the words "at the completion of the adoption", the words "no later than 19 December 2009".

The motion, as amended and subamended, would read as follows:

THAT the National Assembly recall sections 61 and 62 of the *Act respecting the National Assembly* as well as the wording of the oath of allegiance taken by the members of the Cabinet, that it ask that the Premier continue to have his own directives regarding conflicts of interest enforced, that it solemnly affirm that a Cabinet member must not hold a position for which he receives remuneration from another employer during the exercise of his duties and that it ask for the appointment of an independent ethics commissioner at the completion of the adoption no later than 19 December 2009 by the Assembly of a Code of Ethics and Professional Conduct of the Members of the Assembly as proposed by the Government House Leader within the framework of discussions on the parliamentary reform.

The debate continued on the main motion by Mrs. Maltais (Taschereau), on the amendment motion by Mr. Gautrin (Verdun) and on the subamendment motion by Mr. Deltell (Chauveau), subject to the receivability of the latter, which Mr. Chagnon, Second Vice-President, took under advisement.

Mr. Chagnon, Second Vice-President, rendered the following decision on the receivability of the amendment motion proposed by Mr. Gautrin (Verdun):

RULING FROM THE CHAIR

The amendment motion is unreceivable, since it constitutes an important change that excludes one of the principles of the main motion. The principle at issue is that a member of the Cabinet must not be not be bound to another employer, while the amendment motion provides that a member of the Cabinet must not hold a position for which he receives remuneration. If the amendment motion were carried, it would always allow for the possibility of being bound to another employer while the main motion prohibits it.

Furthermore, it is not for the Chair to evaluate the advisability of ending all ties with a former employer.

Lastly, since the amendment motion is unreceivable, the Chair is not required to put the question to the subamendment motion.

The debate continued on the motion by Mrs. Maltais (Taschereau).

The debate being concluded, the question was put on the motion by Mrs. Maltais (Taschereau); a recorded division was thereupon demanded.

At the request of Mr. Gautrin, Deputy Government House Leader, the division was deferred until Routine Proceedings later in today's sitting.

At 11.57 o'clock a.m., at the request of Mr. Gautrin, Deputy Government House Leader, Mr. Chagnon, Second Vice-President, suspended the proceedings until 2.00 o'clock p.m.

The proceedings resumed at 2.05 o'clock p.m.
