Business Having Precedence

Opening Speech Debate of the Session

The Assembly resumed the debate on the Opening Speech of the Session delivered by Mr. Charest, Premier, at the sitting of Tuesday, 10 March 2009, and on the want of confidence motions by Mrs. Marois, Leader of the Official Opposition, Mrs. Roy (Lotbinière), Mr. Khadir (Mercier), Mr. Ferland (Ungava), Mr. Drainville (Marie-Victorin), Mr. Simard (Richelieu), Mr. Cloutier (Lac-Saint-Jean), Mr. Curzi (Borduas), Mrs. Bouillé (Iberville), Mr. Bergeron (Verchères) and Mr. Kotto (Bourget).

The debate being concluded, Mr. Chagnon, Second Vice-President, rendered the following ruling on the receivability of the want of confidence motion by Mr. Bergeron (Verchères):

RULING FROM THE CHAIR

The want of confidence motion moved by Mr. Bergeron (Verchères) within the framework of the debate on the Opening Speech of the Session is out of order on the grounds that this motion contains recitals, which is contrary to Standing Order 191.

On behalf of the Member concerned, Mr. Chagnon, Second Vice-President, requested leave of the Assembly to replace the aforementioned motion ruled out of order by a new motion in compliance with the Standing Orders.

By leave of the Assembly, Mr. Chagnon, Second Vice-President, tabled the motion by Mr. Bergeron (Verchères), which now reads as follows:

THAT the National Assembly severely blame the Premier and his Government for their lack of vision for the future of Québec, more particularly for the total silence of the opening speech regarding possible measures concerning mass transit and for an economic recovery plan that is essentially based on relatively modest investments in road infrastructures and that does not provide for any additional mass transit measures.

Mr. Chagnon, Second Vice-President, then proceeded to put the question on the want of confidence motions presented during the debate on the Opening Speech of the Session.

First, the question was put on the want of confidence motion moved by Mrs. Marois, Leader of the Official Opposition. This motion reads as follows:

THAT the National Assembly severely blame the Premier for his inability to exercise the leadership that Quebecers expect with regard to the historic losses of the Caisse de dépôt et placement du Québec, and for his refusal to allow the Minister of Finance, who is responsible for the Caisse, to appear in committee.

A recorded division was thereupon demanded and, at the request of Mr. Dupuis, Government House Leader, the vote was deferred until Routine Proceedings later in today's sitting. Accordingly, the putting of the question on the want of confidence motions presented during the debate on the Opening Speech was deferred until Routine Proceedings later in today's sitting.

Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mrs. Beaudoin (Rosemont), Mr. Arcand, Minister of International Relations, Mrs. Roy (Lotbinière) and Mr. Khadir (Mercier) jointly moved:

THAT the National Assembly express its strong disapproval of the Afghan bill that would make it illegal for Shiite minority women to refuse to have sex with their husbands;

THAT it ask the Afghan Government to honour its human rights obligations, particularly as regards women's rights, and reconsider its family code which interferes with their fundamental freedoms.

Government Bills

Passage in Principle
