## **Introduction of Bills**

By leave of the Assembly to set aside Standing Orders 84 and 185, Mr. Ratthé (Blainville), Mr. Bachand, Minister of Economic Development, Innovation and Export Trade, and Mr. Deltell (Chauveau) jointly moved:

THAT the National Assembly mark Québec Retail Trade Week and salute the holding of the 9<sup>th</sup> Annual Retail Trade Convention which takes place in Montréal on 30 and 31 March 2009.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Orders 84 and 185, Mrs. Courchesne, Minister of Education, Recreation and Sports, Mrs. Champagne (Champlain), Mr. Deltell (Chauveau) and Mr. Khadir (Mercier) jointly moved:

> THAT this Assembly mark the holding, from 28 March to 4 April 2009, of Québec Adult Learners Week and salute the efforts made by thousands of adults throughout Québec who have undertaken training;

> THAT this Assembly thank all of the stakeholders and partners of adult education and professional development who, for years, have combined their efforts to constantly improve the quality and scope of services provided to the population;

> THAT this Assembly also mark the work carried out by the Institut de coopération pour l'éducation des adultes, coordinator of the event.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Orders 84 and 185, Mrs. Jérôme-Forget, Minister of Finance, Mr. Legault (Rousseau), Mr. Bonnardel (Shefford) and Mr. Khadir (Mercier) jointly moved:

WHEREAS Québec was the first province to harmonize with the Federal goods and services tax (GST) in the early 1990s;

WHEREAS since then, three Atlantic provinces have harmonized with the GST in 1997 and have received compensation for this from the Federal Government totalling close to 1 billion dollars;

WHEREAS the Government of Ontario announced that it would harmonize its sales tax with the GST beginning on 1 July 2010;

WHEREAS the Federal Government will grant a 4.3 billion dollar compensation to Ontario for this harmonization, an amount that is justified in the Canada-Ontario memorandum of understanding particularly owing to the desire to stimulate economic growth and job creation, and the Federal Government will administer this new provincial tax free of charge on behalf of Ontario;

WHEREAS the Ontario sales tax will be very similar to the Québec sales tax (QST) since certain goods, such as books, will not be subject to the provincial tax and that input tax refunds in Ontario may be identical to those agreed to by Québec for an 8-year period;

WHEREAS Ontario is the fourth province to receive compensation from the Federal Government as part of the harmonization of the provincial and federal sales taxes, while Québec has not received any compensation to this day even though it was the first province to harmonize its sales tax;

BE IT RESOLVED THAT the National Assembly ask the Federal Government to treat Québec justly and equitably, by granting compensation that is comparable to that offered to Ontario for the harmonization of its sales tax with the GST, which would represent an amount of 2.6 billion dollars for Québec. The question was put on this motion; a recorded division was thereupon demanded.

By leave of the Assembly to set aside Standing Orders 84 and 185, Mr. Khadir (Mercier), Mr. Dupuis, Minister of Public Security, Mr. St-Arnaud (Chambly) and Mrs. Roy (Lotbinière) jointly moved:

THAT the National Assembly of Québec demand the maintaining of the firearms registry, including hunting weapons, and denounce Private Bill C-301 introduced by the Federal Member for Yorkton-Melville, Garry Breitkreuz, which dilutes the application and scope thereof.

By leave of the Assembly, the motion was carried.

#### **Business Having Precedence**

#### Debate on the Budget Speech

The Assembly continued the debate on the motion by Mrs. Jérôme-Forget, Minister of Finance, –That this Assembly approves in general the budgetary policy of the Government, and on the want of confidence motions moved by Mr. Legault (Rousseau), Mr. Khadir (Mercier), Mr. Simard (Richelieu), Mrs. Marois, Leader of the Official Opposition, and Mr. Girard (Gouin).

At the end of her speech, Mrs. Bouillé (Iberville) moved the following want of confidence motion:

THAT the National Assembly severely blame the Government for having let the agricultural community down by systematically refusing to increase the budget of La Financière agricole du Québec, which has been of 300 million dollars for the past 7 years, and which will cause the organization to face a deficit of more than 1.2 billion dollars in 2009.

The debate continued on the motion by Mrs. Jérôme-Forget, Minister of Finance, and on the want of confidence motions moved by Mr. Legault (Rousseau), Mr. Khadir (Mercier), Mr. Simard (Richelieu), Mrs. Marois, Leader of the Official Opposition, Mr. Girard (Gouin) and Mrs. Bouillé (Iberville).

Thirteen hours and thirty minutes having elapsed since Mrs. Jérôme-Forget, Minister of Finance, began the Budget Speech, the debate thereon was suspended in the Assembly to be resumed by the Committee on Public Finance, in compliance with the provisions of Standing Order 275.

## **Opening Speech Debate of the Session**

The Assembly resumed the debate, which had been adjourned on 12 March 2009, on the Opening Speech of the Session delivered by Mr. Charest, Premier, at the sitting of Tuesday, 10 March 2009, and on the want of confidence motions by Mrs. Marois, Leader of the Official Opposition, Mrs. Roy (Lotbinière), Mr. Khadir (Mercier), Mr. Ferland (Ungava), Mr. Drainville (Marie-Victorin), Mr. Simard (Richelieu), Mr. Cloutier (Lac-Saint-Jean), Mr. Curzi (Borduas), Mrs. Bouillé (Iberville) and Mr. Bergeron (Verchères).

#### **Debates Upon Adjournment**

The Assembly held two debates upon adjournment:

- the first, on a question by Mr. Simard (Richelieu) to Mrs. Jérôme-Forget, Minister of Finance, about public-private partnerships;
- -- the second, on a question by Mr. Girard (Gouin) to Mr. Hamad, Minister of Employment and Social Solidarity, about the void in the Québec Parental Insurance Plan.

At 6.27 o'clock p.m., Mrs. Houda-Pepin, First Vice-President, adjourned the Assembly until Wednesday, 1 April 2009, at 10.00 o'clock a.m.
