#### ORDERS OF THE DAY

#### **Business Having Precedence**

Debate on the Budget Speech

The Assembly entered upon the debate on the motion by Mrs. Jérôme-Forget, Minister of Finance, —That this Assembly approves in general the budgetary policy of the Government.

At the end of his speech, Mr. Legault (Rousseau) moved the following want of confidence motion:

THAT the National Assembly severely blame the Government for having presented a 2009-2010 budget without a recovery plan to limit the effects of the economic crisis on Québec, particularly the lack of major measures to counter dropping out of school, to adequately fund postsecondary education, to increase the productivity of businesses and minimize the number of jobs lost and to come in aid to moderate-income individuals.

At 10.53 o'clock a.m., Mr. Chagnon, Second Vice-President, suspended the proceedings for a few minutes.

The proceedings resumed at 11.01 o'clock a.m.

Following a meeting with the House leaders, Mr. Chagnon, Second Vice-President, informed the Assembly that the allocation of speaking time for the 13 hours and 30 minutes provided for in the first part of this debate had been determined as follows: a period of 6 hours and 6 minutes is set aside for the group forming the Government, including the Budget Speech; a period of 6 hours and 16 minutes is set aside for the group forming the Official Opposition, including the comments made by the representative of this group on 19 March 2009, and his address today; 53 minutes are allotted to the independent Members affiliated with the Action démocratique du Québec; and 15 minutes are allotted to the Member for Mercier. Within this framework, any time not used by a group will be transferred to the other group; any time not used by the independent Members affiliated with the Action démocratique du Québec will be transferred to the Member for Mercier, while any time not used by the Member for Mercier will be transferred to the independent Members affiliated with the Action démocratique du Québec; any time not used by the independent Members as a whole will be redistributed equally among the parliamentary groups; and individual addresses will not be limited.

The debate continued on the motion by Mrs. Jérôme-Forget, Minister of Finance, and on the want of confidence motion moved by Mr. Legault (Rousseau).

At the end of his speech, Mr. Khadir (Mercier) moved the following want of confidence motion:

THAT the National Assembly severely blame the Government for having presented a budget that will have effects that are totally contrary to the revolution of sustainable development announced by the Premier just two weeks ago.

The debate continued on the motion by Mrs. Jérôme-Forget, Minister of Finance, and on the want of confidence motions moved by Mr. Legault (Rousseau) and Mr. Khadir (Mercier).

A period of 15 minutes shall be allotted for the closing statements, which time shall be shared equally among the members of the parliamentary group forming the Government and the Members sitting in opposition;

The Minister of Agriculture, Fisheries and Food shall be a member of the said Committee during its proceedings with respect to this order of reference.
