On 29 May 2014, the Minister responsible for Access to Information and the Reform of Democratic Institutions announced the creation, within his secretariat, of a team tasked with enhancing the protection of electors' personal information; this decision followed *Le Devoir* newspaper's disclosures concerning breaches in the protection of personal data linked to the electoral list.

The Minister had asked his department to propose solutions to protect electors' confidential information.

- Would the Minister provide us with the detailed composition of this team?
- Would he specify the number of meetings held in relation to this mandate since 29 May 2014 and, for each one, indicate the date, location, purpose, agenda, and provide the list of persons present?
- Will he commit to tabling in the National Assembly all of the recommendations made by this team?
