**Tuesday, 21 October 2008 — No. 104** 

President of the National Assembly: Mr. François Gendron

The Assembly was called to order at 2.08 o'clock p.m.

Moment of reflection

The Secretary General, Mr. François Côté, tabled the following:

Copy of a letter, dated 25 June 2008, addressed to Mr. Michel Bissonnet, President of the National Assembly, by Mr. Philippe Couillard, Member for Jean-Talon, informing him of his resignation as Member for this electoral division;

The Secretary General informed the Assembly of the vacant office of President and then tabled the following:

The Secretary General then invited the longest-serving Member of the Assembly, Mr. Gautrin, Member for Verdun, to preside at the election of the President of the National Assembly.

The Presiding Officer explained the balloting procedure and, at 2.15 o'clock p.m., suspended the meeting for a few minutes.

At 3.13 o'clock p.m., the voting was concluded and the meeting was suspended for the counting of the votes by the Secretary General and Mr. Claude Bisson, Jurisconsult.

At 3.39 o'clock p.m., the Members once again took their seats.

The Presiding Officer declared that Mr. François Gendron, the Member for Abitibi-Ouest, was elected President of the National Assembly, having received a number of votes that is not less than that of the majority of the valid votes cast by the Members of the Assembly.

Accordingly, the Presiding Officer left the Chair.

Mr. Dumont, Leader of the Official Opposition, and Mrs. Marois, Leader of the Second Opposition Group, then accompanied Mr. Gendron to the Chair.

The Mace was then laid upon the Table and, consequently, the sitting opened.

Mr. President then delivered a speech.

Mr. Fournier, Government House Leader, moved:

THAT the National Assembly ratify the special procedure for the election of the President contained in the document entitled "Standing Orders and Rules of Procedure respecting the Election of the President of the National Assembly by Secret Ballot" that was tabled earlier by the most senior Member of the Assembly, the Member for Verdun, and, accordingly, that the Assembly give effect to the results of the vote held in pursuance of this procedure.

The motion was carried.

Mrs. Marois, Leader of the Second Opposition Group, Mr. Dumont, Leader of the Official Opposition, and Mr. Charest, Premier, each took the floor.

Mr. President informed the Assembly that notice of the motion to be placed on the *Order Paper and Notices* of 22 October 2008, in the name of Mr. Taillon (Chauveau), had been submitted within the specified delay, which motion is to be debated under Business Standing in the Name of Members in Opposition on that same day. This motion reads as follows:

THAT the Government table in the National Assembly, on or before 25 November 2008, an action plan to attenuate the effects of the economic slowdown. This plan must contain: 1° the measures envisaged to encourage household consumption; 2° the measures to maintain the purchasing power of the middle class; 3° the expectations with regard to the Federal Government concerning an assistance plan for Québec's manufacturing sector and the elements of its monetary policy to counter the credit crunch arising from the financial crisis; 4° the acceleration of projects that are likely to quickly stimulate job creation; 5° the effects of these measures on the budget situation of the Québec Government for the current year and for the preparation of the 2009-2010 budget.

In pursuance of Standing Order 97.1, he then tabled the following:
