Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mrs. Gagnon-Tremblay, Minister of International Relations and Minister responsible for La Francophonie, Mr. Riedl (Iberville) and Mr. Turp (Mercier) jointly moved:

THAT the National Assembly of Québec underline, in this year 2008 marked by the holding of the 12th Francophonie Summit in Québec City, the 20th anniversary of the Institut de l'énergie et de l'environnement de la Francophonie, a subordinate body of the Organisation internationale de la Francophonie established in Québec City, and its important contribution to developing the Francophone space in the fields of energy, the environment and sustainable development, and recall that this institute was created under the guidance of former Premier of Québec, Mr. Robert Bourassa, following the 2nd Francophonie Summit held in Québec City in 1987.

By leave of the Assembly to set aside Standing Order 185, Mr. Gosselin (Jean-Lesage), Mr. Couillard, Minister of Health and Social Services and Minister responsible for the Capitale-Nationale region, and Mrs. Maltais (Taschereau) jointly moved:

THAT the National Assembly mark the remarkable exploit of two citizens of the Capitale-Nationale region, Mrs. Sylvie Fréchette and Mr. François Thivierge, who reached the summit of Everest last 20 and 22 May, in two separate expeditions; upon completing his ascent, Mr. Thivierge planted the flag of the 400th anniversary of Québec City at the top of the world; mother of three children, Mrs. Fréchette is only the second Québec woman to have accomplished this formidable physical and psychological feat.

By leave of the Assembly to set aside Standing Order 185, Mr. Bergeron (Verchères), Mrs. Courchesne, Minister of Education, Recreation and Sports and Minister of Families, and Mrs. Méthé (Saint-Jean) jointly moved:

THAT the National Assembly underline the World Day Against Child Labour, which will be marked this year by numerous events organized worldwide to make known the message: Education is the correct response to child labour.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Order 185, Mr. Pelletier, Minister responsible for Canadian Intergovernmental Affairs, Aboriginal Affairs, Francophones within Canada, the Reform of Democratic Institutions and Access to Information, Mr. Desrochers (Mirabel) and Mr. Ferland (Ungava) jointly moved:

THAT the National Assembly acknowledge the historic gesture of the House of Commons, which, on 11 June 2008, offered a formal apology to the Natives who suffered serious abuse while attending residential schools against their will;

THAT it recall the motion carried by the National Assembly, on 20 March 1985, which recognized the existence of the Abenaki, Algonquin, Attikamek, Cree, Huron, Micmac, Mohawk, Montagnais, Naskapi and Inuit nations in Québec, and that of 30 May 1989, which recognized the Maliseet nation;

THAT it express its sincere compassion to all of the Native students who endured pain and suffering while attending these residential schools and who still today have difficulty healing their pain;

THAT it underline the courage and determination of these women and men who continued to have confidence in themselves and in life:

THAT it express the hope that this gesture will bring us together to reflect on this dark chapter of Canadian history, to reaffirm the values that unite us, to strive to make certain that these injustices never happen again, and to make us further aware collectively of the concerns of Native peoples;

THAT it indicate its desire that this apology will enable the victims to live life with increasing hope, appreciation and respect.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

Government Bills

Report Stage
