The Assembly proceeded to Oral Question Period.

#### **Motions Without Notice**

By leave of the Assembly to set aside Standing Order 185, Mrs. Vallée, Minister of Justice, together with Mr. Cloutier (Lac-Saint-Jean), Mrs. Roy (Montarville) and Mrs. Massé (Sainte-Marie–Saint-Jacques), moved:

THAT the National Assembly mark International Day against Homophobia and Transphobia, to be observed on 17 May 2015;

THAT it denounce all forms of discrimination, intimidation and violence against members of the LGBT communities;

THAT it reaffirm its support and solidarity toward these communities and applaud the commitment of all who help fight homophobia and transphobia;

THAT the members of this Assembly continue to work together to remove the barriers that persist despite progress made in order to make Québec an open, inclusive society for all citizens so as to achieve true gender equality;

THAT, lastly, it commit to pursuing efforts to ensure the safety, integrity, dignity and freedom of all Quebecers, regardless of their sexual orientation or gender identity.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

By leave of the Assembly to set aside Standing Order 185, Mr. Bédard, Leader of the Official Opposition, together with Mr. Couillard, Premier, Mr. Legault, Leader of the Second Opposition Group, and Mr. Khadir (Mercier), moved:

THAT the National Assembly underline National Patriots' Day, to be observed on 18 May 2015;

THAT it remember the importance of the patriots' struggle in 1837–1838 for the recognition of our nation, for its political freedom and for the establishment of a democratic government.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

Mr. Bonnardel (Granby), together with Mrs. David (Gouin), moved a motion concerning the awarding and management of public contracts in the information technologies and communications industry; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mrs. Massé (Sainte-Marie–Saint-Jacques), together with Mr. Villeneuve (Berthier) and Mrs. D'Amours (Mirabel), moved:

THAT the National Assembly designate 2015 as International Year of Soils, as declared by the UN General Assembly, and underline that healthy soils help ensure food security and fight climate change;

THAT the Assembly affirm that Québec's farmlands are a precious resource to be protected and developed in harmony with the ecosystems they are part of.

By leave of the Assembly, the motion was carried.

#### **Notices of Proceedings in Committees**

Mr. Sklavounos, Deputy Government House Leader, convened the following committees:

- the Committee on Institutions, to conclude its public hearings within the framework of special consultations on the draft regulation concerning the Regulation respecting change of name and of other particulars of civil status for transsexual and transgender persons;
- the Committee on Public Finance, to continue its public hearings within the framework of special consultations on Bill 38, An Act to allow the Caisse de dépôt et placement du Québec to carry out infrastructure projects;
- the Committee on Labour and the Economy, to continue its clause-byclause consideration of Bill 37, An Act to confirm that the cement plant and maritime terminal projects in the territory of Municipalité de Port-Daniel–Gascons are subject solely to the authorizations required under section 22 of the Environment Quality Act.

And by leave of the Assembly to set aside Standing Order 143, he convened the following committee:

— the Committee on Labour and the Economy, to conclude its public hearings within the framework of special consultations on Bill 42, An Act to group the Commission de l'équité salariale, the Commission des normes du travail and the Commission de la santé et de la sécurité du travail and to establish the Administrative Labour Tribunal.

#### Passage in Principle

The Assembly resumed the debate, which had been adjourned on 13 May 2015, on the motion moved by Mr. Barrette, Minister of Health and Social Services, that Bill 20, An Act to enact the Act to promote access to family medicine and specialized medicine services and to amend various legislative provisions relating to assisted procreation, do now pass in principle.
