#### ORDERS OF THE DAY

#### **Government Bills**

Passage in Principle

Mrs. Normandeau, Minister of Municipal Affairs and Regions, moved, —That Bill 82, An Act to amend various legislative provisions respecting municipal affairs, do now pass in principle.

After debate thereon, the motion was carried and Bill 82 was accordingly passed in principle.

Mr. Fournier, Government House Leader, moved that Bill 82 be referred for clause-by-clause consideration to the Committee on Planning and the Public Domain.

The motion was carried.

Mr. Béchard, Minister of Natural Resources and Wildlife, moved, —That Bill 87, An Act to establish a mining heritage fund, do now pass in principle.

After debate thereon, the motion was carried and Bill 87 was accordingly passed in principle.

Mr. Fournier, Government House Leader, moved that Bill 87 be referred for clause-by-clause consideration to the Committee on Labour and the Economy.

The motion was carried.

Report Stage

The Assembly took into consideration the report from the Committee on Social Affairs on its clause-by-clause consideration of Bill 70, An Act to amend the Act respecting health services and social services, the Health Insurance Act and the Act respecting the Régie de l'assurance maladie du Québec, together with the amendments handed in by Mr. Couillard, Minister of Health and Social Services.

The amendments were declared in order.

After debate thereon, the amendments were carried.

The report, as amended, was concurred in.
