#### ORDERS OF THE DAY

### **Business Standing in the Name of Members in Opposition**

Mrs. Roy (Lotbinière) moved:

THAT the National Assembly demand that the Government ensure greater security for citizens by increasing the complement of police officers, particularly through a heightened presence on our roads.

Following a meeting with the House leaders, Mrs. Houda-Pepin, First Vice-President, informed the Assembly of the speaking time for the proceedings with respect to this motion: 10 minutes shall be allotted for a reply by its mover; the remaining time will be distributed among the parliamentary groups, who will have a time envelope that corresponds to the proportion of seats they respectively have in the Assembly; any time not used by a group will be transferred to the two other groups, in accordance with the proportion of seats they hold; and individual addresses shall not be limited.

#### **ROUTINE PROCEEDINGS**

Mr. President rendered his decision on the point of privilege raised by the House Leader of the Second Opposition Group on 13 November 2007. According to the latter, the Minister of Transport was allegedly in contempt of Parliament by releasing the contents of a bill that had not yet been introduced in the Assembly and by referring to legislative provisions that had not yet been adopted as though they had force of law.

#### **RULING FROM THE CHAIR**

Nothing in the facts alleged allows the Chair to conclude that there was, at first glance, contempt of Parliament.

In this case, nothing indicates that the text of the bill was released before its introduction, even if it is clear that several measures contained in the bills coincide with information contained in the Minister's news release or published in the newspapers.

Furthermore, nothing in the documents submitted allows us to conclude that the Minister acted as though the bill had force of law.

However, the Chair is extremely concerned by the matters raised and particularly by the release of elements contained in a bill before its introduction in the Assembly. The Chair does not deny that the Government has the responsibility of informing the public on measures it intends to take. However, when these measures take the form of a bill, it is important that the Members be the first informed of the details of the contents of a bill.

The current state of jurisprudence is such that only the communication of the text of a bill could constitute contempt of Parliament. Even if there are no grounds on which to proceed now with a precedential change, all Members must act prudently and keep in mind the role of the parliamentary institution and its Members when the time comes to release the contents of a bill they wish to submit to the Members of the Assembly. More particularly, Government Members, even if they are responsible for communicating with the public, must always have in mind the role of Members in the legislative process. Otherwise, the Chair could be required to strengthen jurisprudence.
