#### **Motions Without Notice**

By leave of the Assembly to set aside Standing Order 185, Mrs. St-Pierre, Minister of International Relations and La Francophonie, together with Mrs. David, Minister of Culture and Communications, Mrs. Poirier (Hochelaga-Maisonneuve), Mrs. Samson (Iberville) and Mrs. Massé (Sainte-Marie–Saint-Jacques), moved:

> THAT the National Assembly mark the 10th anniversary of the Convention on the Protection and Promotion of the Diversity of Cultural Expressions and that it highlight the leading role that Québec's experts, civil society and the Québec Government have played in developing, passing and ratifying this Convention;

> THAT the National Assembly applaud the Québec Government's third contribution to the International Fund for Cultural Diversity, which aims to foster the emergence of dynamic cultural sectors in developing countries;

THAT the National Assembly reaffirm the importance it places on furthering the Convention's principles and objectives within various international forums and on its implementation in the digital environment;

THAT, lastly, the National Assembly reaffirm the essential nature of State support for Québec culture, which promotes the diversity of cultural expressions in a spirit of dialogue, respect and openness toward other cultures.

By leave of the Assembly, the motion was carried.

Mr. Bergeron (Verchères) moved a motion concerning the services offered by ferries reporting to the Société des traversiers du Québec; this motion could not be debated for want of unanimous consent.

Mr. Martel (Nicolet-Bécancour) moved a motion concerning the Québec–Lévis and Sorel-Tracy–Saint-Ignace-de-Loyola ferries' right to strike; this motion could not be debated for want of unanimous consent.

Mrs. David (Gouin), together with Mr. Bonnardel, Second Opposition Group House Leader, moved a motion concerning proportional representation during the next federal election; this motion could not be debated for want of unanimous consent.

#### **Notices of Proceedings in Committees**

Mr. Sklavounos, Deputy Government House Leader, convened the following committees:

#### Information on the Proceedings of the Assembly

In response to a question raised on 8 October 2015 by Mr. Drainville, Official Opposition House Leader, Mr. Gendron, Third Vice-President, handed down a directive on statements made by a Minister in committee and outside parliamentary proceedings about Members from the Official Opposition within the framework of the clause-by-clause consideration of Bill 20, An Act to enact the Act to promote access to family medicine and specialized medicine services and to amend various legislative provisions relating to assisted procreation.

#### DIRECTIVE FROM THE CHAIR

With regard to comments made in committee, parliamentary jurisprudence has consistently established that when presiding, the Committee Chair has the same powers and duties as the President of the National Assembly and therefore has full authority to make rulings. This same jurisprudence has established that the Chair of the Assembly shall not interfere in committee proceedings or give a directive on a ruling made in committee.

With regard to comments made in committee proceedings, the Committee Chair alone has the power to rule on these statements.

With regard to comments made outside parliamentary proceedings in a media scrum and reported in newspaper articles, the Chair of the Assembly recalls the principle stating that its jurisdiction does not extend to remarks made outside the National Assembly Chamber.

That said, the Chair of the Assembly reiterates that, in our democratic system, the Government has various parliamentary tools at its disposal to have the bills it introduces in the Assembly passed. The Standing Orders also provide for mechanisms enabling Members in Opposition to express their views on a bill. They are entitled to use these mechanisms legitimately, regardless of whether doing so prolongs the bill's consideration. In other words, the Members are vested with full independence for carrying out their duties.

Mrs. Gaudreault, Second Vice-President, informed the Assembly that on Wednesday, 21 October 2015, during Business Standing in the Name of Members in Opposition, a debate would be held on the motion moved by Mr. Bérubé (Matane-Matapédia).

This motion reads as follows:

THAT the National Assembly declare that the recent stay of proceedings against five members of the Hell's Angels in the SharQc trial is a fiasco that undermines the credibility of the "mega-trial" formula, which is considered an important tool in fighting organized crime; THAT it note that, in his ruling, Justice James L. Brunton criticized Director of Criminal and Penal Prosecutions (DCPP) prosecutors;

THAT it also note that Québec police forces worked for years to gather enough evidence to bring serious charges against these highly criminalized individuals and that the Québec State devoted substantial financial resources to this effort;

THAT it acknowledge that this fiasco has occurred just as the Liberal Government decided to eliminate 40% of the prosecutors who fight organized crime, and that the Liberal Government did not keep its promise to reinvest in resources for the Director of Criminal and Penal Prosecutions;

THAT it stress how extremely serious this situation is, that an in-house DCPP inquiry alone will not restore Quebecers' confidence and that it is the duty of the Minister of Justice, who bears ultimate responsibility for the administration of justice in Québec, to order an independent inquiry;

THAT, lastly, following this inquiry, the National Assembly demand that the Minister of Justice testify before a parliamentary committee to explain the reasons that brought the SharQc trial to a halt and that, at this time, the Minister table a plan of remedial measures to be implemented within the justice system so that similar situations do not occur in future.

## **ORDERS OF THE DAY**

#### **Government Bills**

#### Passage

Mr. Leitão, Minister of Finance, moved the passage of Bill 13, An Act to give effect to the Budget Speech delivered on 4 June 2014 and to various other fiscal measures.

After debate thereon, the motion was carried on division and, accordingly, Bill 13 was passed.

At 3.22 o'clock p.m., at the request of Mrs. Vien, Deputy Government House Leader, Mrs. Gaudreault, Second Vice-President, suspended the proceedings until 4.15 o'clock p.m.

The proceedings resumed at 4.16 o'clock p.m.

Report Stage

The Assembly took into consideration the report from the Committee on Agriculture, Fisheries, Energy and Natural Resources on its clause-by-clause consideration of Bill 55, An Act respecting transparency measures in the mining, oil and gas industries.

After debate thereon, the report was concurred in on division.

At 4.46 o'clock p.m., at the request of Mrs. Vien, Deputy Government House Leader, Mr. Gendron, Third Vice-President, suspended the proceedings until 6.00 o'clock p.m.

#### **Debates upon Adjournment**

At 6.00 o'clock p.m., the Assembly held two debates upon adjournment:

- the first, on a question from Mr. Turcotte (Saint-Jean) to Mr. Blais, Minister of Education, Higher Education and Research, about the future of community education centres;
- the second, on a question from Mr. Jolin-Barrette (Borduas) to Mrs. Vallée, Minister of Justice, about the need to hold a parliamentary committee on the resources allocated to the Directeur des poursuites criminelles et pénales and the government's plan to fight organized crime.

Mrs. Vien, Deputy Government House Leader, moved the adjournment of the Assembly until Wednesday, 21 October 2015 at 9.40 o'clock a.m.

The motion was carried.

Accordingly, at 6.25 o'clock p.m., Mr. Gendron, Third Vice-President, adjourned the Assembly until Wednesday, 21 October 2015 at 9.40 o'clock a.m.
