(81) Mr. Drainville (Marie-Victorin) – 24 September 2015 To the Premier

The Lieutenant-Governor has the power to recommend bills introduced in the National Assembly. Since the beginning of the 41st Legislature, he has made recommendations regarding bills 11, 13, 28 and 56.

We would like to have:

- A copy of each brief having led to the approval or refusal of the Lieutenant-Governor's recommendation of a bill during the 41st Legislature;
- The documentation supporting this approval or refusal of a recommendation for each of the bills;
- A copy of each of the recommendations for bills during the 41st Legislature;
- The number of hours and the financial and human resources involved in the approval or refusal of a recommendation.

(82) Mr. Villeneuve (Berthier) – 30 September 2015 To the Minister of Health and Social Services

We would like to have:

- the total number of recognized stabilization centres in Québec;
- the number of stabilization centres whose status has changed since 2012 and their location;
- the number of regions recognized as being remote (all three levels);
- the number of regions that applied for remote region status since 2012 and their location;
- the amounts paid in 2013-2014, in 2014-2015 and in 2015-2016 to private employment agencies for nurses and nurses' aides in the Lanaudière region;
- the amounts paid in 2013-2014, in 2014-2015 and in 2015-2016 in overtime for nurses and nurses' aides in the Lanaudière region.

(83) Mr. Caire (La Peltrie) – 6 October 2015 To the Minister of Families

Computer projects:

 The information space project – management of new indicators has been suspended for 242 days. The project should have been completed on 31 March 2015. The September 2015 information resources dashboard update shows that the project is still suspended after 242 days.

The timeline indicator shows a 0 % variation and the status display is green. The organization gave no explanation for the delay. Can the Minister justify the delay as provided for by the Conseil du trésor in the dashboard?

- 2. The migration of the management information portal was to have been completed on 31 December 2014. The project had an authorized budget of \$203,100. In September 2015, the information resources dashboard indicates a cost overrun with regard to the authorized budget. The Public Curator does not provide any explanation. Can the Minister explain the cost overrun to us?
- 3. The allocations update (CIS) was suspended for 364 days. The project was supposed to have been completed on 30 September 2014. In the information resources dashboard update, the revised end date is 31 October 2014. The organization does not give any explanations. Can the Minister explain the schedule overrun to us?
- 4. The merging of the initial and revised grant processing phases was supposed to have been completed on 30 September 2014 at the Ministère de la Famille. The project is no longer in the information resources dashboard despite its not being completed at the last update. Can the Minister provide us with the project status report?

(84) Mr. Caire (La Peltrie) – 6 October 2015To the Minister of Education, Higher Education and Research

Computer projects:

- 1. The computer infrastructure project of the Institut de tourisme et d'hôtellerie du Québec was supposed to have been completed on 30 June 2014. In September 2015, the completion date was revised and changed to 30 June 2015. The organization provides no explanations and the timeline indicator shows 0 % and a green status display in the information resources dashboard. Can the Minister explain the schedule overrun to us regarding this project that began in 2012?
- 2. Seventeen percent of the office technology migration at the Institut de tourisme et d'hôtellerie du Québec was completed as at 13 May 2015. The revised completion date was 1 June 2014. We cannot find this project in the information resources dashboard update. Can the Minister provide us with this project's status report?

(85) Mr. Caire (La Peltrie) – 6 October 2015 To the Minister of Justice

Computer projects:

 On 5 May 2013, the MANIT – Télécommunication et vidéo-conférence project was in the Conseil du trésor's information resources dashboard. The project was not completed, but it should have been since 31 March 2015.

Same goes for the printing optimization project, which was 77 % completed and should have been fully carried out by 5 January 2105. Both projects are no longer in the dashboard at this time.

Can the Minister provide us with the status report for both projects, one of \$506,000 and the other of \$749,400, both initiated in 2013?

(86) Mr. Caire (La Peltrie) – 6 October 2015To the Minister of Municipal Affairs and Land Occupancy

Computer projects:

1. The Archivage et refontes d'applications de faible envergure project was supposed to have been completed on 31 March 2014. Since the project has not progressed since then, the information resources dashboard indicates a new revised completion date on 31 March 2016.

A message states that the organization has indicated that the project is progressing according to plans. The timeline indicator shows a 0% variation and a green status display. The project's overall progress percentage is 15%. Can the Minister provide us with the true picture of the project since it was launched on 1 September 2013?

2. An automated management tool and a workstation security patching procedure were to have been in place by 31 March 2015. As of today, the project has not been completed and a new revised completion date has been set for 31 December 2015.

The cost indicator shows a 4.10 % variation. A cost overrun is therefore to be expected. Can the Minister give us an idea of the extent of the cost overrun for the project?

3. The Société d'habitation du Québec's workstation security fixes were to have been in place by 31 March 2015. A revised completion date has been set for 31 December 2015.

Yet, the timeline indicator shows a 0 % variation. The cost indicator shows a 4.1 % variation. The organization has not provided any explanations. Can the Minister tell us exactly what is going on regarding this computer project?

4. The Société d'habitation du Québec's database migration to the 11G version was supposed to have been completed by 30 September 2014. As at 13 May 2015, the project had not been completed and the cost indicator showed a 9.3 % variable without any explanations from the organization.

On 29 September, the project was completed, but the actual completion date is the same as the revised completion date, that is, 20 September 2014. The organization indicates that the cost overruns regarding permits and purchases as well as regarding the efforts and costs incurred for outside resources were necessary to complete the project. Can the Minister give us an explanation for the poor assessment of project requirements and give us the project's actual completion date?

5. The mobile customer offer and meeting rooms project was supposed to have been completed by 31 December 2014. In September 2015, the project is not completed and the new revised completion date is 31 December 2015.

The organization has not provided any explanation regarding failure to comply with the deadline. Can the Minister provide us with the explanation that should appear in the information resources dashboard?

6. Workstation infrastructure upgrading was supposed to have been completed by 31 December 2014. In September 2015, the project is not completed and the new revised completion date is 31 December 2015.

The organization has not provided any explanation regarding failure to comply with the deadline. Can the Minister provide us with the explanation that should appear in the information resources dashboard?

7. Development infrastructure upgrading was to have been completed by 31 March 2015. In September 2015, the project is not completed and the new revised completion date is 31 July 2015. The timeline indicator shows a 0 % variation and a green status display.

The organization has not provided any explanation regarding failure to comply with the deadline. Can the Minister provide us with the explanation that should appear in the information resources dashboard?

8. The revision of the printing of reports produced with the central platform was supposed to be completed by 31 March 2015. In September 2015, the project is not completed and the new revised completion date is 31 March 2016. The timeline indicator shows a 0 % variation and a green status display.

The organization has not provided any explanation regarding failure to comply with the deadline. Can the Minister provide us with the explanation that should appear in the information resources dashboard?

(87) Mr. Caire (La Peltrie) – 6 October 2015 To the Minister of Transport

Computer projects:

1. The Ministère wants to develop a Web application to facilitate the operation of the Ministère's Système de Gestion de la Sécurité (SGS) des aéroports. The project was launched in February 2010 and still has not been completed according to the information resources dashboard. According to the timeline indicator, there is a 31.7 % variation with a new revised timeline set at 31 March 2016.

The organization mentions that the project is progressing according to plans, but that the gap exists because Phase 1 of the project did not adequately meet security management system (SGS) procedures. As at 13 May 2015, according to the dashboard, the project was progressing according to plans. How can this change be explained after having spent 4 years developing this \$690,000 project?

2. Concerning the Sécurité de l'information – certification et authentification project, the information resources dashboard mentions that it has been suspended for 466 days. The project was supposed to have been completed on 31 March 2015 according to the information available last 13 May. In the new dashboard, the timeline indicator shows a 25.2 % variation and a new revised timeline set at 30 March 2016.

The organization mentions that because of the water damage and the priority given to updating the computer contingency plan, the completion date was delayed for a year. The project has been suspended for 466 days, that is, before the water damage. Can the Minister explain to us why the project has now been suspended for 466 days?

3. The Agence métropolitaine de transport cancelled the CRM project for marketing and customer service, itself suspended for 210 days, since following the announcement of AMT's abolition, phase 2 of the project was cancelled. A reordering of the overall projects/initiatives identified was carried out within the organization to ensure continuity of new developments in future entities.

Considering that there are 8 projects involving the Agence métropolitaine de transport appearing in the dashboard and that most have not been completed, can the Minister provide us with the details, including the costs, of the projects that will be recovered and of those that will simply be abandoned?

4. The creation of the insurance rates databank was to have been completed on 31 December 2014. The project began in 2006. A few months later, the computer resources dashboard indicated that the project has been completed, but that the actual completion date is the same as the revised date indicated on 13 May 2015.

According to the dashboard, close to \$200,000 were spent between the months of May and September without any modification of the revised completion date. Can the Minister tell us why?

5. The strategic planning module (GSQ) had been suspended for 392 days as at 13 May 2015. However, the project was to have been completed by 31 March 2014. In September 2015, the project has still been suspended for the past 392 days according to the information resources dashboard.

The timeline indicator shows a 20.6 % variation for over 392 days of suspension. The organization mentions that the unavailability of a key resource on the users' side (extended absence) has caused additional delays. The GSQ system is the tool that is used by the Ministère des Transports to manage structures. Can the Minister confirm that system management depends on one resource and give us the project's new revised completion date?

(88) Mr. Caire (La Peltrie) – 6 October 2015 To the Minister of Energy and Natural Resources

Computer projects:

1. The upgrading of the Ministère's office automation platform was to have been completed by 31 March 2015 according to the information displayed in the computer resources dashboard of 13 May 2015. At the most recent updating, the revised completion date remains the same, but the project still has not been completed.

The timeline indicator shows a 5.1 % variation and a green status display. The organization does not provide any explanation regarding the delay. Can the Minister provide explanations, such as requested by the Conseil du trésor?

2. The programming of CAPSIS' new growth models was to have been completed by 31 March 2015. As of today, the new revised completion date is 4 June 2015. The project still has not been completed.

The organization mentions that a request was made to extend the project's deadline because work began three months later than originally scheduled. Nine months later, the project still has not been completed and the timeline indicator shows a 9.7 % variation. Can the Minister tell us why?

(89) Mr. Caire (La Peltrie) – 6 October 2015

To the Minister of Sustainable Development, the Environment and the Fight Against Climate Change

Computer projects:

1. The implementation of a collaborative portal with an integrated document management system at the Société québécoise de récupération et de recyclage was to have been completed on 31 October 2014. In its latest update, the computer resources dashboard indicates a new revised completion date for 30 November 2015.

The timeline indicator shows a 0 % variation and a green status display. The organization has added \$160,000 for the project's additional outside resources. Can the Minister give us a status report as regards the project's actual deadline overrun?

2. The Volunteer Lake Monitoring Network (RSVL) (P-001) is a Ministère project that was to have been completed by 1 March 2015. After a 927-day suspension, the project is 61 % completed.

In the information resources dashboard update of September 2015, the timeline indicator shows a 2.7 % variation with a green status display. The project has now been suspended for 1130 days. The organization does not provide any explanation. Can the Minister provide explanations regarding the 1130-day suspension?

- 3. The improvement of the Ministère's SAGO system and its related systems (P-009) was to have been completed by 31 March 2015. As of today, the new revised completion date is 10 June 2015 and the timeline indicator shows a 9.6 % variation. There are no explanations for this delay. Can the Minister give us the project's status report?
- 4. The securing of the Ministère's access to production data and logging (DRI-83) was to have been completed by 31 March 2015. The project has been suspended for the past 213 days. As of today, the new revised completion date is 1 March 2016 and the timeline indicator shows a 9.4 % variation. There is no explanation for the delay. Can the Minister give us the project's status report?

(90) Mr. Caire (La Peltrie) – 6 October 2015 To the Minister of Labour, Employment and Social Solidarity

Computer projects:

1. The project to optimize the territorial references data system (LOC) was to have been completed by 1 May 2015 at the Régie du bâtiment du Québec. Without any explanation, the project still has not been completed and the new information resources dashboard indicates a green status display. The project began in 2012 and nothing indicates that it will soon be completed. Can the Minister provide us with the project's status report to ensure transparency?

2. The implementation of a project management system at the Régie du bâtiment was to have been completed by 1 October 2014. In the most recent update of the information resources dashboard, the new revised completion date is 1 June 2015.

The Régie du bâtiment du Québec mentions that the production launch has been postponed by two months. The timeline indicator is of 15.3 % and several months after the revised completion date, the project is still at 80 % completion. Can the Minister give us the project's status report?

(91) Mr. Caire (La Peltrie) – 6 October 2015 To the Minister of Public Security

Computer projects:

1. The Alcool (Acolyte) system overhaul project was launched in April 2009. It is currently 43 % completed with a revised completion date set for 31 October 2015. The timeline indicator of the information resources dashboard indicates a 5.40 % variation without any explanation provided by the organization with regard to the variances. The organization indicates that the project is progressing on schedule.

The liquor permit issuing system was developed in 1984. Can the Minister explain the 5.4 % variation in the deadline of this project which is beginning its sixth year with only 45 % of the project carried out?

2. The office suite and Windows 8 migration at the Ministère de la Sécurité publique was to have been completed on 31 March 2015. In the information resources dashboard of September 2015, the new revised date of completion is 31 July 2015. The timeline indicator shows a 71 % variation.

In a lengthy technical explanation, the organization mentions that the project will be completed within budget. The project began in 2013 for an amount of \$2,827,900. How can the project exceed the delay by over a year and not have any impact on the costs? Can the Minister provide us with the project's status report?

3. The CQLC forms overhaul was scheduled for 28 February 2015. The new revised completion date is 30 September 2015. The timeline indicator shows a 63.9 % variation.

The organization mentions that a revision of the project's existing processes brought about changes in the scope. The project is currently 71 % completed. What are the changes made to the project to explain the 7-month delay?

4. The upgrading of the detention infrastructure network was to have been completed by 31 March 2015. The new revised completion date is 12 December 2015. The organization mentions that the latest site's migration date has been postponed owing to staff unavailability.

The project is 76 % completed and the line indicator is at 28.60 %. What is the Minister's plan to better assess staff availability when she undertakes a computer project?

5. The purpose of the GFAI – DRI Croissance de l'espace magnétique project was to increase the hosted data storage space to ensure continuity of operations. The revised completion date was 31 March 2015 in the information resources dashboard's last update.

The project no longer appears in the dashboard update. Since the project was not completed in May 2015, can the Minister provide us with the project's current status report?

6. The security intelligence system overhaul (SIR) was to have been completed by 31 March 2015. The new revised completion date is 31 March 2016. The timeline indicator shows a 49.1 % variation.

The organization mentions that unforeseen events regarding the administrative process caused a delay in this project's timetable. Can the Minister tell us what the unforeseen events causing a one-year delay are?

(92) Mr. Caire (La Peltrie) – 6 October 2015 To the Minister of Health and Social Services

Computer projects:

1. The Service Clientèle en Ligne application replacement project was to have been completed by 31 March 2015. It has now been suspended. The organization mentions that delays in resource supply have forced the suspension of this project.

There is no information as to the number of days the suspension will last, nor is there any indication as to when the project will resume. Can the Minister provide us with the status report of the project that is 40 % completed?

2. The merging of 2014-2015 development systems which brings together all of the requests concerning existing small-scale development systems (less p-d) for the year 2014-2015 was to have been completed by 30 April 2015. As of today, the project has not been completed.

According to the information resources dashboard, delays in the supply of outside resources resulted in the reduction of the number of projects initially included in this service clustering. This explains the disparity between the initial amount envisaged and the proposed amount. The dashboard timeline indicates a green status display. Can the Minister confirm that the project targeting 2014-2015 will not be ready before 2016?

3. The overhaul of the reference system of the RSSS establishments was to have been completed on 1 March 2015. Today, the revised completion date is 30 September 2015. The timeline indicator shows a 30.4 % variation.

The organization attributes the deadline overrun to Bill 10. According to the organization, the system is also highly outdated, with portions still on the central computer. The entire system must be overhauled. Can the Minister tell us how he plans to relaunch the RSSS establishments reference overhaul?

4. The "workstation development" project of the Régie de l'assurance maladie du Québec, which was to have been completed on 12 December 2014, resulted in a cost overrun. There are no explanations provided in the information resources dashboard.

It should also be noted that as at 31 May 2015, the project had not been completed, but that as at today, the actual completion date is 31 October 2015. Can the Minister explain the cost overrun?

5. The "inspection systems" project was to have been completed by 30 April 2014. It is not yet completed. The organization mentions that, owing to the lack of resources to complete the project, it has suspended a portion of 2014-2015, which explains the deadline overrun.

Can the Minister give us a new revised completion date for the management project that supports the inspections processes?

(93) Mr. Caire (La Peltrie) – 6 October 2015 To the Minister of Culture and Communications

Computer projects:

1. The Virtuo small purchases module project of the Musée d'Art contemporain de Montréal shows a cost overrun of \$30 k. The project was to have been completed by 12 December 2015.

The organization explains the disparity by stating that the \$30 k difference between the cost of the project and the authorized budget can be explained by the decision to include the salary of an in-house technician dedicated to the project.

The project was supposed to cost only \$38,000 when first authorized. It ended up costing \$134,000 in 2015. Can the Minister confirm that the in-house technicians' salaries will be added to all computer projects?

2. The museum data management project (GIPA) of the Musée de la Civilisation was to have been completed on 31 March 2015. The organization mentions that the data conversion work took much longer than expected, that the solution has now been deployed for all users and that they are currently in a stabilization period.

The new information in the information resources dashboard mentions that the project has not been completed and that it was to have been completed by 30 June 2015. The timeline indicator is at 25 %. Can the Minister tell us exactly what is going on regarding this project?

(94) Mr. Caire (La Peltrie) – 6 October 2015 To the Chair of the Conseil du trésor

Computer projects:

1. The Centre de services partagés du Québec purchased and implemented an integrated desktop virtualization infrastructure. On 13 May 2015, \$533,700 \$ had been spent. Today, the project has been completed at a cost of \$5,019,300 with cost and deadline overruns.

The organization mentions that the work to harmonize the solution with the CSPQ's technological infrastructures exceeded the planned costs. There is therefore no specific explanation. How, within a few months, did the CSPQ spend over 4 million dollars and exceed the authorized costs?

2. The server infrastructure virtualization of the SAGIR business solution is in production at the Centre de services partagés du Québec. The project, which was to have been completed by 31 March 2015, was postponed until 30 June 2015. According to the information resources dashboard, the timeline indicator shows 8.5 % and the project is 40 % completed in spite of the green display status. The organization states that the revised completion date will allow for a better harmonization with the customer's activities and calendar, without any impact on the costs and scope. How can the project not create a cost and deadline overrun if the revised completion date is already passed and the project has not been completed?

3. The Centre de services partagés du Québec developed the Masse et Centrage system to directly communicate any changes in aircraft weight and to keep a record of aircraft weight changes. The most recent information resources dashboard update indicates that the revised completion date was 31 March 2015. Today, the new date is 1 June 2015 and the project is still not completed.

The variation indicator shows 22.5 % and the explanation is summed up as the completion date being postponed to cover the application's post implementation period. Why is it that the revised completion date has ended and that the explanation concerns the completed project?

4. The Oracle BD and OAS-ATW upgrading project was to have been completed by 31 March 2015. The project was postponed until 30 September 2015. The timeline indicator shows 27.3 % and the organization explains that the timeline revision for a better harmonization with the customer's activities and calendar has no impact on the costs and scope.

How can you change a deadline by several months without any impact on costs and scope? Can the Minister confirm that no CSPQ public servant worked more because of this project's deadline postponement?

5. The Centre de services partagés du Québec wanted to equip itself with a new management system for its air operations, in service mode, to replace the current outdated system. The project was to have been completed by 6 March 2015, but the revised completion date was replaced by 31 March 2015.

The project still has not been completed and the timeline indicator shows 2.4 %. The organization provides no explanation for these disparities. Since the CSPQ is going to divest itself of air operations, will it complete the computer project and how is the disparity explained? 6. The antivirus upgrade at the Centre de services partagés du Québec was to have been completed on 31 March 2015 but the revised completion day was changed to 30 September 2015. The timeline variation is of 25.5 %. The organization explains that the revised timeline, caused by the recognized obligation to manually deploy the antivirus, is without impact on the costs and scope of the previous authorization.

This project was authorized on 4 January 2013 for an amount of over 2 million dollars. How can the manual implementation of the antivirus be carried out without any cost overrun while the project included a remote deployment? How many public servants were mobilized to upgrade the antiviruses in all of the infrastructures managed by the CSPQ?

7. The DGSAGIR migration to the PPM-RSO5-IGE-REQ-QRG tools of the Centre de services partagés du Québec was to have been completed by 31 May 2015. The project is not completed and the information resources dashboard indicates a green status display and a 0 % variation in the timeline indicator.

Since the organization does not give any explanation for the disparities, can the Minister tell us why the project still has not been completed?

8. The WebSphere Portal and Application Server (WAS) – Volet clicSécur upgrade project was to have been completed by 31 March 2015. It has been postponed until 31 May 2016. The organization explains that the first declaration was based on a preliminary evaluation. The project should have been declared after the tabling of the detailed architecture, which explains the variation in costs and timeline. Significant disparities between the preliminary and detailed evaluation required that action be taken with the client. Following this action, the decision to continue was made.

According to the dashboard, the upgrading of the Internet access infrastructure including the Proxy ISA2004 changed its revised date for the same reason.

The timeline indicator shows a 75.5 % variation and a cost variation of 106.5 %. The project authorized in April 2013 is 40 % completed. Can the Minister give us an idea of the magnitude of the cost overrun? Furthermore, the organization mentions that the first declaration was based on the preliminary evaluation. How many other computer projects are based on the preliminary evaluation?

9. The Commission administrative des régimes de retraite et d'assurances is implementing SGR2 L2 and SGR 3. The project was to have been completed by 31 December 2014, but the revised completion date was changed to 12 December 2015 without any explanation from the organization.

The cost and timeline displays are green and despite the stagnation of the project's progress percentage, no other suspension date is indicated. Can the Minister provide us with a status report on the implementation of the SAGIR RG (SRG2 L2 and SRG3) at the CARRA?

10. The Centre de services partagés du Québec launched a project in June 2014 to optimize the management of physical access sites thanks to the standardization of procedures and methods. The project was to have been completed by 31 March 2015, but it has now been postponed until 30 September 2015. The timeline indicator shows a 50 % variation.

The organization explains that the project date has been postponed because of the 2014-2015 budget cuts. The UPAC report of September 2015 recommends limiting consultants' access to premises and information deemed essential to carry out their mandate.

How can the Minister explain the postponement of an information resources project involving security when the UPAC recommends strengthening this component? 11. The upgrading of EPM 2007 to PPM 2013 is a project enabling the passage to the 2013 version because the 2007 version will no longer be supported by the provider. The project was to have been completed by 28 February 2015 but has been postponed to 31 October 2015 because new requirements in the licence purchasing process for this project have resulted in the obligation to postpone it for a few months to allow the project management team to finalize another project whose deadline could not be postponed.

This project management team is the same one as for another project according to the information resources dashboard. Can the Minister tell us if the team is made up of outside resources and what the new requirements in the licence purchasing process are?

12. The Centre de services partagés du Québec purchased and implemented an integrated desktop virtualization infrastructure. On 13 May 2015, \$533,700 \$ had been spent. Today, the project has been completed at a cost of \$5,019,300 with cost and deadline overruns.

The organization mentions that the work to harmonize the solution with the CSPQ's technological infrastructures exceeded the planned costs. There is therefore no specific explanation. How, within a few months, did the CSPQ spend over 4 million dollars and exceed the authorized costs?

13. The Centre de services partagés du Québec authorized the purchase and implementation of a work orchestration solution in packages on 1 April 2013. As at 13 May 2015, the project was to have been completed two months prior, but it was only 50 % completed. Today, the information resources dashboard indicates a 81.2 % variation in the deadline and a postponement of the project until 31 March 2016.

The organization explains that the postponement stems from inconclusive bid solicitation results. After two years and close to one million dollars spent, what are the changes that were made to the project and why are the bid solicitations inconclusive? 14. The Centre de services partagés du Québec launched an upgrade of the inventory management solution for aeronautical parts (Winair software package) on 20 June 2014. The project was to have ended on 31 May 2015. As at 28 September 2015, the project is still 26 % completed and the information resources dashboard indicates a green status display and a 8.9 % variation in the timeline indicator.

The organization does not provide any explanation to justify the delay in delivering the project. Can the Minister provide us with the missing dashboard explanations?

15. The firewall replacement at the Société québécoise des infrastructures was to be completed by 31 March 2015. As at 13 May 2015, the project was still under preparation. The project is now completed with a cost overrun.

The organization does not provide any explanation and the cost and timeline status indicators are green. Can the Minister provide us with the SQI's missing explanations?

(95) Mr. Bonnardel (Granby) – 20 October 2015 To the Minister of Labour

Pursuant to the *Act respecting collective agreement decrees*, public building maintenance businesses must observe the public building maintenance staff decree whose application is ensured by the Comité paritaire de l'entretien d'édifices publics.

As it turns out, a public building maintenance business must be incorporated in order to be able to bid on government contracts. Therefore, as it is often the case for small businesses, these businesses' shareholders work in operations. According to the Comité paritaire de l'entretien d'édifices publics, they thus become salaried employees and are therefore subject to the decree.

A maintenance business in my riding was fined by the Comité paritaire de l'entretien d'édifices publics because the owners of the business had not, pursuant to section 8 of the decree, received their vacation pay, which is 6 % of their earnings. As they are the only employees of the business, for economic and practical reasons, they chose not to take any vacations.

In addition to being obliged to remit vacation pays to both shareholders, the business was charged claims expenses representing 20 % of the amounts paid.

Is it really in the spirit of the law to apply these rules to owners who work in their own businesses? Is the Minister aware of this situation and does he approve of this?

(96) Mr. Lisée (Rosemont) – 20 October 2015 To the Minister of Employment and Social Solidarity

Phase 2 of the Stratégie nationale pour l'intégration et le maintien en emploi des personnes handicapées was to have been launched in June 2014, but we are still waiting for it. One of the measures provided for in Phase 1 of the strategy was the funding enhancement of the Contrat d'intégration au travail (CIT – action 44) measure, which facilitates hiring and maintaining of a disabled person in a regular work environment and promotes equal access to the labour market for disabled persons.

It should be recalled that the budget of the MESS' program 1, from which this strategy's funding comes, was cut by over \$17 M in 2014-2015 and by \$12.8 M in 2015-2016. In reply to a question asked on 16 September 2014, the Minister was unable to confirm that work integration contracts would be part of the measures included in Phase 2 of the strategy. He was also unable to specify the deadline that he set. We therefore asked him the same question on 26 February 2015. The Minister then told us that the deadline for Phase 2 of the strategy was being reviewed. Eighteen months later, we are still waiting for answers.

What is the Minister's deadline for the launching of Phase 2 of the strategy? Can he confirm that the CIT will be among the measures included in Phase 2 of the strategy and that they will be funded so as to allow more people to benefit from them?

(97) Mr. Lisée (Rosemont) – **20 October 2015**

To the Minister for Rehabilitation, Youth Protection and Public Health

On 16 September 2014, we questioned the Minister about the Public Protector's report on the financial contribution toward placement (published in 2013). More particularly, we asked her to give us the deadline she had set to implement all of these recommendations. In reply to our questions on the progress of work, on 6 October 2014, the Minister recognized that the current regulatory provisions were inequitable with regard to financial contribution toward placement of minor children. She said she intended to review the *Regulation respecting the application of the Act respecting health services and social services* (chapter S-5, r.1), as well as establish a working group to prepare an action plan to follow up on the Public Protector's report.

Does the Minister still intend to review this regulation? If so, what is the deadline? When will the new regulation be in force? How many meetings were held by the working group established by the Minister? We would like a copy of the working group's action plan.

When we again questioned the Minister on 26 February 2015 regarding the state of progress of this work, the Minister indicated on the following 2 April, that:

The implementation of the Public Protector's recommendations might also require amendments to certain laws, particularly to allow access to tax information of parents whose contribution is required. As this is a law that is outside the purview of the MSSS, consultations with other departments may be necessary.

The Public Protector wants to again be informed of the progress of work on 16 October 2015. The MSSS will therefore make certain to forward an updated table of the follow-up work and to schedule another meeting.

Did consultations with other departments actually take place? If so, with which departments? What emerged from these consultations? What is the Government's deadline as regards amendments to other laws? We would like a copy of the follow-up table prepared at the request of the Public Protector and updated.

The Minister also indicated that:

All of the work defining the policy directions and enabling the follow-up to the Public Protector's recommendations will be completed during the summer of 2015. The Government will subsequently propose the necessary legislative and regulatory amendments.

Has this work been completed as scheduled?

When will the necessary legislative and regulatory amendments be introduced to the Members of the National Assembly?

The Regulation is 30 years old. When will the parents concerned finally see the new regulation?

(98) Mr. Lisée (Rosemont) – **20 October 2015**

To the Minister for Rehabilitation, Youth Protection and Public Health

In December 2014, the Minister released a report entitled "Les activités socioprofessionnelles et communautaires : État de la situation et actions convenues pour l'amélioration des services." This report painted a picture of the various services provided to persons with intellectual disabilities, autism spectrum disorders (ASD) or physical disabilities at the end of their schooling, and raised issues of concern as regards their social and professional integration. The report presented the following 14 actions to improve the situation of these young people aged 21 years and over:

1. Establish an interdepartmental committee. This committee is composed of the MSSS, the MELS and the MESS, who will be joined, if necessary, by the MTQ and the MF. It will be coordinated by the MSSS. It's mandate is to support the development and consolidation of a common vision shared by the departments, to ensure the follow-up of work, to agree on how to address the other concerns raised, to discuss problems that could arise within the work context and to see to the evaluation of interventions with a view to developing expertise and adjusting practices if need be.

2. Support the development of a common vision by drafting a document that describes and explains the possible trajectories in accordance with people's life plans to introduce this understanding to the various networks.

3. Disseminate the document on the trajectories in each of the networks.

4. Create a support guide for all network stakeholders to promote a transitional approach from school to active life by adopting a common vision, by relying on leading principles fostering quality transitions, by ensuring the commitment of all stakeholders, by establishing the roles and responsibilities of each person and by supporting the development, as the case may be, of a common tool.

4.1 Disseminate the guide within the various networks.

4.2 Determine the conditions of the follow-up given to the implementation of the transitional approach from school to active life.

5. Take measures to ensure that young people with disabilities whose schooling ends in June 2015 do not end up without a support network, particularly those requiring daily supervision.

5.1 Agree to the information transmission conditions and communicate them to the education networks and to the health and social services network.

5.2 Regionally or locally refer students requiring daily supervision.

6. Specify the policy directions and clarify the roles and responsibilities as regards daytime activities.

6.1 Establish guidelines that will govern service offers concerning daytime activities within the health and social services network.

6.2 Develop a regional framework for the organization of daytime activity services.

6.3 Establish a plan to implement the new organization of services, while avoiding service breakdowns.

6.4 Establish follow-up and accountability mechanisms for the various management levels.

7. Examine the work-family balance needs of families who must deal with the presence of a disabled adult who does not have the necessary autonomy to stay home alone.

8. Within the context of the Intégration sociale à la formation générale des adultes study programme renewal, test and document a partnership commitment approach among the MELS, MESS and MSSS network organizations, to support the achievement of the adult's life plan and social participation.

9. Promote the public education services included in the adult educational services plan among the partner departments.

10. Within the framework of the new Politique nationale du sport, du loisir et de l'activité physique, improve support to organizations providing adapted services to disabled persons and support concerted actions that encourage these persons to adopt and maintain a physically active lifestyle.

11. Develop and implement an MESS-MSSS national reference framework guiding the achievement of local and regional services agreements between both networks' establishments and organizations. This framework will clarify the MESS and the MSSS service offer, specify the roles and responsibilities of the establishments and organizations involved in both networks as regards reception, evaluation, references from one network to another, follow-up, assistance and joint interventions for disabled persons.

12. Support the improvement of transport services, particularly in rural areas, by better coordination of services throughout the region and the establishment of interconnections between adjoining services.

13. Improve access to daytime activities within the health and social services network and ensure follow-up thereof.

14. Continue to improve the connection between the MSSS and MESS services and measures within the framework and following the work that will be carried out.

How advanced is the implementation of each of these recommendations? What is the Minister's deadline to complete the application of each of them? How many meetings of the interdepartmental committee have been held since its establishment?

What amounts were granted in order to implement these recommendations?

(99) Mr. Lisée (Rosemont) – **20 October 2015**

To the Minister for Rehabilitation, Youth Protection and Public Health

We recently questioned the Government about students with special needs who are left without any services at school. A complementary services agreement exists between the Ministère de l'Éducation and the Ministère de la Santé but, in actual fact, it has hardly been applied owing to a lack of resources and because several stakeholders are unaware of its existence.

It is nonetheless necessary and urgent that we truly apply the complementary services agreement between both departments so as to adequately support our children with difficulties, so that they may receive, in a timely manner, the services that their situation requires.
