Motions Without Notice

Mr. Dupuis, Government House Leader, moved:

THAT owing to the urgency of the situation and in order to permit the passage of the following Bills:

- Bill 33, An Act to amend the Act respecting health services and social services and other legislative provisions;
- Bill 52, An Act respecting the implementation of the Québec Energy Strategy and amending various legislative provisions;

- Bill 49, An Act to amend the Forest Act and other legislative provisions and providing for special provisions applicable to the Territory of application of chapter 3 of the Agreement Concerning a New Relationship Between Le Gouvernement du Québec and the Crees of Québec for the Years 2006-2007 and 2007-2008:
- Bill 57, An Act to amend the Act respecting hours and days of admission to commercial establishments;

The following Standing Orders be suspended until the the Assembly has put the question on the passage of the aforementioned Bills:

19 (second paragraph), 20 to 22, 29 (the words "Provided that it may, on a motion made during the time set aside for motions without notice, resolve to meet in secret" in the first paragraph, as well as the second paragraph), 53 (the words "and personal explanations" in the fourth paragraph, as well as the seventh paragraph), 54 (the first, second, third and fifth paragraphs), 61, 69 (the words "speak at any time to a matter of privilege suddenly arising" in the first paragraph, and the words "He may also" in the second paragraph), 70 (the words "either in raising the point of privilege or"), 71 to 73, 84 (second and third paragraphs), 86 (the words "or at the request of some other Member", in the first paragraph, as well as the second paragraph), 87 (second, third and eighth paragraphs), 88 to 95, 96 (the words "Except as otherwise provided in Standing Order 97,"), 97 to 102, 105 to 108, 110 to 114, 146 (the word "either" in the third line, as well as the words "; or on a motion made pursuant to Standing Order 97 by a Member in opposition at a Wednesday meeting" in the sixth and seventh lines), 157, 164 and 165, 174 to 177, 186 (second paragraph), 194 to 210, 212 to 217, 220 to 222, 223 (the words "or for the previous question" in the second paragraph), 227 (the words "or privilege suddenly arising), 228, 230, 244 (the words ", and any amendments proposed thereto shall be relevant to its subject matter and consistent with its nature and purpose" in the first paragraph), 248, 252 to 254, 256 (second and third paragraphs), 257 and 304 to 312;

Immediately the present motion is carried, Motions Without Notice shall be concluded and the subsequent business under Routine Proceedings shall be taken;

Notwithstanding the provisions of Standing Order 53, immediately the Orders of the Day have been entered upon, the Standing Committee on Social Affairs shall conclude its proceedings with respect to the clause-by-clause consideration of Bill 33, An Act to amend the Act respecting health services and social services and other legislative provisions, and table its report in the Assembly through its chairman or one of the Committee members;

Notwithstanding the provisions of Standing Order 53, the Standing Committee on Labour and the Economy shall then conclude its proceedings with respect to the clause-by-clause consideration of Bill 52, An Act respecting the implementation of the Québec Energy Strategy and amending various legislative provisions, Bill 49, An Act to amend the Forest Act and other legislative provisions and providing for special provisions applicable to the Territory of application of chapter 3 of the Agreement Concerning a New Relationship Between Le Gouvernement du Québec and the Crees of Québec for the Years 2006-2007 and 2007-2008, as well as Bill 57, An Act to amend the Act respecting hours and days of admission to commercial establishments, and table its reports in the Assembly through its chairman or one of the Committee members;

The report from a committee shall consist of the minutes of its proceedings and of the text of the bill as it appeared when the committee interrupted its proceedings;

Any Member shall be permitted to hand in to the office of the Secretary General, no later than one hour after the aforementioned committee reports shall have been tabled, a copy of such amendments as he wishes to propose thereto; the proceedings of the Assembly shall be suspended until this time period shall have expired;

Upon resumption of the proceedings, the Assembly shall enter upon the consideration of each of the aforementioned committee reports, and the debate on the consideration of each of these reports and on the amendments submitted in compliance with the present motion, when applicable, shall last not more than 30 minutes, which period shall be allotted as follows: 10 minutes to the parliamentary group forming the Government, 10 minutes to the parliamentary group forming the Official Opposition, 5 minutes to the independent Members and 5 minutes to the Minister presenting the Bill for his reply;

Upon the conclusion of each of the debates on the consideration of the aforementioned reports, the question shall then be put forthwith on the amendments submitted in compliance with the present motion, when applicable, as a whole, in the order indicated by the Chairman, without a reading thereof, and without recorded division; the question shall thereafter be put on the sections of the bill as amended and on the sections of the bill that the Standing Committee and the Assembly have not disposed of in a previous vote, as a whole, in the order indicated by the Chairman, without a reading thereof, and without recorded division; the question shall thereafter be put on the title and other headings as well as on the appendices of the bill as amended, when applicable, as a whole, in the order indicated by the Chairman, without a reading thereof, and without recorded division; and, finally, the question shall then be put on the committee report, amended or not, without recorded division;

THAT, subsequently, the debate on the passage of each of the aforementioned bills shall last not more than 30 minutes, which period shall be allotted as follows: 10 minutes to the parliamentary group forming the Government, 10 minutes to the parliamentary group forming the Official Opposition, 5 minutes to the independent Members and 5 minutes to the Minister presenting the bill for his reply; voting on the passage of the bill shall be by a show of hands unless five Members demand a recorded division:

A Minister or a Deputy Government House Leader may move at any time during the debate on the passage of a bill that the bill be referred to a Committee of the Whole for the consideration of amendments that he indicates; the question on such motion, which requires no notice and may be neither amended nor debated, shall be put forthwith, and a recorded division may not be demanded thereon, and, when applicable, the Assembly shall automatically resolve itself into a Committee of the Whole; the debate in Committee of the Whole shall be limited to the consideration of the proposed amendments; the debate in Committee of the Whole shall last not more than 15 minutes, which period shall be allotted as follows: 5 minutes to the parliamentary group forming the Government, 5 minutes to the parliamentary group forming the Official Opposition, 3 minutes to the independent Members and 2 minutes to the

Minister presenting the bill for his reply, at the end of which period the question shall be put forthwith on the amendments together, without being read by the Chairman and without a standing vote, as well as on the amendments the Minister introducing the bill may not have been able to move during consideration; after which the Chairman of the Committee of the Whole shall report to the Assembly, without consulting the Committee nor the Assembly; the question on such report shall be put forthwith without debate and without recorded division;

A Minister may table documents at any time during the Orders of the Day;

Except as otherwise provided in this motion, all voting in the Assembly and in Committee of the Whole shall be by a show of hands, unless a Minister or a Deputy Government House Leader demands a recorded division or a standing vote;

A Minister or a Deputy Government House Leader shall be permitted to move the withdrawal of a motion at any time during the sitting; the question on such motion, which requires no notice and may be neither amended nor debated, shall be put forthwith, and a recorded division may not be demanded thereon;

A Minister or a Deputy Government House Leader shall be permitted to move the revocation of an order or a resolution of the Assembly at any time during the sitting; the question on such motion, which requires no notice and may be neither amended nor debated, shall be put forthwith, and a recorded division may not be demanded thereon;

A Minister or a Deputy Government House Leader shall be permitted to suspend the proceedings at any time during the sitting; the question on such motion, which requires no notice and may be neither amended nor debated, shall be put forthwith, and a recorded division may not be demanded thereon;

A Minister or a Deputy Government House Leader may move the adjournment of the debate at any time during the sitting; the question on such motion, which requires no notice and may be neither amended nor debated, shall be put forthwith, and a recorded division may not be demanded thereon; A Minister or a Deputy Government House Leader may move the adjournment of the Assembly at any time during the sitting; the question on such motion, which requires no notice and may be neither amended nor debated, shall be put forthwith, and a recorded division may not be demanded thereon;

The Assembly may sit every day, beginning at 10.00 o'clock a.m., until it decides to adjourn its proceedings;

Subject to the foregoing, the provisions of the Standing Orders relating to extended hours of meeting shall apply;

The rules hereinbefore specified shall remain in force until the Assembly has put the question on the passage of Bill 33, An Act to amend the Act respecting health services and social services and other legislative provisions, Bill 52, An Act respecting the implementation of the Québec Energy Strategy and amending various legislative provisions, Bill 49, An Act to amend the Forest Act and other legislative provisions and providing for special provisions applicable to the Territory of application of chapter 3 of the Agreement Concerning a New Relationship Between Le Gouvernement du Québec and the Crees of Québec for the Years 2006-2007 and 2007-2008, and Bill 57, An Act to amend the Act respecting hours and days of admission to commercial establishments.

Mrs. Lemieux, Official Opposition House Leader, raised a point of order claiming that consent was required to move such a motion. Mr. President took the matter under advisement and, at 11.17 o'clock a.m., suspended the proceedings for a few minutes.

At 12.06 o'clock p.m., Mr. President rendered the following decision:

RULING FROM THE CHAIR

During the Routine Proceedings when motions without notice are entered upon, consent is required only when the motion necessitates notice. The motion to suspend certain rules of procedure moved by the Government House Leader does not require consent for a debate to be held thereon, since notice is not required when the reason claimed is the urgency of the situation.

At 12.37 o'clock p.m., Mr. President suspended the proceedings until

The proceedings resumed at 3.05 o'clock p.m.

3.00 o'clock p.m. to allow the Members to examine the motion.

Mrs. Lemieux, Official Opposition House Leader, questioned the receivability of the motion to suspend certain rules of procedure.

Mr. Bédard, Deputy Opposition House Leader, in turn raised grounds against the receivability of the motion.

Mr. Dupuis, Government House Leader, raised his grounds for the receivability of the motion.

At 3.30 o'clock p.m., Mr. President took the matter under advisement and suspended the proceedings.
The proceedings resumed at 5.33 o'clock p.m.
Mr. President rendered the following ruling:
RULING FROM THE CHAIR
The motion to suspend certain rules of procedure is receivable. In a motion to suspend the rules, it is not necessarily required to suspend Standing Orders when introducing new rules. However, when new rules are introduced, they absolutely must not come into conflict with those that already exist. The fact that the motion to suspend certain rules of procedure provides for the time when the committee shall interrupt its proceedings does not come into conflict with the closure motion provided for in Standing Orders 249 to 251, as the latter motion is not an imperative procedure, but a possibility for the Government House Leader, in like manner as the motion to suspend certain rules of procedure. They both are simply alternative methods.
Mr. President heard additional arguments from Mrs. Lemieux, Official Opposition House Leader, and Mr. Bédard, Deputy Opposition House Leader, on the receivability of the motion to suspend certain rules of procedure moved by Mr. Dupuis, Government House Leader.
At 6.00 o'clock p.m., Mr. President suspended the proceedings until 8.00 o'clock p.m.

The proceedings resumed at 8.05 o'clock p.m.

Mr. President rendered the following ruling:

RULING FROM THE CHAIR

The closure motion is not the only manner in which committee proceedings may be concluded. It is simply a procedure to be used at the discretion of the Government House Leader, the motion to suspend certain rules of procedure now being the method of choice.

Jurisprudence has acknowledged the possibility of providing for the suspension of Standing Orders 249 to 251 in a motion to suspend certain rules of procedure and for their replacement by another procedure to conclude the consideration of a bill in committee. However, nothing in jurisprudence indicates that these Standing Orders must absolutely be suspended in order to provide for a special procedure for the purpose of concluding the consideration of a bill.

At 8.10 o'clock p.m., Mr. President suspended the proceedings to organize the limited debate on the motion to suspend certain rules of procedure.

At 8.13 o'clock p.m., following a meeting with the House leaders, Mr. Cusano, First Vice-President, announced the allocation of speaking time for the proceedings with respect to the limited debate on the motion to suspend certain rules of procedure moved by Mr. Dupuis, Government House Leader: 10 minutes shall be set aside for the independent Members; the two parliamentary groups shall share equally the rest of the time allotted for this debate; within this framework, any time not used by a parliamentary group will be added to that of the other group, while any time not used by the independent Members may be redistributed equally among the two parliamentary groups, it having been agreed that this apportionment may not be carried out before the time allotted to both parliamentary groups has entirely expired; and individual addresses shall not be limited.
