The Assembly was called to order at 10.02 o'clock a.m.

#### **ORDERS OF THE DAY**

#### **Business Standing in the Name of Members in Opposition**

Mr. Bouchard (Vachon) moved:

THAT the National Assembly demand that the Liberal Government desist from imposing undue school tax increases on Québec taxpayers.

Following a meeting with the House leaders, Mrs. Leblanc, Second Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this motion: ten minutes shall be allotted for a reply by its mover and ten minutes shall be set aside for the independent Members; the two parliamentary groups shall share equally the rest of the time allotted for this debate; within this framework, any time not used by a parliamentary group will be added to that of the other group, while any time not used by the independent Members may be redistributed equally amongst the parliamentary groups, it having been agreed that this apportionment may not be carried out before the time allotted to both parliamentary groups has entirely expired; and individual addresses shall not be limited.

And debate arising on the motion moved by Mr. Bouchard (Vachon);

At the request of Mrs. Leblanc, Second Vice-President, Mr. Fournier, Minister of Education, Recreation and Sports, withdrew certain words deemed unparliamentary.

At the end of his speech, Mr. Fournier, Minister of Education, Recreation and Sports, moved:

THAT the motion under discussion be amended as follows: By replacing, in the first line, the word "demand" by the word "ask" and by adding, in the third line, after the word "taxpayers", the words "and that, to this end, it enable school boards to implement a mechanism to apportion the tax increase, such as is proposed in Bill 43 and such as was requested by the former Member for Taillon on 19 May 2005".

The motion, as amended, would read as follows:

THAT the National Assembly ask that the Liberal Government desist from imposing undue school tax increases on Québec taxpayers and that, to this end, it enable school boards to implement a mechanism to apportion the tax increase, such as is proposed in Bill 43 and such as was requested by the former Member for Taillon on 19 May 2005.

After comments from both sides on the receivability of the motion to amend, the debate continued on the main motion by Mr. Bouchard (Vachon) and on the motion to amend it by Mr. Fournier, Minister of Education, Recreation and Sports, subject to the receivability of the latter, which Mrs. Leblanc, Second Vice-President, took under advisement.

Mrs. Leblanc, Second Vice-President, rendered her decision on the receivability of the motion to amend moved by Mr. Fournier, Minister of Education, Recreation and Sports:

# RULING FROM THE CHAIR

The motion to amend is unreceivable. The principle of the main motion is that the Liberal Government desist from imposing undue school tax increases, whereas the amendment proposes to spread the tax increase over a period of time, which is contrary to the principle.

The debate being concluded, the question was put on this motion; a recorded division was thereupon demanded.

At the request of Mrs. Lamquin-Éthier, Deputy Government House Leader, the division was deferred until Routine Proceedings on the present sitting day.

At 12.00 o'clock p.m., Mrs. Leblanc, Second Vice-President, suspended the proceedings until 2.00 o'clock p.m.

The proceedings resumed at 2.07 o'clock p.m.

#### **Motions Without Notice**

Mr. President handed down the following directive regarding motions without notice:

# DIRECTIVE FROM THE CHAIR

When a Member moves a motion under the heading "Motions without Notice," the Chair must inquire whether all Members present in the Assembly consent unanimously to its being debated. If even a single Member signifies that he does not consent to the holding of the debate, it may not be held.

When the Chair asks whether there is consent to debate a motion, certain distinctions must be made according to the situation. First, Members may consent to the debate, purely and simply. The motion is then debated pursuant to the relevant provisions of the Standing Orders. Second, Members may give their consent under certain conditions. The President must then inquire whether all Members agree to such conditions. If they do, the debate takes place in accordance with these conditions; if they do not, the debate cannot be held. Finally, the House leaders may agree among themselves on the conditions surrounding the holding of a debate without the Assembly's having been informed of their agreement. In such a context the Chair cannot impose these conditions on the other Members; the proposed conditions must be known to all Members present, each of whom must have consented thereto in order to bind the Assembly.

Furthermore, it is important to remember that it is the Members, not the parliamentary groups, who give their consent. Thus, a Member belonging to the same parliamentary group as the mover of a motion may consent or not to a debate on that motion and, if he so wishes, attach conditions to his consent.

Mr. Després, Minister of Transport, moved a motion concerning the completion of Highway 25; this motion could not be debated for want of unanimous consent.

Mrs. L'Écuyer (Pontiac) moved:

THAT the National Assembly mark Adoption Awareness Month.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

Mrs. Harel (Hochelaga-Maisonneuve) moved:

THAT the National Assembly mark Hemophilia Month.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.
