Motions Without Notice

— the Committee on Institutions, to continue its clause-by-clause consideration of Bill 59, An Act to enact the Act to prevent and combat hate speech and speech inciting violence and to amend various legislative provisions to better protect individuals.

- the Committee on Transportation and the Environment shall hold a deliberative meeting to discuss the possibility of examining petitions.

Information on the Proceedings of the Assembly

Mrs. Gaudreault, Second Vice-President, informed the Assembly that on Wednesday, 17 February 2016, during Business Standing in the Name of Members in Opposition, a debate would be held on the motion moved by Mrs. Soucy (Saint-Hyacinthe).

This motion reads as follows:

THAT the National Assembly acknowledge the adverse effects of deciding to terminate the Québec Government's contractual commitments with respect to oil and gas exploration on Anticosti Island;

THAT it recognize that such a breach of contract on the Québec Government's part could entail significant contractual penalties and legal action representing millions of dollars;

THAT it demand that the Government honour its contractual obligations by allowing the exploration projects aimed at assessing Anticosti Island's oil and gas potential to be completed.

At 3.14 o'clock p.m., at the request of Mr. Sklavounos, Deputy Government House Leader, Mrs. Gaudreault, Second Vice-President, suspended the proceedings until the expiry of the time limit for receiving notices for debates upon adjournment.

The proceedings resumed at 3.27 o'clock p.m.

At 3.28 o'clock p.m., at the request of Mr. Sklavounos, Deputy Government House Leader, Mrs. Gaudreault, Second Vice-President, suspended the proceedings until 6.00 o'clock p.m.

Debates upon Adjournment

At 5.58 o'clock p.m., the Assembly held two debates upon adjournment:

- the first, on a question from Mrs. Lamarre (Taillon) to Mr. Barrette, Minister of Health and Social Services, on his statement about whether or not couples should have children depending on their income;
- the second, on a question from Mr. Villeneuve (Berthier) to Mr. Paradis, Minister of Agriculture, Fisheries and Food, about the Fédération des producteurs acéricoles du Québec's demands to increase production quotas.

Mr. Sklavounos, Deputy Government House Leader, moved the adjournment of the Assembly until Wednesday, 17 February 2016 at 9.40 o'clock a.m.

The motion was carried.
