Oral Questions and Answers

The Assembly proceeded to Oral Question Period.

Deferred Divisions

The Assembly took the division, which had been deferred at the sitting of 16 March 2016, on the motion moved by Mrs. Roy (Montarville) during Business Standing in the Name of Members in Opposition.

This motion reads as follows:

THAT the National Assembly acknowledge that Québec benefits socially and economically from immigration when its volume reflects our reception and integration capacity;

THAT it note that many municipal, community and economic sector stakeholders are concerned by our present inability to receive, integrate and francize all of the immigrants admitted to Québec;

THAT it ask the Government to take the current context into account and not raise immigration thresholds.

The motion was negatived on the following vote:

Motions Without Notice

Mr. Jolin-Barrette (Borduas), together with Mrs. Hivon (Joliette), Mrs. David (Gouin) and Mrs. Roy (Arthabaska), moved a motion concerning Bill 596, An Act to amend the Civil Code to make judicial remedies for victims of sexual aggression imprescriptible; this motion could not be debated for want of unanimous consent.

Mr. Turcotte (Saint-Jean), together with Mrs. David (Gouin), moved a motion concerning the Federal Government's employment insurance system; this motion could not be debated for want of unanimous consent.

Mrs. David (Gouin), together with Mr. Bérubé (Matane-Matapédia) and Mr. Caire (La Peltrie), moved a motion concerning the Unité permanente anticorruption and the recommendations of the report of the Commission of Inquiry on the Awarding and Management of Public Contracts in the Construction Industry; this motion could not be debated for want of unanimous consent.

Notices of Proceedings in Committees

Mr. Sklavounos, Deputy Government House Leader, convened the following committees:

- the Committee on Citizen Relations, to continue its clause-by-clause consideration of Bill 77, Québec Immigration Act;
- the Committee on Labour and the Economy, to continue its clause-byclause consideration of Bill 70, An Act to allow a better match between training and jobs and to facilitate labour market entry;
- the Committee on Planning and the Public Domain, to undertake clauseby-clause consideration of Bill 83, An Act to amend various municipalrelated legislative provisions concerning such matters as political financing;
- the Committee on Transportation and the Environment, to continue its clause-by-clause consideration of Bill 76, An Act to modify the organization and governance of shared transportation in the Montréal metropolitan area.

And by leave of the Assembly to set aside Standing Order 143, he convened the following committee:

— the Committee on Culture and Education, to continue its public hearings within the framework of special consultations on Bill 86, An Act to modify the organization and governance of school boards to give schools a greater say in decision-making and ensure parents' presence within each school board's decision-making body.

Mr. Ouimet, First Vice-President, gave the following notices:

- the Committee on Health and Social Services shall hold a deliberative meeting to discuss the possibility of examining a petition;
- the Committee on Institutions shall hold a deliberative meeting to organize the next steps of its mandate to examine the report on the implementation of the *Code of ethics and conduct of the Members of the National Assembly*.

Government Motions

Mrs. Vallée, Minister of Justice, moved:

THAT the National Assembly:

Concur in the recommendations and justifications included in the report of the Comité de la rémunération des procureurs aux poursuites criminelles et pénales for the period 2015–2019, tabled in the National Assembly on 6 October 2015 by the Minister of Justice, noting, however, that recommendation No. 1 will be amended as follows, for the reason specified in the letter from the Committee Chair tabled in the National Assembly on 15 March 2016:

THAT the salary rates and scales as at 31 March 2015 be increased in the order of 10%, without any additional cost-ofliving-related indexation, and spread out over the four years in question, as shown below:

- 2.5% on 1 April 2015 (which is added to the 1% adjustment paid on 31 March 2015);
- 2.5% on 1 April 2016 (of the salary scales as at 31 March 2016);
- 2.5% on 1 April 2017 (of the salary scales as at 31 March 2017);
- 2.25% on 1 April 2018 (of the salary scales as at 31 March 2018).

At the beginning of her address, Mrs. Vallée, Minister of Justice, moved:

THAT the motion be amended as follows:

THAT "2.25%" in the last line be replaced by "2.5%".

The motion, as amended, would read as follows:

THAT the National Assembly:

Concur in the recommendations and justifications included in the report of the Comité de la rémunération des procureurs aux poursuites criminelles et pénales for the period 2015–2019, tabled in the National Assembly on 6 October 2015 by the Minister of Justice, noting, however, that recommendation No. 1 will be amended as follows, for the reason specified in the letter from the Committee Chair tabled in the National Assembly on 15 March 2016:

THAT the salary rates and scales as at 31 March 2015 be increased in the order of 10%, without any additional cost-ofliving-related indexation, and spread out over the four years in question, as shown below:

- 2.5% on 1 April 2015 (which is added to the 1% adjustment paid on 31 March 2015);
- 2.5% on 1 April 2016 (of the salary scales as at 31 March 2016);
- 2.5% on 1 April 2017 (of the salary scales as at 31 March 2017);
- 2.5% on 1 April 2018 (of the salary scales as at 31 March 2018).

The amendment motion was declared receivable.

By leave of the Assembly to set aside Standing Order 199, the debate continued on the main motion and on the amendment motion moved by Mrs. Vallée, Minister of Justice.

The debate being concluded, the amendment motion was carried.

The motion, as amended, was carried.
