Mr. Bérubé (Matane-Matapédia), together with Mr. Spénard (Beauce-Nord) and Mr. Khadir (Mercier), moved a motion concerning the appointment of the Anti-Corruption Commissioner; this motion could not be debated for want of unanimous consent.

Mr. Paradis (Lévis), together with Mr. Lisée (Rosemont) and Mrs. Massé (Sainte-Marie–Saint-Jacques), moved a motion concerning Pavillon Sainte-Marie de Saint-Jérôme; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mr. Coiteux, Minister of Public Security, together with Mrs. Maltais (Taschereau), Mr. Bérubé (Matane-Matapédia), Mr. Spénard (Beauce-Nord) and Mrs. David (Gouin), moved:

THAT the National Assembly of Québec honour Mr. Cyrille Delâge, Coroner and Fire Investigation Commissioner for Québec City;

THAT it recognize the dedication and commitment of this ardent protector of human life renowned for contributing to fire safety development in Québec, who helped ensure that Quebecers are better protected;

THAT it highlight his near-fifty-year public protection career, during which the findings contained in his reports enabled firefighters to improve their response techniques, thereby helping reduce the risks inherent in their profession;

THAT it recall the Prix Hommage he was awarded on 16 February 2016, during the 20^e Mérite québécois de la sécurité civile et incendie ceremony, for his remarkable career as both Fire Investigation Commissioner and Coroner;

THAT it convey its condolences to Mr. Delâge's family and friends.

By leave of the Assembly, the motion was carried.

At the request of Mr. Ouimet, First Vice-President, the Assembly observed a minute of silence.

By leave of the Assembly to set aside Standing Order 185, Mrs. David (Gouin), together with Mrs. Charlebois, Minister for Rehabilitation, Youth Protection, Public Health and Healthy Lifestyles, Mr. Lisée (Rosemont) and Mr. Paradis (Lévis), moved:

THAT the National Assembly mark Québec Social Workers' Week, held from 20 to 26 March;

THAT it acknowledge the essential work done by more than 13,000 social workers, who provide services to all clienteles—children, families, people struggling with a wide range of problems—throughout Québec;

THAT it recognize that these men and women work skilfully and passionately under difficult conditions to improve people's living conditions and to fight social inequality;

THAT it recall that bad luck can strike any one of us and that, when it comes down to it, we are all vulnerable.

Business Having Precedence

Debate on the Budget Speech

The Assembly entered upon the debate on the motion moved by Mr. Leitão, Minister of Finance, that the Assembly approve the Government's budgetary policy.

At the end of his address, Mr. Marceau (Rousseau) moved the following motion stating a grievance:

THAT the National Assembly severely censure the Liberal Government for its lack of an economic policy, which has resulted in stagnating private-sector investments, an unrelenting burden on families and the Government's reneging on its promise to create 250,000 jobs.

The debate continued on the motion moved by Mr. Leitão, Minister of Finance, and on the motion stating a grievance moved by Mr. Marceau (Rousseau), subject to the receivability of this motion.

At the end of his address, Mr. Bonnardel (Granby) moved the following motion stating a grievance:

THAT the National Assembly severely censure the Liberal Government for having increased every Québec citizen's tax burden by an average of \$750 since the beginning of its term in office.

Following a meeting with the House leaders, Mr. Ouimet, First Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this debate: 6 hours 26 minutes to the parliamentary group forming the Government, including the Budget Speech; 3 hours 48 minutes to the parliamentary group forming the Official Opposition, including the comments made by its representative on 17 March 2016 and his address during today's proceedings; 2 hours 37 minutes to the Second Opposition Group, including the comments made by its representative on 17 March 2016 and his address during today's proceedings; 30 minutes to the independent Members belonging to Québec solidaire, and 7 minutes 30 seconds to the independent Member for Arthabaska. Within this framework, any time not used by the independent Members belonging to Québec solidaire or by the Member for Arthabaska shall be redistributed among the parliamentary groups in the proportions established above and any time not used by a parliamentary group shall be redistributed among the parliamentary group shall be redistributed and the same proportions. Lastly, individual addresses shall not be limited.

The debate continued on the motion moved by Mr. Leitão, Minister of Finance, and on the motions stating a grievance moved by Mr. Marceau (Rousseau) and Mr. Bonnardel (Granby), subject to the receivability of these motions.

At 1.00 o'clock p.m., Mr. Ouimet, First Vice-President, suspended the proceedings until 3.00 o'clock p.m.

The proceedings resumed at 3.03 o'clock p.m.

Debate on the Budget Speech

The Assembly continued the debate on the motion moved by Mr. Leitão, Minister of Finance, that the Assembly approve the Government's budgetary policy, and on the motions stating a grievance moved by Mr. Marceau (Rousseau) and Mr. Bonnardel (Granby), subject to the receivability of these motions.

At the end of his address, Mr. Khadir (Mercier) moved the following motion stating a grievance:

THAT the National Assembly of Québec severely censure the Liberal Government for its 2016–2017 budget and its \$2 billion surplus paid in full into the Generations Fund, which keep Québec in a permanent state of austerity and prevent adequate funding of public services, in particular those of the health and social services network.

The debate continued on the motion moved by Mr. Leitão, Minister of Finance, and on the motions stating a grievance moved by Mr. Marceau (Rousseau), Mr. Bonnardel (Granby) and Mr. Khadir (Mercier), subject to the receivability of these motions.

At the end of his address, Mr. Therrien (Sanguinet) moved the following motion stating a grievance:

THAT the National Assembly severely censure the Liberal Government for its austerity policy, which jeopardizes Québec's economic growth.

The debate continued on the motion moved by Mr. Leitão, Minister of Finance, and on the motions stating a grievance moved by Mr. Marceau (Rousseau), Mr. Bonnardel (Granby), Mr. Khadir (Mercier) and Mr. Therrien (Sanguinet), subject to the receivability of these motions.

By leave of the Assembly to set aside Standing Orders 53 and 59, Mr. Caire (La Peltrie) tabled the following:

A copy of a document on a plan for a modern, efficient state entitled "Un pacte de responsabilité – Plan pour un état moderne et efficace, automne 2015". (Sessional Paper No. 2059-20160323)

At the end of his address, Mr. Caire (La Peltrie) moved the following motion stating a grievance:

THAT the National Assembly severely censure the Liberal Government for lacking a credible plan to bridge the remaining \$890 million gap in 2017–2018 program spending.

The debate continued on the motion moved by Mr. Leitão, Minister of Finance, and on the motions stating a grievance moved by Mr. Marceau (Rousseau), Mr. Bonnardel (Granby), Mr. Khadir (Mercier), Mr. Therrien (Sanguinet) and Mr. Caire (La Peltrie), subject to the receivability of these motions.

At the end of his address, Mr. Lelièvre (Gaspé) moved the following motion stating a grievance:

THAT the National Assembly severely censure the Liberal Government for the lack of concrete measures meeting the regions' needs, especially those of the resource regions, in its 2016–2017 budget.

The debate continued on the motion moved by Mr. Leitão, Minister of Finance, and on the motions stating a grievance moved by Mr. Marceau (Rousseau), Mr. Bonnardel (Granby), Mr. Khadir (Mercier), Mr. Therrien (Sanguinet), Mr. Caire (La Peltrie) and Mr. Lelièvre (Gaspé), subject to the receivability of these motions. At the end of his address, Mr. Lisée (Rosemont) moved the following motion stating a grievance:

THAT the National Assembly severely censure the Liberal Government for having tabled a budget inspired by the practices of Stephen Harper's Conservative Government, which Quebecers rejected massively in the last federal general election.

The debate continued on the motion moved by Mr. Leitão, Minister of Finance, and on the motions stating a grievance moved by Mr. Marceau (Rousseau), Mr. Bonnardel (Granby), Mr. Khadir (Mercier), Mr. Therrien (Sanguinet), Mr. Caire (La Peltrie), Mr. Lelièvre (Gaspé) and Mr. Lisée (Rosemont), subject to the receivability of these motions.

The debate was adjourned in the name of Mr. Kelley, Minister responsible for Native Affairs.

At 6.00 o'clock p.m., Mr. Gendron, Third Vice-President, adjourned the Assembly until Thursday, 24 March 2016 at 9.40 o'clock a.m.
