Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mr. Couillard, Premier, together with Mrs. Thériault, Minister responsible for the Status of Women, Mr. Péladeau, Leader of the Official Opposition, Mr. Legault, Leader of the Second Opposition Group, and Mrs. David (Gouin), moved:

> THAT the National Assembly pay tribute to Mrs. Marie-Claire Kirkland-Casgrain, first female Member of the National Assembly of Québec, first woman Minister within the Québec Government and first woman appointed Provincial Court judge;

> THAT it highlight her invaluable contribution to advancing Québec society, particularly in terms of gender equality, one of its fundamental values;

> THAT, lastly, the Members of the Assembly observe a minute of silence in her memory.

Information on the Proceedings of the Assembly

Mr. Ouimet, First Vice-President, informed the Assembly that on Wednesday, 6 April 2016, during Business Standing in the Name of Members in Opposition, a debate would be held on the motion by Mr. Drainville (Marie-Victorin).

This motion reads as follows:

THAT the National Assembly mandate the Auditor General of Québec to analyze the awarding of an \$11.2 million loan and \$8.5 million subsidy to the company Premier Tech, by Investissement Québec and the Ministère du Développement économique respectively, announced by Premier Jean Charest on 7 May 2012;

THAT the Auditor General do everything in her power to report to the Assembly by 1 June 2016.

Debate on the Budget Speech

The Assembly resumed the debate, which had been adjourned on 24 March 2016, on the motion moved by Mr. Leitão, Minister of Finance, that the Assembly approve the Government's budgetary policy, and on the motions stating a grievance moved by Mr. Marceau (Rousseau), Mr. Bonnardel (Granby), Mr. Khadir (Mercier), Mr. Therrien (Sanguinet), Mr. Caire (La Peltrie), Mr. Lelièvre (Gaspé), Mr. Lisée (Rosemont), Mr. Bergeron (Verchères), Mrs. Poirier (Hochelaga-Maisonneuve), Mrs. Massé (Sainte-Marie–Saint-Jacques), Mrs. Hivon (Joliette) and Mr. Villeneuve (Berthier), subject to the receivability of these motions.

At the end of her address, Mrs. David (Gouin) moved the following motion stating a grievance:

THAT the National Assembly of Québec severely censure the Liberal Government for its 2016–2017 budget and its Plan for Success in Education and Higher Education, which does not counterbalance the public education system's chronic underfunding caused by budgetary cutbacks made by this government and previous governments.

Debate on the Budget Speech

The Assembly continued the debate on the motion moved by Mr. Leitão, Minister of Finance, that the Assembly approve the Government's budgetary policy, and on the motions stating a grievance moved by Mr. Marceau (Rousseau), Mr. Bonnardel (Granby), Mr. Khadir (Mercier), Mr. Therrien (Sanguinet), Mr. Caire (La Peltrie), Mr. Lelièvre (Gaspé), Mr. Lisée (Rosemont), Mr. Bergeron (Verchères), Mrs. Poirier (Hochelaga-Maisonneuve), Mrs. Massé (Sainte-Marie–Saint-Jacques), Mrs. Hivon (Joliette), Mr. Villeneuve (Berthier), Mrs. David (Gouin), Mr. Kotto (Bourget), Mr. Ouellet (René-Lévesque) and Mr. Rochon (Richelieu), subject to the receivability of these motions.

Given that 13 hours and 30 minutes had elapsed since Mr. Leitão, Minister of Finance, began the Budget Speech, the debate thereon was suspended in the Assembly to be resumed by the Committee on Public Finance, in accordance with the provisions of Standing Order 275.

Government Bills

Passage

Mrs. Vallée, Minister of Justice, moved the passage of Bill 89, An Act to ensure better consistency between the French and English texts of the Civil Code.

After debate thereon, the motion was carried and, accordingly, Bill 89 was passed.

Report Stage

The Assembly took into consideration the report from the Committee on Citizen Relations on its clause-by-clause consideration of Bill 77, Québec Immigration Act, together with the amendments transmitted by Mrs. Weil, Minister of Immigration, Diversity and Inclusiveness.

The amendments were declared in order.

After debate thereon, the amendments were carried.

The report, as amended, was concurred in.

Debates on Reports from Committees

The Assembly took into consideration the report from the Committee on Agriculture, Fisheries, Energy and Natural Resources, which met on 16 and 17 March 2015, to hold public hearings within the framework of special consultations on the farmland grabbing phenomenon. The report contains observations, conclusions and 5 recommendations.

Mr. Gendron, Third Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this debate: 56 minutes 30 seconds to the parliamentary group forming the Government; 33 minutes 30 seconds to the parliamentary group forming the Official Opposition; 23 minutes to the parliamentary group forming the Second Opposition Group; and 7 minutes to the independent Members, subject to a maximum of 2 minutes to the Member for Arthabaska. Within this framework, any time not used by the independent Members or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

The debate was adjourned in the name of Mr. Morin (Côte-du-Sud).

At 9.30 o'clock p.m., the President adjourned the Assembly until Wednesday, 6 April 2016 at 9.40 o'clock a.m.
