ORDERS OF THE DAY

Government Bills

Passage

Mrs. Weil, Minister of Immigration, Diversity and Inclusiveness, moved the passage of Bill 82, An Act to proclaim Memorial Day for Crimes Against Humanity Committed in Cambodia Between 1975 and 1979.

After debate thereon, the motion was carried and, accordingly, Bill 82 was passed.

Passage in Principle

The Assembly resumed the debate, which had been adjourned on 1 June 2016, on the hoist motion moved by Mr. Spénard (Beauce-Nord) within the framework of the debate on the passage in principle of Bill 100, An Act to amend various legislative provisions respecting mainly transportation services by taxi, moved by Mr. Daoust, Minister of Transport, Sustainable Mobility and Transport Electrification.

At 12.59 o'clock p.m., Mr. Gendron, Third Vice-President, suspended the proceedings until 3.00 o'clock p.m.

The proceedings resumed at 3.01 o'clock p.m.

The Assembly continued the debate on the motion moved by Mr. Daoust, Minister of Transport, Sustainable Mobility and Transport Electrification, that Bill 100, An Act to amend various legislative provisions respecting mainly transportation services by taxi, do now pass in principle.

At the end of his address, Mr. Roberge (Chambly) moved the following motion to divide said Bill:

THAT, pursuant to Standing Order 241, Bill 100, An Act to amend various legislative provisions respecting mainly transportation services by taxi, be divided into two bills, the first of which shall be entitled "An Act to amend various legislative provisions respecting transportation services by taxi" and shall comprise sections 1 to 41 and 45 to 57; the second of which shall be entitled "An Act to improve highway safety mainly for cyclists" and shall comprise sections 42 to 44, and section 57, except the words "except section 13, paragraph 1 of section 14, section 17 to the extent that it concerns section 59.3 of the Act respecting transportation services by taxi, and section 36 to the extent that it concerns paragraph 2 of section 112.1 of that Act, which come into force on the date or dates to be set by the Government".

At 4.18 o'clock p.m., Mr. Ouimet, First Vice-President, suspended the proceedings until 4.30 o'clock p.m.

The proceedings resumed at 4.32 o'clock p.m.

At 4.38 o'clock p.m., after hearing arguments from all sides regarding the receivability of this motion, Mr. Gendron, Third Vice-President, took the matter under advisement and suspended the proceedings.

The proceedings resumed at 5.37 o'clock p.m.

Mr. Gendron, Third Vice-President, made his ruling on the receivability of the motion to divide moved by Mr. Roberge (Chambly).

RULING FROM THE CHAIR

The bill contains more than one principle, comprising both various provisions related to transportation services by taxi in Québec and other measures to ensure cyclists' safety.

Once the Chair has ascertained the existence of more than one principle, receivability is analyzed, taking the following criteria into consideration: each bill resulting from the division must be coherent and able to stand alone.

In the case at hand, the purpose of the motion to divide is to separate distinct principles into two bills. The motion to divide coherently separates the initial bill's various elements into two bills, each of which is able to stand alone without cross-referencing the other.

Consequently, the motion meets the receivability criteria inherent in a motion to divide and is declared receivable.

Mr. Gendron, Third Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to the limited debate on this motion to divide: 56 minutes 30 seconds to the parliamentary group forming the Government; 33 minutes 26 seconds to the parliamentary group forming the Official Opposition; 23 minutes 4 seconds to the parliamentary group forming the Second Opposition Group; and 7 minutes to the independent Members, subject to a maximum of 2 minutes to the Member for Arthabaska. Any time not used by the independent Members or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

The Assembly entered upon the debate on the motion to divide moved by Mr. Roberge (Chambly).

At 6.00 o'clock p.m., Mr. Gendron, Third Vice-President, suspended the proceedings until 7.30 o'clock p.m.

The proceedings resumed at 7.30 o'clock p.m.

The Assembly continued the debate on the motion to divide moved by Mr. Roberge (Chambly) within the framework of the debate on the passage in principle of Bill 100, An Act to amend various legislative provisions respecting mainly transportation services by taxi, moved by Mr. Daoust, Minister of Transport, Sustainable Mobility and Transport Electrification.

The debate being concluded, the question was put on this motion to divide, and a recorded division was thereupon demanded.

The motion was negatived on the following vote:
