Mr. Charest, Premier, moved:

Government Bills

Report Stage

The Assembly took into consideration the report from the Committee on Public Finance on its clause-by-clause consideration of Bill 120, An Act to abolish certain public bodies and transfer administrative responsibilities.

After debate thereon, the report was concurred in.

Passage

Mr. Corbeil, Minister of Natural Resources and Wildlife, moved the passage of Bill 121, An Act to amend the Mining Act.

After debate thereon, the motion was carried and, accordingly, Bill 121 was passed.

Passage

Mr. Kelley, Minister for Native Affairs, moved the passage of Bill 123, An Act respecting tax-exempt status for certain payments made in accordance with the Partnership Agreement on Economic and Community Development in Nunavik.

After debate thereon, the motion was carried and, accordingly, Bill 123 was passed.

At 12.59 o'clock p.m., Mr. Cusano, First Vice-President, suspended the proceedings until 3.00 o'clock p.m.

The proceedings resumed at 3.07 o'clock p.m.

Report Stage

The Assembly took into consideration the report from the Committee on Institutions on its clause-by-clause consideration of Bill 133, An Act to amend article 1974 of the Civil Code.

After debate thereon, the report was concurred in.

Passage in Principle

The Assembly resumed the debate, which had been adjourned on 9 December 2005, on the motion by Mrs. Théberge, Minister of Families, Seniors and the Status of Women, –That Bill 124, Educational Childcare Act, do now pass in principle.

The debate being concluded, the question was put on this motion; a recorded division was thereupon demanded.

The motion was carried on the following vote:

Yeas: 59 Nays: 40 Abstentions: 0

Accordingly, Bill 124 was passed in principle.

Mr. Moreau, Deputy Government House Leader, moved that Bill 124 be referred for clause-by-clause consideration to the Committee on Social Affairs.

The motion was carried.

At 5.45 o'clock p.m., at the request of Mr. Moreau, Deputy Government House Leader, and by leave of the Assembly, Mr. Gendron, Third Vice-President, suspended the proceedings until 8.00 o'clock p.m.

The proceedings resumed at 8.06 o'clock p.m.

Passage in Principle

Mrs. Gauthier, Minister of Tourism, on behalf of Mr. Lessard, Interim Minister of Agriculture, Fisheries and Food, moved, –That Bill 137, An Act respecting reserved designations and added-value claims, do now pass in principle.

After debate thereon, the motion was carried and Bill 137 was accordingly passed in principle.

Mr. Moreau, Deputy Government House Leader, moved that Bill 137 be referred for clause-by-clause consideration to the Committee on Agriculture, Fisheries and Food.

The motion was carried.

Mr. Moreau, Deputy Government House Leader, moved the adjournment of the Assembly until Wednesday, 14 December 2005, at 10.00 o'clock a.m.

The motion was carried.

Accordingly, at 9.01 o'clock p.m., Mr. Cusano, First Vice-President, adjourned the Assembly until Wednesday, 14 December 2005, at 10.00 o'clock a.m.
