Government Bills

Passage in Principle

Mr. Després, Minister of Transport, moved, —That Bill 129, An Act to amend the Act respecting owners and operators of heavy vehicles and other legislative provisions, do now pass in principle.

After debate thereon, the motion was carried and Bill 129 was accordingly passed in principle.

Mr. Moreau, Deputy Government House Leader, moved that Bill 129 be referred for clause-by-clause consideration to the Committee on Transportation and the Environment.

The motion was carried.

The Assembly resumed the debate, which had been adjourned on 24 November 2005, on the motion by Mr. Couillard, Minister of Health and Social Services, —That Bill 130, An Act to amend the Act respecting prescription drug insurance and other legislative provisions, do now pass in principle.
