By leave of the Assembly to set aside Standing Order 185, Mr. Coiteux, Minister of Public Security, together with Mr. Bérubé (Matane-Matapédia), Mr. Spénard (Beauce-Nord) and Mrs. Massé (Sainte-Marie–Saint-Jacques), moved:

Passage in Principle
