The Assembly was called to order at 9.40 o'clock a.m.

Oral Questions and Answers

The Assembly proceeded to Oral Question Period.

Motions Without Notice

Mrs. Lamarre (Taillon), together with Mr. Paradis (Lévis) and Mrs. Massé (Sainte-Marie–Saint-Jacques), moved a motion concerning negotiations with the Federal Government on health transfers; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mr. Charette (Deux-Montagnes), together with Mrs. St-Pierre, Minister of International Relations and La Francophonie, Mr. Bergeron (Verchères) and Mrs. Massé (Sainte-Marie–Saint-Jacques), moved:

THAT the National Assembly offer its support to the Haitian people affected by Hurricane Matthew;

THAT the Assembly offer its support to ensure free, democratic elections in Haiti next month.

By leave of the Assembly, the motion was carried.

By leave of the Assembly to set aside Standing Order 185, Mr. Proulx, Minister of Education, Recreation and Sports, together with Mr. Turcotte (Saint-Jean), Mr. Schneeberger (Drummond–Bois-Francs) and Mrs. Massé (Sainte-Marie–Saint-Jacques), moved:

THAT the National Assembly congratulate our Olympic and Paralympic athletes on their outstanding performance at the Rio Games;

THAT it recognize that these athletes are a true source of inspiration and pride for the public and for future athletes as well as being excellent ambassadors for Québec;

THAT it highlight the efforts these athletes make every day to achieve the greatest heights.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

Mrs. Massé (Sainte-Marie–Saint-Jacques), together with Mr. Therrien (Sanguinet), moved a motion concerning the Canada-European Union Comprehensive Economic and Trade Agreement; this motion could not be debated for want of unanimous consent.

Notices of Proceedings in Committees

Mr. Sklavounos, Deputy Government House Leader, convened the following committees:

- the Committee on Planning and the Public Domain, to continue its clause-by-clause consideration of Bill 110, An Act respecting the process of negotiation of collective agreements and the settlement of disputes in the municipal sector;
- the Committee on Public Finance, to continue its clause-by-clause consideration of Bill 87, An Act to facilitate the disclosure of wrongdoings within public bodies;

-- the Committee on Labour and the Economy, to continue its clause-byclause consideration of Bill 70, An Act to allow a better match between training and jobs and to facilitate labour market entry.

Mr. Gendron, Third Vice-President, gave the following notices:

- the Committee on Agriculture, Fisheries, Energy and Natural Resources shall meet to elect its Vice-Chair; and then, hold a deliberative meeting to discuss the possibility of examining certain orders of initiative;
- the Committee on Labour and the Economy shall hold a deliberative meeting to organize the next steps of the order of initiative on the process that led to the sale of shares in RONA by Investissement Québec; and then, discuss the possibility of examining an order of initiative;
- the Committee on Transportation and the Environment shall meet to elect its Chair.

ORDERS OF THE DAY

Government Bills

Report Stage

The Assembly took into consideration the report from the Committee on Transportation and the Environment on its clause-by-clause consideration of Bill 104, An Act to increase the number of zero-emission motor vehicles in Québec in order to reduce greenhouse gas and other pollutant emissions, together with the amendment transmitted by Mr. Heurtel, Minister of Sustainable Development, the Environment and the Fight Against Climate Change.

The amendment was declared in order.

After debate thereon, the amendment was carried.

The report, as amended, was concurred in.

Passage in Principle

Mrs. Charlebois, Minister for Rehabilitation, Youth Protection, Public Health and Healthy Living, moved that Bill 99, An Act to amend the Youth Protection Act and other provisions, do now pass in principle.

After debate thereon, the motion was carried, and Bill 99 was accordingly passed in principle.

Mr. Sklavounos, Deputy Government House Leader, moved that Bill 99 be referred to the Committee on Health and Social Services for clause-by-clause consideration.

The motion was carried.

At 12.09 o'clock a.m., at the request of Mr. Sklavounos, Deputy Government House Leader, and by leave of the Assembly to set aside Standing Order 20, Mr. Gendron, Third Vice-President, suspended the proceedings until 3.00 o'clock p.m.

The proceedings resumed at 3.01 o'clock p.m.

Business Standing in the Name of Members in Opposition

Mr. Gaudreault (Jonquière) moved:

THAT the National Assembly demand that the Liberal Government immediately suspend any and all measures aimed at service centralization that are harmful to Québec's regions;

THAT it ask the Government to appoint a Member from one of Québec's resource regions as Minister of Regions and as Minister of Regional Development;

THAT the National Assembly ask the Government of Québec to modify the composition of its advisory committee on economics and innovation to comprise five representatives from Québec's regions, including two from the Capitale-Nationale region.

Mr. Ouimet, First Vice-President, informed the Assembly of the allocation of speaking time for the proceedings with respect to this limited debate: 10 minutes to the mover of the motion for his reply; approximately 52 minutes to the parliamentary group forming the Government; approximately 30 minutes 20 seconds to the parliamentary group forming the Official Opposition; approximately 21 minutes 40 seconds to the Second Opposition Group; and 6 minutes to the independent Members. Within this framework, any time not used by the independent Members or by a parliamentary group shall be redistributed among the parliamentary groups in the proportions established above. Lastly, individual addresses shall not be limited.

A debate arose thereon.

Mr. Bérubé, Official Opposition House Leader, moved:

THAT the motion moved by the Member for Jonquière be amended as follows:

By replacing, in the second paragraph, the words "one of Québec's resource regions" by the words "a region far from Québec's urban centres"; and

By replacing, in the third paragraph, the words "comprise five representatives from Québec's regions, including two from the Capitale-Nationale region" by the words "so that Québec's regions, including the Capitale-Nationale region, are appropriately represented".

The motion, as amended, would read as follows:

THAT the National Assembly demand that the Liberal Government immediately suspend any and all measures aimed at service centralization that are harmful to Québec's regions;

THAT it ask the Government to appoint a Member from a region far from Québec's urban centres as Minister of Regions and as Minister of Regional Development;

THAT the National Assembly ask the Government of Québec to modify the composition of its advisory committee on economics and innovation so that Québec's regions, including the Capitale-Nationale region, are appropriately represented.

The debate continued on the main motion moved by Mr. Gaudreault (Jonquière) and on the amendment motion moved by Mr. Bérubé, Official Opposition House Leader, subject to the permission of its author.

Pursuant to Standing Order 98.1, Mr. Gaudreault (Jonquière) accepted the amendments proposed by Mr. Bérubé, Official Opposition House Leader.

The debate being concluded, the question was put on the amendment motion moved by Mr. Bérubé, Official Opposition House Leader, and a recorded division was thereupon demanded.

At the request of Mr. Sklavounos, Deputy Government House Leader, the divisions on the amendment by Mr. Bérubé, Official Opposition House Leader, and on the motion by Mr. Gaudreault (Jonquière) were deferred until Routine Proceedings on the next sitting day.

Mr. Sklavounos, Deputy Government House Leader, moved the adjournment of the Assembly until Thursday, 20 October 2016 at 9.40 o'clock a.m.

The motion was carried.

Accordingly, at 5.02 o'clock p.m., Mr. Gendron, Third Vice-President, adjourned the Assembly until Thursday, 20 October 2016 at 9.40 o'clock a.m.
