The Assembly was called to order at 10.04 o'clock a.m.

#### ORDERS OF THE DAY

#### **Government Motions**

The Assembly held the debate on the motion arising out of the tabling by Mrs. Gagnon-Tremblay, Minister of International Relations, on 7 April 2005, of the Cartagena Protocol on Biosafety to the Convention on Biological Diversity.

This motion reads as follows:

THAT the National Assembly approves the Cartagena Protocol on Biosafety to the Convention on Biological Diversity, pursuant to section 22.3 of the *Act respecting the Ministère des Relations internationales*.

Following a meeting with the House leaders, Mr. Gendron, Third Vice-President, informed the Assembly of the allocation of speaking time for the debate on this motion: 10 minutes shall be set aside for the independent Members; the two parliamentary groups will share equally the rest of the time allotted for this debate; within this framework, any time not used by a parliamentary group will be added to that of the other group, while any time not used by the independent Members may be redistributed equally among the parliamentary groups, it having been agreed that this apportionment may not be carried out before the time allotted to both parliamentary groups has entirely expired; and individual addresses shall not be limited.

A debate arose thereon.

The debate being concluded, the motion was carried. Accordingly, this commitment was approved.
