Information on the Proceedings of the Assembly

THAT the National Assembly deplore that the Premier of Québec, responsible for youth issues, has abandoned Québec's youth.

ORDERS OF THE DAY

Government Bills

Passage in Principle

Mr. Pelletier, Minister responsible for Canadian Intergovernmental Affairs, Francophones within Canada, the Agreement on Internal Trade, the Reform of Democratic Institutions and Access to Information, moved, —That Bill 86, An Act to amend the Act respecting Access to documents held by public bodies and the Protection of personal information and other legislative provisions, do now pass in principle.

After debate thereon, the motion was carried and Bill 86 was accordingly passed in principle.

Mrs. Lamquin-Éthier, Deputy Government House Leader, moved that Bill 86 be referred for clause-by-clause consideration to the Committee on Culture.

The motion was carried.

The Assembly held three debates upon adjournment:

- the first, on a question by Mrs. Harel (Hochelaga-Maisonneuve) to Mr. Couillard, Minister of Health and Social Services, about the recognition of paramedics;
- the second, on a question by Mr. Turp (Mercier) to Mrs. Beauchamp, Minister of Culture and Communications, about the CKAC news room;
- the third, on a question by Mr. Bouchard (Vachon) to Mrs. Courchesne, Minister of Employment and Social Solidarity, about assistance to aged workers.

At 6.42 o'clock p.m., Mr. Cusano, First Vice-President, adjourned the Assembly until Wednesday, 6 April 2005, at 10.00 o'clock a.m.
