Mrs. Courchesne, Minister of Relations with the Citizens and Immigration and Minister responsible for the Status of Women, tabled the following:

By leave of the Assembly to set aside Standing Orders 53 and 188, Mr. Dupuis, Government House Leader, moved:

THAT, pursuant to Standing Order 146, the Committee on Social Affairs hold a general consultation with reference to the document tabled on 4 November 2004 and entitled "For a New Social Contract of Equality between Women and Men", and that it hold public hearings beginning on 18 January 2005;

THAT all briefs be submitted to the Secretariat of Committees by 10 December 2004;

Government Bills

Passage

Mr. Dupuis, Minister of Justice and Attorney General, moved the passage of Bill 46, An Act to amend the Act respecting Attorney General's prosecutors and the Labour Code.

After debate thereon, the motion was carried and, accordingly, Bill 46 was passed.

Mr. Dupuis, Minister of Justice, moved the passage of Bill 59, An Act to amend the Civil Code as regards marriage.

After debate thereon, the motion was carried and, accordingly, Bill 59 was passed.

At 3.19 o'clock p.m., at the request of Mr. Dupuis, Government House Leader, Mr. Gendron, Third Vice-President, suspended the proceedings until 3.30 o'clock p.m.
