THAT, pursuant to section 246.44 of the *Courts of Justice Act*, the National Assembly approve the recommendations contained in the report of the Committee on the remuneration of the judges of the Court of Québec of 25 March 2004 regarding the computation of the pension of judges. These recommendations ensure that no penalties are incurred by a judge who has exercised managerial duties and who could exceptionally find himself with a pension that is less than that of a puisne judge, without for that matter unduly increasing the admissible salary.
