Mr. Legault (Rousseau) moved:

THAT the National Assembly of Québec  
deplore the various increases in tariffs ordered by the  
Liberal Government.

Following a meeting with the House leaders, Mrs. Leblanc, Second Vice-President, announced the allocation of speaking time for the proceedings with respect to this motion: ten minutes shall be allotted for a reply by its mover and ten minutes shall be set aside for the independent Members; the two parliamentary groups shall share equally the rest of the time allotted for this debate; within this framework, any time not used by a parliamentary group may be added to that of the other group while any time not used by the independent Members shall be redistributed equally amongst the parliamentary groups, and individual addresses shall not be limited.

## **ORDERS OF THE DAY**

### **Estimates of Expenditure**

#### *Interim Supply*

By leave of the Assembly to set aside Standing Order 188, Mr. Dupuis, Government House Leader, moved that the Assembly give general approval to one quarter of the Estimates of Expenditure, pursuant to Standing Orders 280 and 281, according to the following terms and conditions:

THAT immediately this motion is carried, the Assembly resolve itself into a Committee of the Whole;

THAT beginning immediately, for a period of 60 minutes, an exchange shall take place between the Minister responsible for Government Administration, Chair of the Conseil du trésor, and the Members sitting in opposition;

THAT immediately thereafter, for a period of 90 minutes, an exchange shall take place between the Minister of Health and Social Services and the Members sitting in opposition;

THAT subsequently, for a period of 90 minutes, an exchange shall take place between the Minister of Education and the Members sitting in opposition;

THAT subsequently, for a period of 60 minutes, an exchange shall take place between the Minister for Regional Development and Tourism and the Members sitting in opposition;

THAT immediately thereafter, the question shall be put for concurrence in one quarter of the Estimates of Expenditure for the 2004-2005 fiscal year;

THAT immediately thereafter, the Chairman of the Committee of the Whole shall report the interim supply estimates to the Assembly; and the question for concurrence in such report and that for passage of the consequent appropriation bill shall be put without debate, pursuant to the first paragraph of Standing Order 281;

THAT finally, pursuant to the second paragraph of Standing Order 281, on a motion that the Government House Leader shall be permitted to move without notice and that may not be debated, the estimates of expenditure, save those for the National Assembly, shall be referred for consideration to the Standing Committees;

THAT the opening statements concerning each of the exchanges with the aforementioned Ministers be apportioned as follows: five minutes to each parliamentary group and two minutes to the independent Members;

THAT this motion become an order of the Assembly.

The motion was carried.

Mr. Dupuis, Government House Leader, moved that the Assembly resolve itself into a Committee of the Whole for the consideration of the Estimates of Expenditure for the 2004-2005 fiscal year, with a view to granting Interim Supply, being one quarter of the said Estimates.

The motion was carried.

*Consideration in Committee of the Whole*

The Committee of the Whole entered upon the consideration of Interim Supply for the fiscal year ending 31 March 2005.

The debate being concluded, Interim Supply for the 2004-2005 fiscal year was concurred in on division.

The Chairman of the Committee of the Whole reported to the Assembly as follows:

The Committee of the Whole has granted a quarter of Interim Supply in a sum not to exceed \$10,595,983,175.00 to defray a part of the expenditure estimates of Québec tabled in the National Assembly for the 2004-2005 fiscal year not otherwise provided for.

The report was concurred in on division.

Mrs. Jérôme-Forget, Chair of the Conseil du trésor and Minister responsible for Government Administration, moved:

THAT Bill 43, Appropriation Act No. 1, 2004-2005, be brought before the Assembly;

THAT this Bill do pass in principle;

THAT this Bill do pass.

This motion was carried on division. Accordingly, Bill 43, Appropriation Act No. 1, 2004-2005, was passed.

Mr. Dupuis, Government House Leader, moved that the Estimates of Expenditure for the 2004-2005 fiscal year, save those for the National Assembly, be referred for consideration to the Standing Committees.

This motion was carried.
