#### **Business Standing in the Name of Members in Opposition**

Mr. Tremblay (Lac-Saint-Jean) moved:

THAT the National Assembly may vote on the advisability of the construction of the Suroît thermal power plant before any new Government decision is made in this regard.

Following a meeting with the House leaders, Mr. Gendron, Third Vice-President, announced that he had apportioned the speaking time for the proceedings with respect to this motion as follows: ten minutes shall be allotted for a reply by its mover and ten minutes shall be set aside for the independent Members; the two parliamentary groups shall share equally the rest of the time allotted for this debate; within this framework, any time not used by a parliamentary group may be added to that of the other group while any time not used by the independent Members shall be redistributed equally amongst the parliamentary groups, and individual addresses shall not be limited.

The debate being concluded, the question was put on this motion; a recorded division was thereupon demanded.
