Government Bills

Passage in Principle

Mr. Corbeil, Minister for Forests, Wildlife and Parks, moved, —That Bill 14, An Act to amend the Forest Act and other legislative provisions and to enact certain special provisions applicable to forest management activities prior to 1 April 2006, do now pass in principle.

After debate thereon, the motion was carried and Bill 14 was accordingly passed in principle.

Mr. Dupuis, Government House Leader, moved that Bill 14 be referred for clause-by-clause consideration to the Committee on Labour and the Economy.

The motion was carried.

At 10.55 o'clock a.m., at the request of Mr. Dupuis, Government House Leader, Mrs. Leblanc, Second Vice-President, suspended the proceedings until 2.00 o'clock p.m.

Introduction of Bills
Mr. Bellemare, Minister of Justice, moved that leave be granted to introduce the following Bill:
An Act to amend the Civil Code and the Code of Civil Procedure as regards the determination of child support payments.
Mr. President gave the floor to Mr. Boisclair, Official Opposition House Leader, on a matter of privilege suddenly arising. The latter alleged that the Minister of Justice was in contempt of Parliament by releasing the contents of Bill 21, An Act to amend the Civil Code and the Code of Civil Procedure as regards the determination of child support payments, before its introduction in the Assembly. By leave of the Assembly to set aside Standing Order 59, Mr. Boisclair then tabled the following: A press release from the office of the Minister of Justice concerning the amendments to the rules for the determination of child support payments. At 2.17 o'clock p.m., Mr. President suspended the proceedings to take this matter under advisement.

The proceedings resumed at 2.57 o'clock p.m.

Mr. President rendered his decision on the matter of privilege raised by Mr. Boisclair, Official Opposition House Leader.

RULING FROM THE CHAIR

The matter of privilege is not receivable. Nothing in the facts submitted allows us to conclude that the provisions of the bill were released. The press release issued by the Office of the Minister refers only to the major orientations of the bill; it does not in any way infer on the decisions the Assembly will be called upon to take with regard to the bill.

Report Stage

The Assembly took into consideration the report from the Committee on Institutions on its clause-by-clause consideration of Bill 6, An Act to amend the Highway Safety Code and the Code of Penal Procedure as regards the collection of fines, together with the amendment handed in by Mr. Chagnon, Minister of Public Security.
