Motions Without Notice

By leave of the Assembly to set aside Standing Order 185, Mrs. Maltais, Minister for Employment, and Mrs. Thériault (Anjou) jointly moved:

THAT the National Assembly formally ask the Government of Canada to cease using the employment insurance fund for the purpose of reimbursing the federal debt, to use the fund to further support the unemployed by allocating the maximum amount provided for in the *Employment Insurance Act* through the Canada-Québec Labour Market Agreement, and to respect the primacy of Québec in the labour development sector by entering into a supplementary agreement that would put an end to overlapping in the funding of Québec's initiatives for the improvement of service to clienteles such as youth, disabled persons, immigrants and older workers.

Passage
