Passage in Principle

By leave of the Assembly to set aside Standing Order 237, Mr. Lelièvre (Gaspé) moved, –That Bill 391, An Act concerning a land facilities project in the port of Chandler do now pass in principle.

After debate thereon, the motion was carried and Bill 391 was accordingly passed in principle.

Committee of the Whole

Government Bills

Passage

Mrs. Beaudoin, Minister of International Relations, moved the passage of Bill 109, An Act respecting the Observatoire québécois de la mondialisation.

After debate thereon, the motion was carried on division and, accordingly, Bill 109 was passed.

Passage in Principle

Mr. Julien, Minister of Revenue, moved, –That Bill 121, An Act to amend the Act respecting the Ministère du Revenu and other legislative provisions, do now pass in principle.

After debate thereon, the motion was carried and Bill 121 was accordingly passed in principle.

Debates Upon Adjournment

- the first, on a question by Mr. MacMillan (Papineau) to Mrs. Marois, Minister of Finance, the Economy and Research, about the regional county municipality of Papineau. The Minister for Industry and Trade replaced the Minister of Finance in this debate.
- the second, on a question by Mrs. Houda-Pepin (La Pinière) to Mr. Côté, Minister for Housing, about the housing crisis.

Mr. Boisclair, Government House Leader, moved that the Assembly adjourn its proceedings until Tuesday, 19 November 2002, at 10.00 o'clock a.m.

And debate arising;

Mr. Mulcair (Chomedey) requested a directive from the Chair concerning the consequences of carrying the motion to adjourn the Assembly on the holding of the interpellations scheduled for 8, 15 and 22 November 2002.

DIRECTIVE FROM THE CHAIR

Mr. Brouillet, First Vice-President, referred to Standing Order 299, which states that no interpellation may be held during any period in which the Assembly stands adjourned for more than five days. If the motion to adjourn is carried, the interpellations scheduled for 8 and 15 November 2002 cannot be held, unless the Assembly gives its consent.

Furthermore, pursuant to Standing Order 297, the President must announce to the Assembly the subject matter of the interpellation on the last sitting day of the week preceding the week in which it is to be held. If the motion to adjourn is carried, the Assembly will not sit the following week, which implies that the Chair will not make

such an announcement. Unless the Assembly gives its consent, no interpellation may thus be held on 22 November 2002.

The debate being concluded, the question was put on this motion; a recorded division was thereupon demanded.
