Mr. Boisclair, Government House Leader, moved:

THAT the Committee on Social Affairs hold a general consultation on Bill 112, An Act to combat poverty and social exclusion, beginning on 1 October 2002;

THAT all briefs be submitted to the Secretariat of Committees by 20 September 2002;

The Minister of Social Solidarity and the Minister for the Elimination of Poverty and Exclusion shall be members of the said Committee during its proceedings with respect to this order of reference.

The motion was carried.

Mr. Boisclair, Government House Leader, convened the following Committees:

- the Committee on Transportation and the Environment, to continue its clause-by-clause consideration of Bill 67, An Act to amend the Highway Safety Code and other legislative provisions;
- the Committee on Institutions, to give clause-by-clause consideration to Bill 100, An Act to amend the Act respecting offences relating to alcoholic beverages, the Act respecting lotteries, publicity contests and amusement machines and the Act respecting liquor permits;

ORDERS OF THE DAY

Government Bills

Passage

Mr. Trudel, Minister responsible for Native Affairs, moved the passage of Bill 93, An Act to ensure the implementation of the Agreement Concerning a New Relationship Between le Gouvernement du Québec and the Crees of Québec.

After debate thereon, the motion was carried and, accordingly, Bill 93 was passed.

Report Stage

Pursuant to the motion for exceptional procedure carried at the sitting of 11 June 2002, the Assembly took into consideration the report from the Committee on Social Affairs on its clause-by-clause consideration of Bill 98, An Act to amend the Act respecting prescription drug insurance and other legislative provisions, together with the amendments handed in by Mr. Legault, Minister of Health and Social Services.

The amendments were declared in order. The amendment to section 46 will however require a correction in its form by Mr. Brouillet, First Vice-President.

Before the debate began, Mr. Brouillet, First Vice-President, informed the Assembly that, following a meeting with the House leaders, he allocated the speaking time for the proceedings with respect to this limited debate on the motion for exceptional procedure as follows: three minutes shall be set aside for the independent Members; the two parliamentary groups shall share equally the rest of the time allotted for this debate; within this framework, any time not used by a parliamentary group or by the independent Members may be redistributed, and individual addresses shall not otherwise be limited.

And debate arising;		

At 1.00 o'clock p.m., Mr. Brouillet, First Vice-President, suspended the proceedings until 3.00 o'clock p.m.

The proceedings resumed at 3.06 o'clock p.m.

Report Stage

The Assembly continued the debate on the consideration of the report from the Committee on Social Affairs on its clause-by-clause consideration of Bill 98, An Act to amend the Act respecting prescription drug insurance and other legislative provisions, together with the amendments handed in by Mr. Legault, Minister of Health and Social Services.

The debate being concluded, the question was put on the amendments.

The amendments to sections 5, 14, 15, 17, 21, 30, 31, 37, 43 and 46 were carried on division.

The amendments to sections 19 and 42 were carried.

Sections 5, 14, 15, 17, 19, 12, 30, 31, 37, 42, 43 and 46, as amended, and new section 28.1 were carried on division.

New section 13.1 was carried.

The question was put on the report as amended; a recorded division was thereupon demanded.

The report was adopted on the following vote:

Passage

Mr. Legault, Minister of Health and Social Services, moved the passage of Bill 98, An Act to amend the Act respecting prescription drug insurance and other legislative provisions.

Before the debate began, Mr. Bissonnet, Third Vice-President, informed the Assembly that, following a meeting with the House leaders, he allocated the speaking time for the proceedings with respect to this limited debate on the motion for exceptional procedure as follows: three minutes shall be set aside for the independent Members; the two parliamentary groups shall share equally the rest of the time allotted for this debate; within this framework, any time not used by a parliamentary group or by the independent Members may be redistributed, and individual addresses shall not otherwise be limited.

After debate thereon, the question was put on this motion; a recorded division was thereupon demanded.

The motion was carried on the following vote:

(Division No. 107 in Appendix)

Yeas: 50 Nays: 28 Abstentions: 0

Accordingly, Bill 98 was passed.

At 5.51 o'clock p.m., Mr. Bissonnet, Third Vice-President, suspended the proceedings until 8.00 o'clock p.m.

The proceedings resumed at 8.09 o'clock p.m.

Passage in Principle

Mr. Bégin, Minister of Justice, moved, —That Bill 90, An Act to amend the Professional Code and other legislative provisions as regards the health sector, do now pass in principle.

After debate thereon, the motion was carried and Bill 90 was accordingly passed in principle.

Mr. Simard, Deputy Government House Leader, moved that Bill 90 be referred for clause-by-clause consideration to the Committee on Institutions.

The motion was carried.

Report Stage

The Assembly took into consideration the report from the Committee on Institutions on its clause-by-clause consideration of Bill 50, An Act to amend the Civil Code, together with the amendments handed in by Mr. Bégin, Minister of Justice.

The amendments were declared in order.

After debate thereon, the amendments were carried.

The report, as amended, was concurred in.

The Assembly took into consideration the report from the Committee on Institutions on its clause-by-clause consideration of Bill 62, An Act to amend the Act respecting the Ministère de la Justice as regards the register fund.

The report was concurred in.

The Assembly took into consideration the report from the Committee on Institutions on its clause-by-clause consideration of Bill 68, An Act to amend the Act respecting municipal courts, the Courts of Justice Act and other legislative provisions, together with the amendment handed in by Mr. Bégin, Minister of Justice.

The amendment was declared in order.

After debate thereon, the amendment was carried.

The report, as amended, was concurred in.

The Assembly took into consideration the report from the Committee on Institutions on its clause-by-clause consideration of Bill 86, An Act to amend the Courts of Justice Act, the Act respecting municipal courts and other legislative provisions.

After debate thereon, the report was concurred in.

Passage

Mr. Bégin, Minister of Justice, moved the passage of Bill 70, An Act to amend the Act respecting administrative justice and other legislative provisions.

And debate arising;

During the debate, Mr. Bégin, Minister of Justice, moved that Bill 70 be referred to a Committee of the Whole for the consideration of amendments that he specified.

This motion was carried.

Mr. Bégin, Minister of Justice, moved that the Assembly resolve itself into a Committee of the Whole.

The motion was carried.

The said amendments were considered and then carried in Committee of the Whole.

Bill 70, as amended, was reported to the Assembly, which concurred in the Committee's report.

And debate continuing on the motion for the passage of Bill 70;

The debate being concluded, the motion was carried and, accordingly, Bill 70 was passed.

Passage

Mr. Trudel, Minister of Regions, moved the passage of Bill 97, An Act to amend the Act respecting the Ministère des Régions.

And debate arising;

During the debate, Mr. Trudel, Minister of Regions, moved that Bill 97 referred to a Committee of the Whole for the consideration of an amendment that he specified.

This motion was carried.

Mr. Trudel, Minister of Regions, moved that the Assembly resolve itself into a Committee of the Whole.

The motion was carried.

The said amendment was considered and then carried in Committee of the Whole.

Bill 97, as amended, was reported to the Assembly, which concurred in the Committee's report.

And debate continuing on the motion for the passage of Bill 97;

The debate being concluded, the motion was carried and, accordingly, Bill 97 was passed.

Mrs. Lemieux, Minister responsible for the Charter of the French Language, moved the passage of Bill 104, An Act to amend the Charter of the French language.

After debate thereon, the motion was carried and, accordingly, Bill 104 was passed.

Mr. Simard, Deputy Government House Leader, moved that the Assembly adjourn its proceedings until Thursday, 13 June 2002, at 10.00 o'clock a.m.
