Mr. Roger Bertrand, Minister for Health, Social Services, Youth Protection and Prevention, moved that leave be granted to introduce the following Bill:

Presenting Reports from Committees

Mr. Lachance (Bellechasse), chairman, tabled the following:

Complaints of Breach of Privilege or Contempt and Personal Explanations

Mr. Bissonnet, Third Vice-President, informed the Assembly that he had received, within the prescribed time, a request from Mr. Mulcair (Chomedey) to give personal explanations concerning the document, which was tabled on 23 May 2002 by the Government House Leader, entitled "Comments made by Mr. Jean Lapierre regarding the remarks made by Mr. Thomas Mulcair with respect to Mr. Yves Duhaime" and the newspaper articles thereon.

Mr. Bissonnet, Third Vice-President, ruled that this request was in order and, consequently, allowed the Member for Chomedey to give explanations.

Oral Questions and Answers

The Assembly proceeded to Oral Question Period.

At the request of Mr. Bissonnet, Third Vice-President, Mr. Landry, Premier, withdrew certain words deemed unparliamentary.

By leave of the Assembly to set aside Standing Order 53, the Assembly immediately took Notices of Proceedings in Committees.

Mr. Boisclair, Government House Leader, convened the following Committees:

- the Committee on Public Finance, to hold hearings within the framework of a general consultation on Bill 80, Lobbying Transparency and Ethics Act;
- the Committee on Social Affairs, to hold special consultations on Bill 98, An Act to amend the Act respecting prescription drug insurance and other legislative provisions.

Motions Without Notice

Mrs. Goupil, Minister of Child and Family Welfare, moved:

THAT the National Assembly mark Québec Day Care Services Week, which is held from 26 May to 1 June 2002, and whose theme is "Imagine un océan de plaisir".

By leave of the Assembly under Standing Order 84, a debate arose thereon.

The debate being concluded, the motion was carried.

Passage in Principle

Mrs. Lemieux, Minister responsible for the Charter of the French Language, moved, –That Bill 104, An Act to amend the Charter of the French language, do now pass in principle.

And debate arising;

At 12.57 o'clock p.m., Mr. Brouillet, First Vice-President, suspended the proceedings until 3.00 o'clock p.m.

The proceedings resumed at 3.01 o'clock p.m.

Passage in Principle

And debate continuing on the motion by Mrs. Lemieux, Minister responsible for the Charter of the French Language, –That Bill 104, An Act to amend the Charter of the French language, do now pass in principle;

The debate being concluded, the motion was carried and Bill 104 was accordingly passed in principle.

Mr. Simard, Deputy Government House Leader, moved that Bill 104 be referred for clause-by-clause consideration to the Committee on Culture.

Report Stage

The Assembly took into consideration the report from the Committee on Public Finance on its clause-by-clause consideration of Bill 65, Budget Act No. 1 giving effect to the Budget Speech delivered on 29 March 2001 and to certain budget statements.

After debate thereon, the report was concurred in.

Passage

Mr. Jean-François Simard, Minister for the Environment and Water, moved the passage of Bill 72, An Act to amend the Environment Quality Act and other legislative provisions with regard to land protection and rehabilitation.

Mr. Simard, Deputy Government House Leader, moved the adjournment of the debate.

The motion was carried.

Passage in Principle

Resuming the debate, which had been adjourned on 23 May 2002, on the motion by Mr. Legault, Minister of Health and Social Services, —That Bill 101, An Act to amend the Act respecting health services and social services as regards residences for the elderly, do now pass in principle;

At 5.53 o'clock p.m., Mr. Bissonnet, Third Vice-President, suspended the proceedings until 8.00 o'clock p.m.

The proceedings resumed at 8.04 o'clock p.m.
