Motions Without Notice

Mr. Lemay (Masson), together with Mrs. Maltais (Taschereau), Mrs. Massé (Sainte-Marie–Saint-Jacques), Mr. Surprenant (Groulx) and Mrs. Ouellet (Vachon), moved a motion regarding the company Anacolor; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mrs. Charlebois, Minister for Rehabilitation, Youth Protection, Public Health and Healthy Living, together with Mrs. Lamarre (Taillon), Mrs. Lavallée (Repentigny), Mr. Khadir (Mercier), Mr. Surprenant (Groulx), Mr. Sklavounos (Laurier-Dorion) and Mrs. Ouellet (Vachon), moved:

> THAT the National Assembly mark the 29th edition of "Semaine québécoise de la déficience intellectuelle", held this year from 12 to 18 March 2017;

> THAT the Assembly recognize the contribution that persons with intellectual disabilities make in our society;

THAT it express its solidarity with these individuals, their families and the support organizations that show determination in meeting daily challenges and that need backing;

THAT it highlight the commitment of the community as a whole, which helps Québec society move towards even greater inclusiveness.

By leave of the Assembly, the motion was carried.

Mr. Bérubé (Matane-Matapédia), together with Mr. Charette (Deux-Montagnes), Mrs. Massé (Sainte-Marie–Saint-Jacques), Mr. Surprenant (Groulx) and Mrs. Ouellet (Vachon), moved a motion on emergency interventions on Highway 13 the night of 14 to 15 March 2017; this motion could not be debated for want of unanimous consent.

Mrs. Ouellet (Vachon), together with Mr. Khadir (Mercier), moved a motion on the firm KPMG; this motion could not be debated for want of unanimous consent.

Notices of Proceedings in Committees

Mr. Tanguay, Deputy Government House Leader, convened the following committees:

- the Committee on Public Finance shall hold a deliberative meeting to discuss its draft report and determine its observations, conclusions and recommendations, if any, concerning the tax haven phenomenon.
