#### **Motions Without Notice**

By leave of the Assembly to set aside Standing Order 185, Mrs. St-Pierre, Minister of International Relations and La Francophonie, together with Mr. Charette (Deux-Montagnes), Mr. Khadir (Mercier), Mr. Surprenant (Groulx), Mr. Sklavounos (Laurier-Dorion) and Mrs. Ouellet (Vachon), moved:

THAT the National Assembly mark International Francophonie Day, celebrated every year on 20 March;

THAT the Assembly reaffirm its attachment to the institutions of La Francophonie and that it express its conviction that they constitute preferred instruments for fostering peace, justice and human rights;

THAT it recall that the French fact is a fundamental characteristic of Québec and Canadian identity;

THAT, lastly, the National Assembly recall that promoting the French language outside Québec must be a priority and that we must work together to this end.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

Mr. Bérubé, Official Opposition House Leader, together with Mr. Bonnardel (Granby), Mrs. Massé (Sainte-Marie-Saint-Jacques), Mr. Surprenant (Groulx) and Mrs. Ouellet (Vachon), moved a motion on the principle of ministerial accountability on the management of the Ministère des Transports, de la Mobilité durable et de l'Électrification des transports and the Ministère de la Sécurité publique during the snowstorm of 14 to 15 March 2017; this motion could not be debated for want of unanimous consent.

Mr. Legault, Leader of the Second Opposition Group, together with Mr. Lisée, Leader of the Official Opposition, and Mr. Surprenant (Groulx), moved a motion on the head office of the Canada Infrastructure Bank; this motion could not be debated for want of unanimous consent.

By leave of the Assembly to set aside Standing Order 185, Mr. Khadir (Mercier), together with Mrs. Weil, Minister of Immigration, Diversity and Inclusiveness, Mrs. Poirier (Hochelaga-Maisonneuve), Mr. Sklavounos (Laurier-Dorion) and Mrs. Ouellet (Vachon), moved:

THAT the National Assembly mark Nowruz, the first day of spring, celebrated as the New Year by Quebecers originally from Iran, Afghanistan, Azerbaijan, Kurdistan and Tajikistan and by the Baha'is.

By leave of the Assembly, the motion was carried.

### **Notices of Proceedings in Committees**

- the Committee on Planning and the Public Domain, to hold public hearings within the framework of special consultations on Bill 121, An Act to increase the autonomy and powers of Ville de Montréal, the metropolis of Québec.

Mrs. Gaudreault, Second Vice-President, gave the following notice:

 the Committee on Labour and the Economy shall hold a deliberative meeting to discuss the observations, conclusions and recommendations, if any, on the Régie du bâtiment du Québec and Regroupement activistes par inclusion Québec hearings.

## **Information on the Proceedings of the Assembly**

Mrs. Gaudreault, Second Vice-President, informed the Assembly that on Wednesday, 22 March 2017, during Business Standing in the Name of Members in Opposition, a debate would be held on the motion moved by Mr. Lisée, Leader of the Official Opposition.

This motion reads as follows:

THAT the National Assembly ask the Québec Government to freeze physicians' remuneration as of 1 April 2017 and put an end to physician incorporation;

THAT it ask the Government to use the money freed up to abolish the family tax, restore the universal \$7.30 fee for childcare services, provide elementary and secondary school materials free of charge as of September, and raise the solidarity tax credit by \$100 to cushion the impact of the rise in food prices for the 2.7 million recipient households.

By leave of the Assembly to set aside Standing Order 298, she then informed the Assembly that the interpellation between Mrs. Poirier (Hochelaga-Maisonneuve) and Mr. Coiteux, Minister responsible for the Montréal region, on the Liberal Government's abandonment of Montréal East, will be held on Friday, 24 March 2017 from 9.00 o'clock a.m. to 11.00 o'clock a.m.

#### **Government Bills**

Report Stage

The Assembly took into consideration the report from the Committee on Transportation and the Environment on its clause-by-clause consideration of Bill 102, An Act to amend the Environment Quality Act to modernize the environmental authorization scheme and to amend other legislative provisions, in particular to reform the governance of the Green Fund, together with the amendments transmitted by Mr. Heurtel, Minister of Sustainable Development, the Environment and the Fight Against Climate Change, and by Mr. Gaudreault (Jonquière).

#### 21 March 2017

The amendments were declared in order, except the amendments moved by Mr. Gaudreault (Jonquière) to sections 70.1 and 78.1, which were declared out of order because they proposed adding two sections to the bill to amend Division VI of Chapter 1 of the *Environment Quality Act*. It is true that the Act is amended extensively by Bill 102. However, the amendments do not relate to the principles in the bill, although the amendments deal with subjects addressed in the *Environment Quality Act*.

After debate thereon, the amendments moved by Mr. Heurtel, Minister of Sustainable Development, the Environment and the Fight Against Climate Change, were carried, and the amendments moved by Mr. Gaudreault (Jonquière) were negatived.
