## **ORDERS OF THE DAY**

## **BUSINESS HAVING PRECEDENCE**

(1) Resuming the debate, adjourned on **4 April 2017**, on the motion by the Minister of Finance, –That this Assembly approves the budgetary policy of the Government,

And on the motions stating a grievance moved by:

# The Member for Rousseau:

THAT the National Assembly severely censure the Liberal Government for cutting public services and increasing Quebecers' tax burden over the last three years and for tabling a budget proposing partial reinvestment in these services and incomplete reimbursement to Quebecers.

#### The Member for Granby:

THAT the National Assembly severely censure the Liberal Government for having considerably increased the tax burden on Québec families since beginning its term in office.

## The Member for Sainte-Marie–Saint-Jacques:

THAT the National Assembly of Québec censure the Liberal Government for its 2017-2018 budget, which postpones seriously beginning the transition to greater energy-efficiency and more environment-friendly methods, which favours the metropolitan electric network (REM) project to the detriment of real public transit needs and which jeopardizes the goal of achieving Québec's greenhouse gas emission reduction targets for 2020 and 2030.

#### The Member for Pointe-aux-Trembles:

THAT the National Assembly severely censure the Liberal Government for cutting public services over the last three years while continuing to give hundreds of millions of dollars to physicians.

## The Member for Matane-Matapédia:

THAT the National Assembly severely censure the Liberal Government for cutting public services over the last three years under the pretext of a fictitious \$7 billion deficit.

# The Member for René-Lévesque:

THAT the National Assembly severely censure the Liberal Government for not providing the resource regions with the necessary means, in its 2017-2018 budget, to enable them to enhance their economic and social development throughout their territory as a whole.

#### The Member for Saint-Jean:

THAT the National Assembly severely censure the Liberal Government for not significantly increasing funding for independent community action organizations in its 2017-2018 budget.

#### The Member for Berthier:

THAT the National Assembly severely censure the Liberal Government for its unjustified cuts over the last three years, particularly in health, social services and education, which will have serious, unfortunate and irreversible consequences for our children, seniors and the most vulnerable members of our society. And that the Assembly also censure the Liberal Government for eliminating any trace of humanitarianism in its choice of actions.

# The Member for Lévis:

THAT the National Assembly severely censure the Liberal Government for abandoning seniors by not planning any investment to increase the budget for meals in CHSLDs and to offer more baths and showers in CHSLDs.

# The Member for Chambly:

THAT the National Assembly severely censure the Liberal Government for not having a plan to solve the serious problem of hundreds of Québec schools that are in an advanced state of dilapidation.

# The Member for Vachon:

THAT the National Assembly severely censure the Liberal Government for its lack of vision in economic development.

#### The Member for Jonquière:

THAT the National Assembly severely censure the Liberal Government for not having provided sufficient sums in the 2017-2018 budget for high-speed Internet throughout all the regions.

# The Member for Mercier:

Mr. Gaudreault (Jonquière) – 14 March 2017
To the Minister of Transport, Sustainable Mobility and Transport Electrification

On 20 February 2017, the Minister of Transport, Sustainable Mobility and Transport Electrification sent the Committee on Public Administration a document entitled "Sommes du Fonds vert virées au FORT dans le cadre du Plan d'action 2013-2020 sur les changements climatiques – Suivi de la recommandation 7.6 du 34e rapport de la Commission de l'administration publique".

Concerning the graph "Sommes virées du Fonds vert au FORT dans le cadre du Plan d'action 2013-2020 sur les changements climatiques – Effets sur la réduction des émissions de GES » (p. 5):

• How does the Ministère identify the projects that the "Programme d'aide gouvernementale au transport collectif des personnes (PAGTCP) – FORT" would have funded, had it not been for the existence of the Green Fund?

Concerning table 2 "Programmes et mesures financées par le FORT à partir des sommes virées du Fonds vert" (p. 8):

• Why is the Programme d'aide au développement du transport collectif (PADTC) (action 13.7) for 2017 still not in effect?

## (227) Mr. Pagé (Labelle) – 14 March 2017

To the Minister of Education, Recreation and Sports

On 13 February 2017, the Minister of Education, Recreation and Sports announced a \$57-million grant for the implementation of 80 projects within the framework of the Programme de soutien pour le remplacement ou la modification des systèmes de réfrigération fonctionnant aux gaz R-12 ou R-22 : arénas et centres de curling. The financial assistance granted to the applicants concerns the use of several refrigeration technologies, including CO2, ammonia and HFO R-513A.

According to the mathematical information contained in the Minister's various press releases in relation to this announcement, applicants (particularly municipalities) largely opted for HFO R-513, a refrigerant that goes against the MDDELCC notice issued on 7 December 2015. This notice specifies that to produce an icy surface, the use of this substance should be conditional on the PRP remaining at a level that compares with CO2's PRP level, that is, equivalent to one.

The Government decided to subsidize projects that will in large part use a refrigerant that not only pollutes, but also goes against the MDDELCC notice in a ratio of 600 to 1.

Here are the questions:

- Do all of the announced projects observe the condition stipulated by the MDDELCC in its notice of 7 December 2015, namely that refrigerants used systematically have a PRP that compares with CO2's PRP level?
- How can the Government justify its decision to subsidize these systems, whose ownership cost is more expensive, in addition to going against a MDDELCC notice?
- On 25 November 2016, the Minister of Sustainable Development, the Environment and the Fight Against Climate Change announced that PureSphera will receive an amount of \$5 million for two technologies: first, a project to recover refrigeration system gases and blowing agents used in the insulating foam of refrigerators; and another to safely destroy refrigerants and gases. How can the Government justify the reasons behind its decision to subsidize a type of polluting refrigerant rather than natural refrigerants?

# (229) Mr. Turcotte (Saint-Jean) – **21 March 2017** To the Minister of Health and Social Services

On 18 August 2015, your department's assistant deputy ministers, Messrs. Louis Couture and François Dion, signed a devastating letter announcing the suspension of construction work on Hôpital du Haut-Richelieu's new laboratories. Yet this work had been scheduled and planned for over 10 years in my region. I firmly believe that your decision to uphold the cancellation of the extension of the hospital's laboratories in my electoral division is a serious mistake and that, unfortunately, my constituents will end up paying the price.

Faced with your decision and that of your Government, the Haut-Richelieu community got together to present another project to your department, namely the construction of a mother and child centre, a project that has been awaited for several years. Open since 1972, Hôpital du Haut-Richelieu's maternity department has not undergone any significant transformation since its construction, despite the significant increase in population, the evolution of medical practices, changes in parental relationships and ageing facilities. In an article published last 16 February, *Le Canada Français* newspaper disclosed a letter from the Deputy Minister of Health, Mr. Michel Fontaine, who wrote that the project must first obtain ministerial authorization and that the project will require the recognition of the need by the Health and Social Services department's clinic directorates.

• Knowing that needs are present in the territory covered by Hôpital du Haut-Richelieu, that the Haut-Richelieu community wants this project to be up and running as quickly as possible and that Fondation Santé Haut-Richelieu–Rouville gathered several millions of dollars for its realization, when do you expect to launch the project to establish a mother and child centre at Hôpital du Haut-Richelieu?

## (230) Mrs. Massé (Sainte-Marie–Saint-Jacques) – **21 March 2017** To the Minister of Justice

Trans persons can have the sex designation changed from woman to man or man to woman on their birth certificates in the Québec register of civil status, with the exception of persons who are not Canadian citizens. However, obtaining citizenship can easily take more than seven years. Several trans persons who immigrate to Canada do so specifically because they hope to escape the transphobic violence and discrimination they suffered in their country of origin. Once they have arrived in Québec, they face many obstacles and inconsistency. Moreover, since 2009, trans persons who have permanent residency may have the surgical procedures paid by the RAMQ, but the Québec State does not allow them to have official documents that reflect their gender identity and expression.

The State's non-recognition of these persons' gender identity creates situations of discrimination on a daily basis, ranging from problems at border crossings, at the bank, refusal of various services, housing and work, placing these persons in situations of extreme vulnerability.

Québec is the only Canadian province that does not allow a change of name by non-citizens. The logic of civil law should not take precedence over individual rights. Furthermore, contrary to other Canadian provinces, Québec has a process whereby a person can apply for the insertion of an act made outside of Québec in the Québec register of civil status.

The members of the Committee on Institutions were clear, and unanimous, in their May 2015 report on the draft regulation concerning the Regulation respecting change of name and of other particulars of civil status for transsexual and transgender persons, stating that certain problems experienced by trans persons extended beyond the scope of the draft regulation under consideration and that the members felt that a reflection on the advisability of subsequently amending the regulation to include underage persons was necessary and urgent. They further stated that the same held true for immigrants, who were also ignored in these regulatory changes.

• Does the Minister of Justice intend to amend the Civil Code of Québec to allow non-citizen trans persons to change their gender identity and given name in the Québec register of civil status? If so, how long will it take?

# Mrs. Massé (Sainte-Marie–Saint-Jacques) – 23 March 2017 To the Minister of Transport, Sustainable Mobility and Transport Electrification

In 2010, the Government announced a major construction project to rebuild the Turcot interchange in Montréal. Included in this initial project was the construction of a park on a slab allowing for travel on foot and on bike between Saint-Jacques escarpment and the Lachine canal. In addition to establishing links between the Côte-des-Neiges–Notre-Dame-de-Grâce and Sud-Ouest boroughs, this overpass was justified by the creation of a green space only minutes away from downtown Montréal.

It appears that current plans have quite simply abandoned the very idea of a park on a slab. A most bizarre situation since this part of the project only represented approximately 1% of the budget costs of the Turcot interchange reconstruction, estimated at close to 4 billion dollars. Faced with this situation, a coalition of organizations, including particularly the Conseil régional de l'environnement de Montréal, Équiterre and Vélo Québec, was created to push the Government to show leadership and ensure Montrealers that this overpass will indeed be constructed.

- 1) How does the Minister explain that the park on a slab was withdrawn from the Turcot interchange redevelopment plans?
- 2) How does the Minister plan to ensure fluidity on both sides of the Turcot interchange for pedestrians and cyclists without the presence of the park on a slab?
- 3) What is the Minister's vision concerning the development of the urban space and the role of active transportation within it?

# Mr. Martel (Nicolet-Bécancour) – 5 April 2017 To the Minister of Transport, Sustainable Mobility and Transport Electrification

Last September, I asked for data concerning passenger and vehicle traffic regarding the Québec–Lévis, Sorel-Tracy–Saint-Ignace-de-Loyola, Matane–Baie-Comeau–Godbout and Tadoussac–Baie-Sainte-Catherine ferries for the period from 1 February 2016 to 1 September 2016. The Minister of Transport, Sustainable Mobility and Transport Electrification showed transparency by providing the requested information approximately one month later.

To ensure a follow-up to this request, can the Minister show the same transparency and provide an overview of traffic regarding these ferries for each month from September 2016 to April 2017?

Can the Minister clearly indicate, for each of these ferries:

- How many cars were transported between 1 September and 1 October 2016, between 1 October 2016 and 1 November 2016, between 1 November 2016 and 1 December 2016, between 1 December 2016 and 1 January 2017, between 1 January and 1 February 2017, between 1 February and 1 March 2017, and between 1 March and 1 April 2017 in comparison with each of the same periods of the previous year (2015 and 2016)?
- How many passengers were transported between 1 September and 1 October 2016, between 1 October 2016 and 1 November 2016, between 1 November 2016 and 1 December 2016, between 1 December 2016 and 1 January 2017, between 1 January and 1 February 2017, between 1 February and 1 March 2017, and between 1 March and 1 April 2017 in comparison with each of the same periods of the previous year (2015 and 2016)?
