The Assembly proceeded to Oral Question Period.

By leave of the Assembly to set aside Standing Order 53, Mr. Moreau, Minister responsible for Government Administration and Ongoing Program Review and Chair of the Conseil du trésor, tabled the following:

Three tables concerning changes in public spending, the first entitled "Évolution des dépenses en santé et services sociaux – 1997-1998 à 2016-2017", the second entitled "Évolution des dépenses en éducation et culture – 1997-1998 à 2016-2017" and the third entitled "Évolution des dépenses de missions – 1997-1998 à 2016-2017".

Deferred Divisions

The Assembly took the division, which had been deferred at the sitting of 28 March 2017, on the motion moved by Mrs. Maltais (Taschereau), together with Mr. Blais, Minister responsible for the Capitale-Nationale region, Mr. Caire (La Peltrie), Mr. Khadir (Mercier), Mr. Surprenant (Groulx), Mr. Sklavounos (Laurier-Dorion) and Mrs. Ouellet (Vachon).

This motion reads as follows:

THAT the National Assembly mark the historic character and heritage value of the Quebec Bridge, the longest cantilever bridge of its kind in the world;

THAT it recall that the Quebec Bridge was designated a National Historic Site of Canada in 1995 and that the Canadian Society for Civil Engineering and the American Society of Civil Engineers have designated the Quebec Bridge an International Historical Monument of civil engineering;

THAT, for this reason, the National Assembly recognize the importance of preserving the Quebec Bridge, declare that its disappearance would constitute an enormous loss, and assert that it is out of the question that it be demolished;

THAT, lastly, the Assembly ask the Bridge's owner and the Federal Government to honour their commitments regarding the Bridge's maintenance.

By leave of the Assembly to set aside Standing Order 185, Mr. Bonnardel (Granby), together with Mr. Couillard, Premier, Mr. Chevarie (Îles-de-la-Madeleine), Mr. Lisée, Leader of the Official Opposition, Mr. Khadir (Mercier), Mr. Surprenant (Groulx), Mr. Sklavounos (Laurier-Dorion) and Mrs. Ouellet (Vachon), moved:

THAT the National Assembly commemorate the first anniversary of the 29 March 2016 airplane tragedy that occurred in the Magdalen Islands and took the lives of Jean Lapierre, his wife, Nicole Beaulieu, his brothers, Marc and Louis Lapierre, his sister, Martine Lapierre, pilot Pascal Gosselin and co-pilot Fabrice Labourel;

THAT it recall Jean Lapierre's contribution to both the Québec and Canadian political and media scene;

THAT it observe a minute of silence in memory of the victims.

By leave of the Assembly, a debate arose thereon.

The debate being concluded, the motion was carried.

At the invitation of the President, the Assembly observed a minute of silence.

By leave of the Assembly to set aside Standing Order 185, Mr. Proulx, Minister of Education, Recreation and Sports, together with Mr. Blais, Minister responsible for the Capitale-Nationale region, Mrs. Maltais (Taschereau), Mr. Schneeberger (Drummond–Bois-Francs), Mr. Surprenant (Groulx), Mr. Sklavounos (Laurier-Dorion) and Mrs. Ouellet (Vachon), moved:

THAT the National Assembly underscore the inspiring career of Saint-Ferréol-les-Neiges cross-country skier Alex Harvey;

THAT it recognize his positive influence as a role model for young people and Quebecers in general;

THAT it highlight his outstanding performances at the Nordic Ski World Championships in Lahti, Finland in February and at the FIS Cross-Country World Cup Finals in Québec City;

THAT, lastly, it pay tribute to the Québec company Gestev for organizing this international event, which was a resounding success showcasing both the Québec City area and Québec as a whole.
