Passage in Principle

Resuming the debate, which had been adjourned on Friday, 15 June 2001, on the motion by Mr. Trudel, Minister of Health and Social Services, —That Bill 28, An Act to amend the Act respecting health services and social services and other legislative provisions, do now pass in principle;

At 6.00 o'clock p.m., Mr. Pinard, Vice-President, suspended the proceedings until 8.00 o'clock p.m.

The proceedings resumed at 8.03 o'clock p.m.

And debate continuing on the motion by Mr. Trudel, Minister of Health and Social Services, for the passage in principle of Bill 28;

At the end of his address, Mr. Mulcair (Chomedey) moved the following motion to divide the said Bill:

THAT, pursuant to Standing Order 241, Bill 28, An Act to amend the Act respecting health services and social services and other legislative provisions, be divided into two Bills, the first of which shall be entitled An Act to amend the Act respecting health services and social services and other legislative provisions and shall comprise sections 1 to 102, 104, and 106 to 122; and the second of which shall be entitled An Act to amend the Act respecting the Institut national de santé publique du Québec and the Act respecting the Ministère de la Santé et des Services sociaux and shall comprise sections 103 and 105 as well as the provisions of section 122 that apply thereto.

This motion to divide Bill 28 was negatived.

Then, on motion by Mr. Boisclair, Deputy Government House Leader, the debate on the motion by Mr. Trudel, Minister of Health and Social Services, for the passage in principle of Bill 28 was adjourned.

At 9.28 o'clock p.m., on motion by Mr. Boisclair, Deputy Government House Leader, the Assembly adjourned until Wednesday, 20 June 2001, at 10.00 o'clock a.m.
