Motions Without Notice

By leave of the Assembly to set aside Standing Order 84.1 and pursuant to Standing Order 146, Mr. Tanguay, Deputy Government House Leader, moved:

THAT the National Assembly give effect to the order of reference given to the Committee on Institutions within the framework of the consideration of Bill 139, An Act to group the Office Québec/Wallonie-Bruxelles pour la jeunesse, the Office Québec-Amériques pour la jeunesse and the Office Québec-Monde pour la jeunesse, to hold special consultations and public hearings on 4 October 2017;

THAT, for this purpose, the Committee hear the following:

Réseau Québec-Monde Réseau des carrefours jeunesse emploi du Québec Fusion Jeunesse Table de concertation des forums jeunesse régionaux du Québec;

THAT the presentation by each individual or organization last no longer than 10 minutes and the exchange with the Committee members last no longer than 35 minutes, allocated as follows: 17 minutes 30 seconds to the parliamentary group forming the Government, 10 minutes 30 seconds to the Official Opposition, and 7 minutes to the Second Opposition Group;

THAT the Minister of International Relations and La Francophonie be a member of the said Committee during its proceedings with respect to this order of reference.

By leave of the Assembly, the motion was carried.

Pursuant to Standing Order 129, Mrs. Poirier, Chief Official Opposition Whip, moved:

THAT the Member for Terrebonne be named a member of the Committee on Labour and the Economy in substitution for the Member for Saint-Jérôme;

THAT the Member for Chicoutimi be named a member of the Committee on Public Finance in substitution for the Member for Beauharnois; THAT the Member for Joliette be named a member of the Committee on Citizen Relations in substitution for the Member for Bertrand and that the Member for Hochelaga-Maisonneuve be named a member of the same committee in substitution for the Member for Chicoutimi;

Information on the Proceedings of the Assembly

Mr. Gendron, Third Vice-President, informed the Assembly that on Wednesday, 20 September 2017, during Business Standing in the Name of Members in Opposition, a debate would be held on the motion moved by Mrs. Poirier (Hochelaga-Maisonneuve).

This motion reads as follows:

THAT the National Assembly acknowledge the widespread discontent that the public consultation on systemic discrimination and racism is causing among many Québec organizations, groups and citizens;

THAT the Assembly demand that the Government of Québec cancel the public consultation on systemic discrimination and racism;

THAT the Assembly ask the Government to immediately implement concrete measures to fight racism and discrimination.
