Government Bills

Passage

Having suspended the proceedings to meet with the House Leaders, Mr. Brouillet, Vice-President, announced the allocation of speaking time for the limited debate on this hoist motion: five minutes shall be set aside for the independent Member; the two parliamentary groups shall equally share the rest of the time allotted for this debate; any time not used by a parliamentary group or by the independent Member may be redistributed, and individual addresses shall not be limited.

The Assembly entered upon the debate on the hoist motion moved by Mrs. Gagnon-Tremblay.

The debate being concluded, the question was put on this motion; a recorded division was thereupon demanded.
