### **Business Standing in the Name of Members in Opposition**

Mrs. Normandeau (Bonaventure) moved:

THAT the National Assembly demand that the Parti Québécois Government put an end without delay to the inequities of which the citizens of Québec's regions are victims.

Following a meeting with the House leaders, Mr. Pinard, Vice-President, announced the allocation of speaking time for the proceedings with respect to this motion: ten minutes shall be allotted for a reply by its mover and five minutes shall be set aside for the independent Member; the two parliamentary groups shall share equally the rest of the time allotted for this debate; within this framework, any time not used by a parliamentary group may be added to that of the other group while any time not used by the independent Member shall be redistributed amongst the parliamentary groups, and individual addresses shall not otherwise be limited.

And debate arising on the motion moved by Mrs. Normandeau;

The debate being concluded, the question was put on this motion; a recorded division was thereupon demanded.

At the request of Mr. Boisclair, Deputy Government House Leader, the division was deferred until Routine Proceedings on the present sitting day.

## **ROUTINE PROCEEDINGS**

#### **Introduction of Bills**

Mr. President communicated to the Assembly and then laid upon the Table the report from the Law Clerk on the following Private Bill:

An Act to amend the Act respecting Beloeil Golf Club X This Bill may be introduced in the Assembly and it may receive final passage before the twenty-first day of December 2000.

Mr. Dion (Saint-Hyacinthe) then moved that leave be granted to introduce Private Bill 236, An Act to amend the Act respecting Beloeil Golf Club.

This motion was carried.

On motion by Mr. Boisclair, Deputy Government House Leader, Private Bill 236 was referred for consultations and clause-by-clause consideration to the Committee on Planning and the Public Domain, of which the Minister of State for Municipal Affairs and Greater Montréal shall be a member during its deliberations in respect of the said Bill.

## **Presenting Reports from Committees**

Mr. Williams (Nelligan), vice-chairman, tabled the following:

A report from the Committee on Public Finance, which met on 7 November 2000 for clause-by-clause consideration of the following Bill:

138 An Act to again amend the Taxation Act and other legislative provisions — Reported with certain amendments.

Mrs. Gagnon-Tremblay (Saint-François), chairman, tabled the following:

A report from the Committee on Social Affairs, which, on 26 September, 5 and 17 October, and 2 and 7 November 2000, held public hearings within the framework of a general consultation on Bill 140, An Act respecting parental insurance, as well as on the draft regulation on parental insurance.

#### **Government Bills**

Passage in Principle

Mrs. Harel, Minister of Municipal Affairs and Greater Montréal, moved, —That Bill 150, An Act to again amend various legislative provisions respecting municipal affairs, do now pass in principle.

At 3.33 o'clock p.m., the proceedings resumed and the Assembly held a debate on the motion by Mrs. Harel.

Mr. Brouillet, Vice-President, interrupted the debate and informed the Assembly that he had received two requests for debates upon adjournment to be held on Thursday, 9 November 2000:

- the first, on a question by Mr. Gautrin (Verdun) to Mr. Boisclair, Minister of Social Solidarity, about section 146.7 of Bill 102, An Act to amend the Supplemental Pension Plans Act and other legislative provisions (modified title), which removes any right of recourse before the courts;
- the second, on a question by Mr. Chagnon (Westmount-Saint-Louis) to Mr. Legault, Minister of Education, about financial assistance to university students.

And debate continuing;

The debate being concluded, the motion was carried on division and Bill 150 was accordingly passed in principle.

On motion by Mr. Boisclair, Deputy Government House Leader, Bill 150 was referred for clause-by-clause consideration to the Committee on Planning and the Public Domain.

Resuming the debate on the motion by Mr. Chevrette, Minister responsible for Wildlife and Parks, —That Bill 152, An Act to amend the Act respecting the conservation and development of wildlife and the Act respecting hunting and fishing rights in the James Bay and New Québec territories, do now pass in principle;

The debate being concluded, the motion was carried and Bill 152 was accordingly passed in principle.

On motion by Mr. Boisclair, Deputy Government House Leader, Bill 152 was referred for clause-by-clause consideration to the Committee on Transportation and the Environment.

Mr. President tabled the following:

The report of the advisory committee on the working conditions and the pension plan of the Members of the National Assembly.

Mr. Bégin, Minister of the Environment, moved, —That Bill 148, An Act to amend the Act respecting the Ministère de l'Environnement, do now pass in principle.

After debate thereon, the motion was carried and Bill 148 was accordingly passed in principle.

On motion by Mr. Boisclair, Deputy Government House Leader, Bill 148 was referred for clause-by-clause consideration to the Committee on Transportation and the Environment.

## 8 November 2000

Mr. Bégin, Minister of the Environment, moved, -That Bill 149, An Act respecting nature reserves on private land, do now pass in principle.

And debate arising;

At 6.00 o'clock p.m., the debate on the motion by Mr. Bégin, Minister of the Environment, was adjourned. Mr. Bissonnet, Vice-President, adjourned the Assembly until Thursday, 9 November 2000, at 10.00 o'clock a.m.
